#### 1. CALL TO ORDER

Chairman Brian Smith called the meeting to order at 8:30 a.m. and the attendees introduced themselves.

## 2. PUBLIC COMMENTS

There were no public comments provided.

### 3. APPROVAL OF MINUTES

The summary from the September 21, 2020 meeting was approved with no corrections.

#### 4. FORWARD PINELLAS ACTIONS

Mr. Al Bartolotta, Forward Pinellas Planning Division Manager, reviewed the highlights of the Forward Pinellas Board meeting for November 10, 2020. The Board received presentations the BPAC had previously voted. Officers were elected, and Darden Rice was named Chair for the next Board term. Questions arose regarding the meeting situation and Forward Pinellas is working closely with the County Attorney's office for guidance to see what alternatives can be offered to citizens for committee meetings while adhering to the Sunshine law.

#### 5. BIKE YOUR CITY RESULTS: IN-PERSON TO VIRTUAL PLATFORM

Ms. Angela Ryan, Forward Pinellas staff, gave a recap of the Bike Your City event. The original March event was cancelled due to the COVID-19 pandemic. In the continual interest of promoting cycling and pedestrian safety, a virtual, self-guided Bike Your City event was planned for October in Safety Harbor. Staff elected to plan a scavenger hunt because it allowed for social distancing, riding at your own pace and highlighting the different culturally rich attributes in Safety Harbor. Twenty landmark locations were identified, and event participants had two weeks to locate the landmarks and submit pictures through an online QR code process or through a hard-copy form submittal. 558 participants registered for the event and the pictures were shared at a Zoom Webinar held shortly following the close of the event. A partnership with the Safety Harbor Art & Music Center resulted in a community art mosaic bike sculpture that will be permanently displayed in downtown Safety Harbor. Questions were taken and appropriately answered.

#### 6. COMPLETE STREETS 2021 PROGRAM APPLICATIONS

Ms. Ryan shared a presentation with the committee on the Forward Pinellas Complete Streets Grant Program. This is the fifth year Forward Pinellas has offered this program which provides up to \$100 thousand for concept planning projects and \$1 million for construction projects. The program is designed to leverage local transportation funding to bring about transformative land use changes.

- The City of Tarpon Springs is requesting \$100 thousand, with a \$68 thousand match, to develop a complete streets concept plan for Disston Avenue. The corridor is 1.9 miles long with a 0.2-mile gap between Woodhill Drive and Mango Street and the goal of the project is to provide multimodal access to social, faith-based, health, commercial and community institutions by providing lighting, enhanced crossing and ADA compliant sidewalks.
- The City of St. Petersburg is requesting \$100 thousand, to develop a concept plan for the 6<sup>th</sup> Street bikeway. This project is a continuation of a previous project funded by Forward Pinellas in 2019. There are currently no safe bike accommodations in this minority and low-income area. This project will identify preferred safe roadway configurations between Roser Park and Mirror Lake through downtown.

• The City of St. Petersburg is requesting \$1 million for a construction project along 22<sup>nd</sup> Street South, from 11<sup>th</sup> Avenue South to 18<sup>th</sup> Avenue South. This is an important project as it is located in a minority and low-income area which would economically benefit from the inclusion of more walkable and livable street corridors. The project corridor is comprised of a mix of land uses and is located within the South St. Petersburg CRA. This project proposes to widen and add buffered pathways for bikes and pedestrians and allow for new bus stop locations with landscaped amenities.

A subcommittee has been assembled for review and recommendations of the applications. Questions were taken and appropriately answered.

#### 7. BIKE/WALK TAMPA BAY AND LOVE TO RIDE

Ms. Julie Bond was unable to participate in today's committee meeting; however, Ms. Becky Afonso was able to provide information regarding Love to Ride. There is currently a Love to Ride Challenge underway for the month of November. Members can go to the <a href="https://lovetoride.net/florida">https://lovetoride.net/florida</a> website and register. Points can be earned for bike rides and there are prizes and recognitions awarded. Love to Ride will use this information to show FDOT that there are cyclists out there, and funds are needed for biking projects. Questions were taken and appropriately answered.

#### 8. BPAC BUSINESS

#### A. Election of 2021 BPAC Officers

Chairman Smith opened the nominations for chairman and vice chair, adding that both he and Ms. Becky Afonso, current vice chairman, would be willing to serve in their positions for another year. Both were promptly reelected.

#### B. December 2020 Meeting Cancelled

Chairman Smith reminded members that the December 2020 meeting is cancelled.

#### C. Florida Bicycle Association (FBA)

Vice-Chair Becky Afonso gave an update on the Florida Bicycle Association. FBA is currently planning and holding virtual seminars on electric bicycles, scheduled for the month of November. Please check the FBA website calendar and make note these webinars are available through the YouTube channel. Ms. Afonso will be presenting the FBA Legislative Platform to the Hillsborough MPO on November 18<sup>th</sup>, 2020. Nominations for Annual FBA Awards are now open.

#### D. Friends of the Pinellas Trail

Scott Daniels, Friends of the Pinellas Trail (by phone), shared that plans are moving forward for the 30<sup>th</sup> anniversary of the Pinellas Trail, which will be recognized on December 5<sup>th</sup>, 2020. Out of precaution due to the COVID-19 virus, an in-person gathering will not take place. Pinellas County Public Works has written a proclamation going to the Board of County Commissioners on the 30<sup>th</sup> anniversary. The County and Friends of the Pinellas Trail will spread news about the 30<sup>th</sup> Anniversary of the Pinellas Trail. Media and news on the anniversary will be sent out to all the municipalities, along with graphics to help celebrate. Social media events are also planned every day for 30-days, prior to December 5<sup>th</sup>. Friends of Pinellas Trail will be involved with the local media and the Chambers for outreach into the community to help celebrate the 30<sup>th</sup> anniversary

#### 9. AGENCY REPORTS

## Pinellas Trail Loop/Duke Energy Trail (North & South Gaps)

Ms. Joan Rice with Pinellas County Public Works Traffic stated that sidewalk on East lake Road had to be removed in order to construct the new section of the Pinellas Trail and that staff is working quickly to complete this section of the Trail. The construction for this segment of the trail should be completed by the end of December. In respect to the North gap in the Pinellas Trail located in the Countryside area, there will be another public virtual meeting scheduled for December 10<sup>th</sup>. The meeting will provide planning updates and address current public concerns prior to bringing this item to the Board of County Commissioners for a decision. With regards to the Trail Visioning Project, all meetings with the municipalities have been completed. The next step is to seek public opinion via survey. Pinellas Trails 30<sup>th</sup> Anniversary campaign has been very successful with their "Where am I on the Pinellas Trail?" images.

## • Clearwater Bicycle Pedestrian Program

Lauren Matzke with the City of Clearwater was not in attendance.

### • Largo Bicycle Pedestrian Program 1:02:06

Mr. Rick Perz, City of Largo, shared information on West Bay Drive corridor improvements including sidewalk repairs, streetscaping and lane striping. Rosery Road project is scheduled to be completed and opened on November 2<sup>nd</sup>. However, at some point in the near future, Largo is expecting the CSX crossing to be closed for two months to complete improvements in the crossing. An improvement to the Pinellas Trail entrance at West Bay Drive has begun and is expected to be completed in approximately nine months. The Plaza, on the other side of West Bay Drive and Seminole is 99% complete

## St. Petersburg Bicycle Pedestrian Program

Mr. Lucas Cruse, St. Petersburg Transportation, was not in attendance.

#### Pinellas County Schools

Mr. Joseph Camera, Pinellas County Schools, shared that additional students were enrolled for the second quarter. The number of students is limited on the buses and the drivers are carrying additional masks, as students will often forget them, and they are required in order to ride the bus. Mr. Camera stated that at the 49<sup>th</sup> Street S crosswalk cyclists are not using the RRFB's, and that this same issue is occurring near Boca Ciega High School.

#### THE PLANNING COUNCIL AND METROPOLITAN PLANNING ORGANIZATION FOR PINELLAS COUNTY

The Forward Pinellas Board held this public meeting in person on January 13, 2021 at 1 p.m. in the Magnolia Room at the Pinellas County Cooperative Extension. Presenters and members of the public also had the opportunity to participate virtually to ensure public safety in response to the COVID-19 pandemic. Please see the following link for more information about virtual meeting policies and procedures.

## The board unanimously approved a letter to provide comments on the Florida Department of Transportation's FY 2021/22-2025/26 Draft Tentative Work Program

Justin Hall, FDOT reviewed the additions and postponements to the Draft Tentative Five-Year Work Program that outlines the state and federally funded transportation projects for the next five years. Given the impacts from the ongoing pandemic, Florida is facing a \$1.4 billion deficit in its projected transportation revenues across the next five years. The Tampa Bay area felt the biggest sting from the budget cuts with the two-year delay of the Westshore Interchange Project and deferral of other I-275 improvements. Pinellas County's near-\$300 million budget cut was disproportionately higher than the rest of the state.

Secretary Gwynn discussed why several significant transportation projects were postponed, highlighting that they tried to honor ongoing construction projects, planned safety projects, and any maintenance projects to make sure current projects are able to continue. He noted that the majority of what they had available to cut in the budget was from the Strategic Intermodal System (SIS) program and the Westshore Interchange was the biggest SIS project in the Five-Year Work Program. He encouraged the board to continue regional coordination and speak with one voice. In addition, he committed to continuing to pursue the postponed projects, so they are ready to be implemented once funding is in place, hopefully sooner than anticipated.

#### Questions & Comments:

Commissioner Eggers requested an update on the Drew Street project.

FDOT is working with Forward Pinellas staff, local governments, and the public on a
planning study that will result in a proposed alternative that will move into the design phase
after it is completed in the next nine months. They expect the construction phase to begin
two years after that.

Commissioner Seel confirmed with FDOT that the U.S. 19 projects remain fully funded for construction from Main St. to Curlew Rd. In addition, Seel and Eggers also expressed a desire to advance funding for U.S. 19 improvements north at least through Tampa Road.

Commissioner Long expressed her displeasure about all the project delays, especially the postponement of the Westshore Interchange.

Chair Rice asked if the delays in the Westshore Interchange would impact the Tampa Bay Area Regional Transit Authority's Regional Bus Rapid Transit (BRT) project.

 Secretary Gwynn said that because the Westshore Intermodal Center is directly tied to the Westshore Interchange, delays in this project will also cause delays to the BRT.

Pinellas County resident Karen Mullins, voiced disappointment in the postponements outlined in the Five-Year Work Program and would like to see FDOT and Forward Pinellas look at other funding sources so we can continue these projects, especially the Regional Bus Rapid Transit project.

#### The board unanimously approved the Transportation Alternatives Program Grant Awards

St. Petersburg, Pinellas Park, and Pinellas County are the latest local governments in Pinellas County seeking funding under the Forward Pinellas Transportation Alternatives Program, which assists communities wishing to improve bicycle and pedestrian facilities within their communities

Based on the scoring process approved by the board, Forward Pinellas staff recommended these four projects be added to the bottom of the priority list in this order, allowing FDOT to consider these projects for future funding:

- 1. 118<sup>th</sup> Ave. in Pinellas Park
- 2. 28<sup>th</sup> St. in St. Petersburg
- 3. 46<sup>th</sup> St. N. in Lealman (unincorporated Pinellas County)
- 4. 62<sup>nd</sup> Ave. S. in St. Petersburg

#### Questions & Comments:

Councilmember Gabbard asked what the process is for applications that don't get approved.

o Forward Pinellas Staff meets with all applicants to discuss how the scoring criteria are applied to each application and answer any questions the local government might have.

Commissioner Long inquired about the status of corridor improvements along 102<sup>nd</sup> Ave. in the Seminole area

 Pinellas County is currently engaged in a process to identify improvements along this corridor from 113<sup>th</sup> St. to the west. Forward Pinellas staff is coordinating with County staff on the project and they're working collaboratively to ensure that sidewalks, bike lanes and possible trail facilities are considered during the design of the future project.

#### The board approved two amendments to the Countywide Plan Map

- The board recommended approval of two amendments:
  - An amendment from the City of Tarpon Springs to amend properties at 324 East Pine Street, 424 North Ring Avenue, & 395 North Grosse Avenue from Residential Low Medium to Public/Semi-Public to ensure the existing uses conforms to the appropriate Countywide Plan Map category. (12-0)
  - An amendment from the City of Tarpon Springs to amend approximately 8.61 acres at Marina Drive from Resort to Residential Low Medium to ensure consistency with the existing single-family residential neighborhood. (12-0)

The board unanimously approved the 2021 legislative policy priorities based on the Legislative Committee recommendation and appointed new members to the Legislative Committee.

The board unanimously voted to approve committee appointments to the Tampa Bay Transportation Management Area Leadership Group, Chairs Coordinating Committee, and the Metropolitan Planning Organization Advisory Council.

#### **Other Items**

- Four incoming Board Members were welcomed to Forward Pinellas Vice Mayor Cliff Merz, Councilmember Bonnie Noble, Commissioner Pat Gerard, & Councilmember Patti Reed.
- Lee Allen, outgoing CAC member, was recognized for his commitment and dedication to Pinellas County, Forward Pinellas and the City of St. Petersburg.
- Indian Shores and Indian Rocks Beach sidewalk and drainage project is in the PD&E evaluation of alternatives phase with work underway.
- Forward Pinellas staff is working with FDOT on the Frontage Roads Plan for U.S. 19 to identify safety improvements, speed management alternatives, etc. and will bring this plan to the board in the spring.
- FDOT is considering plans to add a second southbound left-turn lane at the Gandy/Park Blvd.
  interchange with US 19 to relieve queuing for drivers turning toward I-275 by removing a
  section of the existing bike lane. Forward Pinellas is working with the City of Pinellas Park and
  FDOT to create a safe routing plan for bicycles and pedestrians in the area, in the event this
  proposed change is implemented.
- All partners have adopted the Gateway Master Plan Memorandum of Understanding.
- House Bill 1339 was passed allowing for affordable housing to be approved on any land use
  including an employment area, commercial or industrial land land uses that are protected in
  Pinellas County. Forward Pinellas staff is coordinating with the cities and Pinellas County to
  conduct research on best practices in the decision-making process to enable affordable housing
  in appropriate areas while also continuing to preserve land for target employment uses.
  - O Commissioner Eggers showed support in the research of best practices but urged cities to preserve employment areas that would support more and better jobs.

- PSTA has launched the Automated Vehicle, "AVA" in the City of St. Petersburg. In addition, PSTA and FDOT will soon be launching a pilot program allowing busses to use the shoulder of I-275 during periods of traffic congestion.
- After 10 years of service, Commissioner Seel will be handing over the TBARTA responsibilities to Commissioner Long. Forward Pinellas has reviewed the scope for the aerial gondola feasibility study and expects this project to move forward this month. The feasibility study is considering alternatives for downtown Clearwater to Clearwater Beach & within Downtown St. Petersburg.
- Councilmember Gabbard requested a commitment from our staff to begin discussions for a
  unified approach to deploying electric scooters throughout the county. Whit Blanton assured
  that staff would begin researching current city ordinances and develop an approach for a
  countywide application for regulations.
- Pinellas County resident Todd Pressman requested the board increase the residential
  equivalency calculation to allow more beds in assisted living facilities as a housing strategy. In
  response, Whit Blanton committed that Forward Pinellas will take up this recommendation
  with local governments as part of a package of potential amendments to the Countywide Plan
  and will present this to the board this spring.
- Forward Pinellas is in the process of its Quadrennial Certification with the Federal Highway Administration (FHWA), which includes a virtual meeting on January 28, 2021. This is required to document compliance with all federal laws and policies for Metropolitan Planning Organizations.
- Forward Pinellas will hold a Board Workshop on January 29, 2021 to discuss agency objectives and priorities for the coming year.



#### Dear Secretary Gwynn:

Forward Pinellas has reviewed the 2021/22 to 2025/26 Draft Tentative Work Program and appreciates the opportunity to provide the Florida Department of Transportation with our comments. We are particularly encouraged and appreciative that the Department has worked hard to program projects adopted in 2020 that reflect our agency's multimodal priority list:

- Funding for the construction of a complete streets project prioritized by our agency along SR 580/Skinner Blvd from Alt 19 to Bass Blvd in Dunedin
- Capital funding for bus replacements for PSTA
- Design and construction funding for improvements along Drew Street in Clearwater
- Construction funding for intersection improvements at Alt 19 and Curlew Rd in Dunedin
- Project Development funding for sidewalk improvements along Gulf Blvd in Indian Shores and Indian Rocks Beach
- Design and construction funding for transportation alternatives improvements along 28<sup>th</sup> St from the Pinellas Trail to 1<sup>st</sup> Ave N in St. Petersburg
- Design funding for transportation alternatives improvements along Central Ave from 34<sup>th</sup> to 31<sup>st</sup> St in St. Petersburg
- Construction funding for sidewalks near North Shore elementary school in St. Petersburg
- Construction funding for Advanced Traffic Management Systems projects throughout Pinellas County

We also greatly appreciate the Department's preservation of construction funding for the US 19 capacity and safety improvements along US 19, particularly from SR 580 to Curlew Road and the Harn Blvd pedestrian crossing. Unfortunately, we must express our dismay with the proposed deferral of several major projects on the Strategic Intermodal System. The planned improvements to I-275 and US 19 are critical to the economy of Pinellas County and the Tampa Bay region, and their deferral will harm the region given the rapid growth that continues throughout West Central Florida. While we understand the budget constraints due to the COVID-19 pandemic, the disproportionate cuts in funding to the District 7 SIS projects compared with other districts is unacceptable and unfair. We request that the Department preserve funding to retain the following projects in the work program as previously established:

- Reconstruction of the interchange at I-275/SR 60/Westshore Blvd. in FY 24
- Funding for design and right-of-way for interchanges along US 19 that include the Tampa Road and Nebraska Ave intersections
- Construction of express lanes in the I-275 corridor from I-375 to the Gateway Expressway, and land continuity improvements from 54<sup>th</sup> Ave S. to Gandy Blvd.

Thank you again for your commitment and partnership with Forward Pinellas and the local governments in Pinellas County and Tampa Bay. We appreciate your consideration of these comments and look forward to working closely with you to advance each of these projects and planning activities.

# <u>Bicycle Pedestrian Advisory Committee – January 25, 2021</u> 6. US 19 Frontage Road Recommendations



#### SUMMARY

The Florida Department of Transportation, in cooperation with Forward Pinellas, is conducting a safety action plan for the US 19 (SR 55) frontage roads. The project is focused on the 11.5-mile segment running from north of 49th Street to north of SR 580 (Main Street) and traverses through the cities of Pinellas Park, Largo, and Clearwater, as well as unincorporated Pinellas County. The frontage roads in this area have served to improve the flow of traffic on the mainline of the roadway but have also been experiencing high vehicle speeds and unsafe conditions for bicyclists, pedestrians and transit users.

The purpose of the plan is to work with community stakeholders and public agency partners to objectively identify needs and evaluate possible changes to improve multimodal safety, operations, and connectivity within the study corridor. The goal is to also apply any lessons-learned to the future design of frontage roads extending north through Pinellas County.

FDOT staff will provide an overview of the planning study, the corridor existing conditions, and the preliminary typical section concepts developed with agency partners. FDOT is looking for feedback on the documented challenges and needs and preliminary recommendations.

#### 1. CALL TO ORDER AND INTRODUCTIONS

Chairman Ronald Wolfson, St. Petersburg Police Officer, called the meeting to order at 9:00 a.m. Ms. Angela Ryan reviewed the Zoom meeting guidelines and the attendees were announced by Ms. Maria Kelly, there were 23 attendees.

#### 2. APPROVAL OF MEETING SUMMARY – July 14, 2020

#### 3. PRESENTATION: SAFE STREETS PINELLAS

Ms. Julie Bond, University of South Florida Center for Urban Transportation (CUTR) shared a presentation with the committee, Road to Zero. CUTR was awarded a Road to Zero Safe System Innovation grant in 2019 to examine public narratives on bicycle and pedestrian deaths. The project recognizes the inherent bias in the way pedestrian and bicycle fatalities are presented in the media. After nine years of analyzing written and oral reports by the media on bicycle and pedestrian crashes, the results have

been presented in public workshops designed to educate people on the topic while identifying was to provide a revised framework for communicating with the public on bicycle and pedestrian fatalities resulting from vehicle collisions. Questions were taken and appropriately answered.

#### 4. RECTANGULAR RAPID FLASHING BEACONS (RRFB's)

Ms. Angela Ryan, Forward Pinellas staff, shared a presentation with the committee on Rectangular Rapid Flashing Beacons (RRFB's). Rectangular Rapid Flashing Beacons (RRFBs) are pedestrian activated traffic control devices typically installed at mid-block crosswalk locations to help people safely cross the street. Florida Law requires motorists to stop for a pedestrian who enters a crosswalk. An RRFB helps to protect the pedestrian using a crosswalk by alerting oncoming motorists of their presence. There are currently over 400 RRFBs in Pinellas County, most of them within the City of St. Petersburg. The RRFBs have proven to be highly effective in Pinellas County and around the country. Despite the proven effectiveness of the RRFB's, two bills, Senate Bill 100 and House Bill 1371, were filed during the 2020 Florida legislative session that would have effectively disallowed them in the state. Neither bill passed, but it is anticipated that similar versions will be proposed in the 2021 legislature. Forward Pinellas will be engaging its committees and partners to support the continued use of RRFB's and to help educate the public about their purpose and importance. Questions were taken and appropriately answered.

#### 5. QUARTERLY REPORT FROM PINELLAS TRAIL PARK RANGER

Chief Ranger Carol Gray, Parks and Conservation Resources (PCR), reported there were no significant incidents in the last quarter, other than evidence of camping at the US19 Underpass as well as some graffiti. Ranger Gray worked with Tarpon Springs PD to clean up the graffiti and will continue to work with them to stay on top of the situation. The installation of the 911 Trail Markers has been completed on all sections of the trail managed by PCR. Still dealing with challenges of the paint adhering to the concrete but will keep working at it.

#### 6. LAW ENFORCEMENT AND AGENCY REPORTS

#### A. Sheriff's Office

Deputy Fallahee was unable to acquire a statistical report prior to the meeting but will submit one as soon as possible for distribution.

#### B. Belleair

Officer Allison Daniels of the Belleair Police Department reported six field interview reports from people on the trail at night. One officer found a couple sleeping in the grassy area of the trail and they left without incident.

#### C. Clearwater

No one attended from the City of Clearwater Police Department.

#### D. Gulfport

Officer Zack Mills of the Gulfport Police Department reported that on September 21<sup>st</sup>, just after 6 am near the Calm Bayou section which is the southeast corner of the City of Gulfport right next to St. Petersburg, St. Petersburg Fire and Rescue responded to a car fire on the Pinellas Trail behind the Twin Brooks Golf Course near 22<sup>nd</sup> Ave S and 41<sup>st</sup> Street S. After the fire was out, a body was discovered in the trunk of the vehicle. A cyclist discovered and reported the car fire. Gulfport is currently working with the St. Petersburg PD to investigate the incident.

#### E. Largo

Officer V. Tran of the Largo PD reported 9 calls for service, but nothing significant to report for any trail related incidences. There were a couple of sightings of homeless people who were just asked to leave.

#### F. St. Petersburg

No one attended from the St. Petersburg Police Department. Chair Wolfe to check to see if someone new will be attending for St. Petersburg.

#### G. Tarpon Springs

Officer Tony Boone was having trouble connecting audio, we will send a message to have the report forwarded.

#### H. Animal Services

Mr. Gary Brown, Pinellas County Animal Services, reported there were no reported calls for service on the Trail.

#### I. Public Safety Services

Ms. Lynn Abbott, Pinellas County EMS & Fire Administration, reported there were 52 calls that translated into 28 incidents where 13 of those were bike related some involving intoxication. There were four heat exposures, three homeless/sleeping reports and two attempted suicides.

#### J. Pinellas County Risk Management

Mr. Dave Mangicaro, Pinellas County Risk Management, stated there was nothing to report at this time.

#### K. Volunteer Patrol Programs and Updates

Chair Wolfson stated that the volunteers have not been active since March due to COVID and hopes to bring them back soon based on what is happening. Ranger Gray reported that the Auxiliary Rangers will be allowed to return for biking and walking, absolutely voluntary with no reporting to work sites. Volunteer hours can be entered on the county website.

#### 7. AUTOMATIC TRAIL COUNTERS

Ms. Angela Ryan, Forward Pinellas staff, reviewed the counter reports for June, July and August 2020 which were included in the agenda packet. 1.5 million people were counted on the trail from January through August 2020.

#### 8. REPORT ON TRAIL CONSTRUCTION ACTIVITY

Ms. Joan Rice, Pinellas County Public Works (PCPW), shared an update on the Trail construction activity. Construction has begun on the North Loop between Enterprise Road and John Chesnut Park. This project will take about two years to complete. The segment of the North Loop that is South of Sunset Pointe is nearing completion of construction, opening in November. For the South Loop, between Haynes Bayshore and 126<sup>th</sup> Avenue, some funding for design and all construction funding has been received. Design will begin in 2022, construction in 2025.

#### 9. REPORT ON TRAIL COMMUNITY INVOLVEMENT ACTIVITIES

Scott Daniels, Friends of the Pinellas Trail, a meeting was held on October 12<sup>th</sup>, via Zoom. Things are moving forward for the 30<sup>th</sup> Anniversary of the Pinellas Trail, which will be recognized on December 5<sup>th</sup>, 2020, however due to the corona virus, the gathering cannot take place. Pinellas County Public Works has written a proclamation going to the Board of County Commissioners, so they can spread the news about the 30<sup>th</sup> Anniversary of the Pinellas Trail. And this will be sent out to all the municipalities, along with graphics to help celebrate. Social media events are also planned every day for 30 days, prior to December 5<sup>th</sup>. Friends of Pinellas Trail will be involved with the local media and the Chambers to get the word out into the community to help celebrate its 30<sup>th</sup> Anniversary.








#### **October Trail Users by Counter Location**




### Counter Data Year to Date by Location



# Fed Pedestrian Safety 'Action' Plan Light on Action, Heavy on Studies

could at least give cities a few more tools to save lives.

In a self-congratulatory press release, representatives for the agency praised themselves for drafting a "first-of-its-kind" comprehensive walking safety plan, which details 30 actions the agency will complete before the end of the Trump administration (most of which were already completed earlier this year, and many of which were pretty offensive to advocates), as well as 60 priorities that the incoming Biden administration will be encouraged to tackle. Secretary Elaine Chao praised the report as an "unprecedented comprehensive safety effort" that was more urgent than ever in the midst of an ever-rising death toll, "because crossing a street should not be lethal for thousands of adults and children every year." (Her predecessors in the Obama administration issued a similarly named plan in 2014 that explored many of the same solutions, albeit in less granular detail.)

Some pedestrian safety advocates applauded the lame-duck leaders of the agency for giving *any* attention to a growing public health crisis that they've hitherto largely ignored, but most found the document pretty toothless without dedicated funding and policy change.

"I wish they would have talked more about tailoring existing programs so that they make better decisions automatic and funded," said Angie Schmitt, pedestrian safety expert and author of "Right of Way," which examines the pedestrian death crisis. "But they may not have done that because Congress controls spending measures."

But other experts stressed that the powers of the Transportation Secretary aren't nearly as limited as the report seemed to suggest — and hoped that Biden's as-yet-unnamed DOT head would be far more bold.

"Speaking as a former mayor who's put out a lot of press releases, when you haven't succeeded in implementing the significant, noteworthy changes you know you need, you put out a list of lots of smaller actions like this," said Mike McGinn, executive director of American Walks and the former mayor of Seattle. "That's what this feels like to me. ... It really doesn't contain much in the way of leverage or consequences. It's a sign of some evolution in the right direction, but it's not a radical transformation."

Here's a glimpse at the good, the bad, and the outright missing.

#### Safer vehicles on the horizon?

To its credit, the DOT seems to recognize the role that vehicle design has played in our roadway death toll — even if its recommendations won't do much to actually make cars safer.

The report offered glimpses of potential future rule-making on some of the most dangerous features common to modern vehicle design, including "improved lower beam headlighting performance to increase seeing distance for drivers," which contributes to the estimated 76 percent of pedestrian deaths that occur after dark. The agency even acknowledged that the "increase in the popularity of sport utility vehicles and light trucks may play a role in the increasing number of pedestrian fatalities." (May play a role? Most advocates think the link is a lot more definitive than that.)

But the report stopped short of recommending one particularly crucial change that the DOT could likely implement without the approval of Congress: adding pedestrian safety ratings to the New Car Assessment Program like the vast majority of other nations already do. Advocates inside the agency have been pushing to require automakers to meet minimum pedestrian crash test standards since the Program was created back in 1978; it's long past time for the agency to stop bowing to pressure from automakers.

#### Finally some decent walking data?

One of the most frustrating barriers to curbing roadway carnage is how astonishingly little data our communities collect on walking — which makes it incredibly hard to understand where they should make the first changes.

Apparently, 2020 was the year that the office of the Secretary finally began to explore the kind of ground-breaking anonymized cell phone data collection systems that can give cities a real-time picture of where and how many people are out there walking around, which in turn might give leaders a blueprint for the most impactful safety interventions. And the agency also started laying the groundwork for cities to develop their own "[pedestrian] data analytics and visualization dashboards" — a project that they're recommending that the next administration take up.

Sadly, we don't just need better data on walkers who are still alive, because we have spotty federal data on dead and seriously injured walkers, too. Happily, the DOT is also pushing for the next team to "develop a Crash Injury Research trauma center-based crash data collection program by modernizing pedestrian crash data collection protocols." (Let's hope that also includes *standardizing* crash reports from state to state and city to city, since so many crash

stats are deeply incomplete, and often largely based on officer conjecture.)

Helping cities get a handle on exactly how bad their crash rates are would be huge. But it would be even better if cities faced real funding consequences for failing to take action against traffic violence — because as it

stands, they don't. Most experts think that change will need to come from Congress, but the next DOT head could pressure the legislature to finally close the loophole that lets states set safety targets that wouldn't lower death totals at all.

#### **Bad education**

Here's something that has almost no proven impact on pedestrian safety, at least when compared to the effect of good roadway engineering: driver's education! But the DOT is recommending cities and states invest in it anyway.

Trump's DOT is recommending that Biden's team "depict the highest-risk behaviors by motorists, pedestrians, and cyclists utilizing crash animation videos in drivers' education courses." Would-be drivers in the 18 states that don't require any form of driver's education to obtain a license will miss out — but that might be okay, since some of the things that the current DOT would have drivers believe are "high-risk" behaviors, like walking down the street without a flashlight, are only risky because cities fail to install adequate streetlights, crosswalks, sidewalks, and generous walk signals, *not* because walkers did anything even remotely wrong. Teaching drivers that walkers are the ones taking a risk by leaving the high-viz vests at home — rather than drivers, who are piloting a machine that can kill other people with one wrong move — is a truly terrible precedent to set.

At least the DOT is also recommending some good educational initiatives — for roadway engineers. The agency has already compiled some good resources on how to design with walkers in mind. Here's hoping the next Congress gives its successors the tools and money they need to actually mandate such design shifts in places everywhere, starting with the places where walkers most frequently die.

#### Endless toolboxes, guidelines and research studies — but few consequences

The DOT's "action" plan offers little in the way of real policies and programs, but it's certainly heavy on research and resources: words like "study," "investigate," "plan," "assessment," "promote," and "toolkit" appear in the document 52 times, though almost none of those words are accompanied by policies that require state and local agencies to *use* those insights in any meaningful way.

Perhaps the most optimistic way to look at the DOT's "action" plan is to think of it largely as a storehouse of government-funded research that can stand ready to inform real policy changes when a new Secretary and (not to mention a new Congress) with a bold commitment to end the pedestrian death crisis finally comes along. The pessimistic take, though, is that the 2014 edition of our federal pedestrian safety "action" plan was heavy on studies, too — including then-futuristic ideas like "vehicle to pedestrian" technologies that Chao's team *still* thinks deserve academic scrutiny and in government-funded labs. And in the six years between the two reports, pedestrian deaths have increased by a shocking 35 percent.

It's time we stop planning for a future where no one dies on our streets, and start doing everything we can to make Vision Zero our present. To do that will take real money, policy and cultural change — not just another government report with a laundry list of missed opportunities, proposed research and little else.





# NEARLY \$300 MILLION IN FEDERAL INFRASTRUCTURE GRANTS INCLUDE BIKES

December 4, 2020





In September 2020, the U.S. Department of Transportation (USDOT) announced this year's awards (https://www.transportation.gov/briefing-room/us-secretary-transportation-elaine-l-chao-announces-1-billion-upgrade-american) for the Better Utilizing Investments to Leverage Development grants (BUILD, formerly TIGER). Of the \$1 billion in grants awarded, nearly \$300 million focus on or support bicycle infrastructure and active transportation. Ranging from recreational trails to river walks, large interchanges and shoulder expansions, BUILD grants provide the necessary dollars to complete important transportation projects that would otherwise lack sufficient funding from other sources.

This year, 21 of the 70 total projects include bicycle infrastructure, a significant increase compared to previous years of BUILD grants. Applicants (generally cities, counties and transportation authorities) recognize that adding and improving bike infrastructure not only makes their applications more competitive, but represents their communities' needs to serve the growing number of people riding bikes for both transportation and recreation.

#### A few of the projects to highlight:

- Jefferson Avenue and 20th Street Revitalization Corridors St. Louis, MO
  - This \$7,950,000 grant will support a Complete Street across downtown St. Louis, including new low-stress bicycle facilities alongside signal, pedestrian and stormwater improvements.
  - <u>PeopleForBikes supported a campaign by Trailnet (https://peopleforbikes.org/grants-awarded/network-protected-bike-lanes-st-louis/)</u>, a local bike/pedestrian advocacy group, to advance a network of protected bike lanes in the downtown area.
- Glass City Riverwalk Toledo, OH
  - This \$23,668,160 grant will help construct more than one mile of shared-use paths with amenities, install transient docks, add a transit stop, install a bike share hub, create a kayak share location and repair existing seawall along the Maumee River in downtown Toledo.
- SR 96 Improvement Project: Providing the Critical Link Between I-16 and I-75 Twiggs County, GA
  - This \$22,000,000 grant will help construct bicycle lanes on State Route 96 as a part of the statewide bicycle network in Georgia.

More Americans than ever are relying on bikes as a means for efficient, socially distanced transportation and close-to-home recreation. Trail counters across the U.S. report a 75% increase in ridership compared to 2019, and governments at the local, state and federal levels face increased pressure to support the growing trends in active transportation by advancing infrastructure projects, enhancing safety and expanding mobility options.

# USING THE LAND AND WATER CONSERVATION FUND FOR LOCAL BIKE PROJECTS

December 4, 2020





There's an opportunity to increase funding for cities and states to build new bike projects across the U.S. thanks to the Land and Water Conservation Fund (LWCF). The federal government fully and permanently funded the LWCF at \$900 million annually when the Great American Outdoors Act became law in August 2020. This is one of the government's primary investments to ensure that Americans nationwide have close-to-home recreation.

Every year, federal funding will flow into states to protect important lands and waters for all Americans through conservation and recreation projects. Launched by Congress in 1964, the LWCF was designed to direct revenue from federal off-shore oil and gas leases (not taxpayer dollars) to acquire land and conservation easements to protect our national parks, wildlife refuges, forests and trails. The LWCF also grants funds to states for local and state park needs, protects critical wildlife habitat, watersheds and recreational access and conserves working farms, ranches and forestlands that enhance local economies.

#### What does that mean for bikes? More and improved bike lanes, trails and bike parks.

The National Park Service administers the State and Local Grants Program within the LWCF, which provides funding for state and local planning and facility development in cities, counties and rural towns. We want to encourage our local partners nationwide to think about bike projects in the pipeline that could be eligible for LWCF funding. One item of note is that LWCF state and local grants only cover 50% of project costs, and state and local grants generally receive 26% of LWCF funding (subject to appropriations).

PeopleForBikes is a member of the Outdoor Recreation Roundtable (ORR), the leading coalition of trade associations supporting the outdoor recreation industry. ORR recently put together a <a href="mailto:survey"><u>survey</u></a> (<a href="https://oregonstate.qualtrics.com/jfe/form/SV">https://oregonstate.qualtrics.com/jfe/form/SV</a> e5v0dBkxQ5Z1KDz) to create a list of LWCF-eligible recreation projects for FY22-FY25 from businesses and partners around the U.S.

The <u>survey (https://oregonstate.qualtrics.com/jfe/form/SV\_e5v0dBkxQ5Z1KDz)</u> will help ORR showcase the outstanding potential for new projects. From our point of view, that means new bike lanes, new bike parks, trails that connect communities, bike projects that support rural development and better access to recreation in diverse communities nationwide. This list will also be used to inform future priorities for the outdoor recreation economy and to educate Congress and the new administration.

We encourage bike businesses, city and state resource agencies and stakeholders involved in bike advocacy to fill out the <u>survey (https://oregonstate.qualtrics.com/jfe/form/SV\_e5v0dBkxQ5Z1KDz)</u>. Any information provided will help inform future efforts beyond 2022.

# Women behind huge increase in running and cycling in 2020

- Fitness app Strava releases global figures for the year
- 108% rise in median activities of women aged 18 to 29 in UK

Women led an unlikely global fitness boom in 2020 with large increases in the numbers running, cycling and walking during the pandemic, according to the world's biggest online fitness platform.

Strava, which tracked more than 1.1bn activities uploaded by its 72m users over the past year, found the number of uploaded runs and cycle rides nearly doubled compared with the same period in 2019, while the number of walks recorded tripled year on year.

While some of this growth could be attributed to new users, Strava's director of international marketing Simon Klima said the increase "was nothing like we've seen before and far surpassed our projections based on historical trends". Much of it, he added, was down to women being more active.

"We've seen a real boost from women in terms of overall activity levels during the pandemic year," he said. "There could be several reasons for that but in the past our research has found that one of the biggest blocks for women to cycling is a perceived safety risk. But during the pandemic women perhaps felt safer to take to their bicycles, thanks to some temporary infrastructure improvements and quieter roads."

Globally, the median number of activities uploaded by women to the platform rose by 45% year on year among those aged 18-29 and around 25% in other age categories. For men the rise was closer to just 10%.

The growth in women's activity was particularly notable in Britain. According to Strava, which has nine million UK users – around 13% of the population – there was a 108% rise in the median number of activities by women in the 18-29 age group, and rises of between 52% and 65% in other age categories.

"As well as cycling, there's also been a greater adoption of running, perhaps partly as an alternative for gym classes," said Klima. "But working from home also gives some people freedom to be active during the day as they spend less time commuting to an office. It has allowed people to take control of their calendars a little bit more and to find more time for being active."

When Strava compared the "moving time" of its users in 2020 it also showed an increase of 14.7%. "What's also interesting with all this data is that the same people have been more active this year than in previous years on average," Klima said.

According to Strava, Britons were also comparatively more active than other nations during lockdown, helped by less strict regulations on exercising outdoors compared with countries such as Italy, Spain and France, where there were huge drops in outdoor exercise levels between March and May.

Despite the lack of races and events like parkrun being suspended owing to Covid, Strava also found 55% of users hit a personal best in the 5km, 10km, half-marathon or marathon in 2020.

Its data also shows that the average distance per run in the UK is 5.5km and the average time is 33 mins and 47 secs – compared with global figures of 6.3km and 38:48.




















#### **Monthly Trail Counts 2017 - 2020**


