Forward Pinellas Board April 14, 2021

U.S. Unemployment Rate 6.0% (March)

• Florida 4.7% (March); Pinellas 4.0% (February)

Homes Sales Rising

- Median Price up 8.0% in Florida; 10.3% in Pinellas (2020)
- Volume up 5.9% (Florida 2019)

Taxable values up 7.3% in FY21

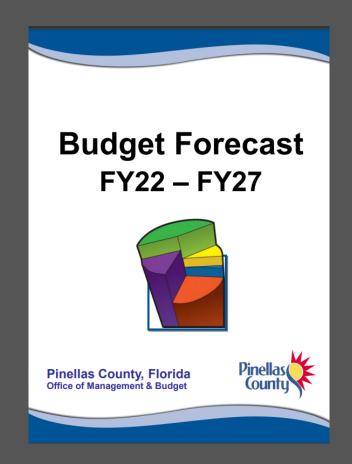


Revenues

- Countywide Property Tax Base: Growth 1.0%
- Sales Tax: Increasing 8.8% in FY22
 - Growth is from a dramatic drop during FY20 and FY21

Expenditures

- Total Salary and Benefit Costs: Growth 2.3%
 - Combined net impact of salaries, FRS, health insurance





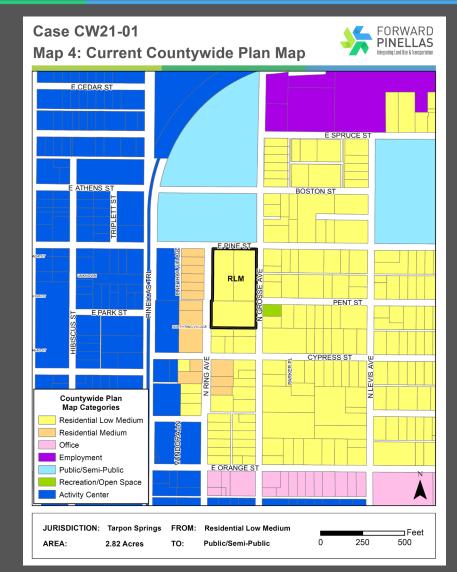
Budget Summary

- FY22 outline prepared with a millage increase from 0.0150 to 0.0160
- Property tax revenues are projected to increase by \$101,031
- Personal services (salaries and benefits) are projected to decrease by \$90,070
- Operating expenses are projected to increase by \$543,219
- Primary drivers of the increase in expenses are:
 - Professional Services (\$400,000 Target Employment Industrial Lands Study Update + Pinellas County Design Studio Pilot Program + MPO Local Cash Match + Fellowship Agreement with USF's Urban & Regional Planning Program)
 - Intergovernmental Services Charges (\$414,440)
 - Funds to maintain a minimum of 10% of expenditures in reserves

On-Going Assignments

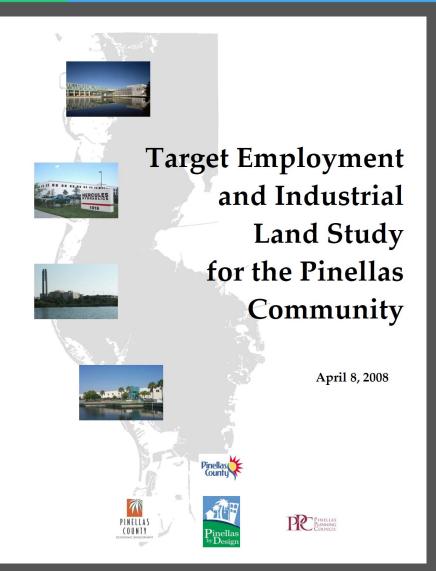
- Countywide Plan Administration (land use map amendments, consistency reviews, official interpretations, PAC, etc.)
- Technical Assistance (zoning map maintenance, mapping for special projects, etc.)
- Gateway Master Plan Implementation
- Knowledge Exchange Series
- Planning for redevelopment within the Investment Corridors in the 2045 Advantage Pinellas Plan



Draft PPC Work Plan

Key Initiatives

- Update the 2008 Target Employment Industrial Lands Study
 - Assess existing conditions, measure effectiveness of current preservation policies, identify new tools, etc.
- Partner with Pinellas County's Housing & Community Development Department to establish a Design Studio Pilot Program
 - Provide this service to local governments to help identify and visualize innovative redevelopment opportunities





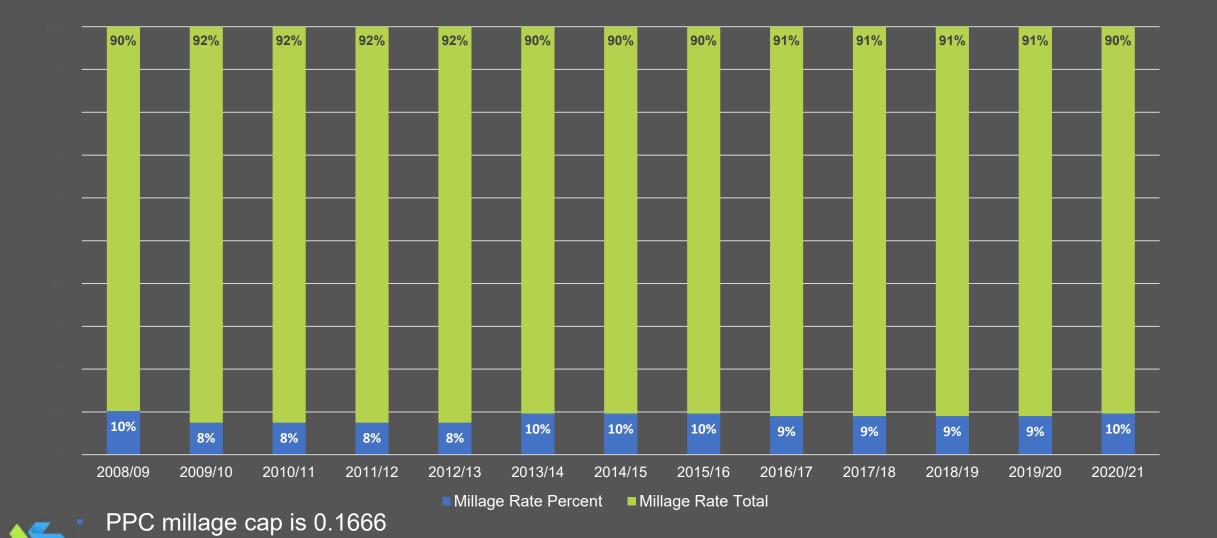
Key Initiatives (continued)

- SunRunner Bus Rapid Transit-Oriented Development Strategic Plan – Phase II
 - Develop design guidelines, architectural standards and other urban design tools for use by local governments to guide redevelopment along the corridor
