1. CALL TO ORDER AND INTRODUCTIONS

Chairman Ronald Wolfson, St. Petersburg Police Officer, called the meeting to order at 9:00 a.m. and asked members to introduce themselves.

2. APPROVAL OF MEETING SUMMARY

The summary from the October 11, 2022, meeting was approved with one mis-spelling correction, Item 5L, shared vs shard.

3. ELECTION OF CHAIR FOR 2023

Chair Wolfson shared that since he had one more year on the force, he would be happy to chair for 2023. Scott Daniels made a motion that Chair Wolfson preside for 2023. This was seconded by Lynn Abbott and passed with a unanimous vote.

4. PRESENTATION: SUNSET POINT ROAD TRAIL CROSSING

Rodney Chatman, Forward Pinellas staff, shared a presentation with the committee of the before-after study of the Sunset Point Road Trail Crossing. Due to the Vision Zero program for Pinellas County, Safe Streets Pinellas, adopted by the Forward Pinellas Board in March 2021, is taking a data driven approach to address top risk factors and

mitigating treatments to reduce potential crashes and lessen crash severity. To date, 22 of 25 local governments have adopted resolutions committing to support the implementation of the plan's recommendations. The Pinellas Trail segment in the Sunset Point Road area of Clearwater was opened in early 2020. In partnership with AECOM, Forward Pinellas consulting firm, data collection was conducted at the Pinellas Trail and Sunset Point Road crossing. The before conditions data collection was done from June 17, 2021 through June 20, 2021 from 6 a.m. to 9 p.m. The after conditions data collection was done February 17, 2022 to February 20, 2022 from 6 a.m. to 9 p.m. Data Collection included: Pinellas Trail Counts, Sunset Point Road Counts, Pedestrian Movements and Field Observations. Additional traffic control elements to make the trail crossing safer were installed with the help of Pinellas County, as well as additional signage, restriping directional travel on the Pinellas Trail, second activation poles on each side and new advanced warning RRFB's. Findings showed that pedestrians were more likely to activate the RRFB regardless of light or heavy traffic, pedestrians often paused in the center median to visually check traffic, cyclists activated the RRFB if no visible break in the traffic was evident and they were more interested in maintaining motion when crossing, but would stop if necessary; for vehicles, based on visual observations, distracted driving appeared to be a significant factor in near misses, occurring at different times of the day; eastbound traffic backed up at times, but generally did not impede the ability to cross and were more aware of the crossing as they were approaching the signal on the side of the Pinellas Trail. The findings will be used to determine future trail intersection crossing design decisions. Questions were taken and appropriately answered.

5. QUARTERLY REPORT FROM PINELLAS TRAIL PARK RANGER

Chief Ranger Carol Gray, Parks and Conservation Resources (PCR) reported from October 1, 2022 – December 31, 2022, on October 11th, there was a report of fallen tree limb on a private property fence, from hurricane Ian, the tree was removed. October 24th, report of damaged to metal bollards in the parking lot barricade at the Sunset Point Trail parking lot. November 28th, dog off leash report at trail marker 250, warning was issued by the Ranger. On December 2nd, possible vandalism of fire damage to the trash can holder at Walsingham Road. The holder was demolished and had to be removed. December 19th, report of suspected public intoxication at the Dunedin Oasis, PCSO was notified but subject moved on prior to their arrival. December 19th, two subjects were camping overnight at the Westbay overpass where Largo PD was contacted, and the subjects were moved on. December 21st, report of a golf cart on the trail on the section adjacent to Orange Street and Shore Drive. A verbal warning was issued. January 3, 2023, injury as the result of an Ebike and pedestrian crash. Injury to the pedestrian, unknown if the Ebike operator sustained any injury.

6. LAW ENFORCEMENT AND AGENCY REPORTS

A. Sheriff's Office

Deputy Brian Camadeca reported from October 1, 2022 – December 31, 2022, there were 53 documented incidences of which a majority were directed patrols, self-initiated by the deputies. Outside of that, there was one report of afterhours trespassing and one arrest on the trail that was initiated by a Dunedin Patrol Deputy that led to fentanyl recovery.

B. Belleair

Officer Allison Daniels with Belleair PD was not in attendance, however emailed in a report from October 1, 2022 – December 31, 2022 sharing there were no incidents, other than persons on the trail after dark.

C. Clearwater

Officer Jarred Stiff reported from October 1, 2022 – December 31, 2022, there were 255 calls, where many of those calls were directed patrols or park walk and talks that were initiated by the officers who work the area or the bike teams on patrol. There was one arrest for battery between two subjects and one drug arrest North of Drew Street in the Maple and Myrtle area where many of the homeless hang out. A majority of issues being reported are mainly coming from between Drew Street to Eldridge Street, where a lot of the directed patrols are happening.

D. Gulfport

Gulfport PD submitted a report from October 1, 2022 – December 31, 2022 sharing there were no incidents.

E. Largo

Officer Keith Bowling was not in attendance, however emailed in a report from October 1, 2022 – December 31, 2022, sharing a welfare check, a traffic stop, a few trespasses and three citizen contacts.

F. St. Petersburg

Officer Osvaldo Sicairos reported from October 1, 2022 – December 31, 2022, there were four drug related calls resulting in arrests, one after hours call at 34th and 40th, one armed robbery of a transient's bike, resulting in an arrest. One camping incident under the pedestrian overpass.

G. Tarpon Springs

Officer Anthony Boone reported from October 1, 2022 – December 31, 2022, 1 medical call near Mears Blvd. He shared that they are understaffed, but will request additional checks to the trail especially in the Elfers Spur area of the trail.

H. Animal Services

Jacob Laboy of Animal Services reported there were no incidents in the last quarter.

I. Public Safety Services

Ms. Lynn Abbott, Pinellas County EMS & Fire Administration reported from October 1, 2022 – December 31, 2022, there were 39 total incidents on or near the trail, noting all were non-condition related events: 10 bike falls, 2 scooter falls; 8 pedestrian falls, 1 dog bite, 1 deer crash into a pedestrian (Keystone Road and the Pinellas Trail), 5 sick persons, 2 wheelchair falls (Trail & Skinner Blvd., trails marker 0358), 3 motor vehicle collisions and 1 overdose. 8 no patient found/cancelled calls.

J. Pinellas County Risk Management

Mr. Scott Rintz shared that risk management completed the second yearly safety inspection and found no major issues. He also shared the department feels the inspection results have greatly improved over the last several years. The next inspection is scheduled for March 2023.

K. Friends of the Pinellas Trail

Scott Daniels shared it is vital to the Pinellas Trail for law enforcement members who do not attend, to send us their reports for up to date information. Mr. Daniels shared a news article sharing the perspective of the writer on how unsafe the trail is. The marking dividing the walkers from the bikers should be redefined, speeders should be fined, and it is important that we continue the efforts to keep up with the safety and security of the Pinellas Trail.

L. Volunteer Patrol Programs and Updates

Chair Wolfson shared that his volunteers are still active. They helped the Park Ranger with some cleanup of abandon property.

Chief Gray shares that the Ranger volunteers are trickling back after Covid.

Aux. Ranger Stuart Schwartzreich did a patrol following the hurricane and observed debris already cleaned up. He shard pictures to trail users who responded favorably with appreciation to the county workers for quick action clean up. He also mentioned the increase in graffiti from the Trop, along the Pinellas Trail and to the new apartment building on 17th Street S. See-Click-Fix has been extremely instrumental in helping to clean up the graffiti.

7. AUTOMATIC TRAIL COUNTERS

Mr. Simpson shared there are still issues with the East Lake counter and those counts were not included in the chart. August showed just under 130,000 users with more bike than pedestrians. Questions were taken and appropriately answered.

8. REPORT ON TRAIL CONSTRUCTION ACTIVITY

Joan Rice was not in attendance but has updated the Trail Construction Activity report included in the agenda packet.

9. OTHER BUSINESS

No other business.

9. ADJOURNMENT

Chairman Wolfson adjourned the meeting at 10:07 a.m. The next PTSTF meeting is scheduled for April 11, 2023.

Summary

Forward Pinellas has received an increasing number of complaints about speeding on the Pinellas Trail. 


December Trail Users by Counter Location



















February Trail Users by Counter Location








