1. **CALL TO ORDER/PLEDGE TO FLAG/INTRODUCTIONS**

Robert Feigel, Forward Pinellas staff, reviewed the Zoom meeting guidelines and the attendees were announced by Maria Kelly. There were 30 attendees. Chair Karen Mullins called the meeting to order at 7:00 p.m. Chair Mullins welcomed guests at this time.

2. **APPROVAL OF MINUTES**

Michael Mannino made a motion to approve the minutes. It was seconded by Dimitri Karides. The minutes were approved with no corrections.

3. **FORWARD PINELLAS ACTIONS**

Al Bartolotta, Forward Pinellas Planning Division Manager, reviewed the highlights of the Forward Pinellas Board meeting for March 11, 2020. The Board approved the grant awards for the Complete Streets Program and the four amendments to the Transportation Improvement Program. The Board also received two presentations. One of the them was on Transportation Resiliency, presented by Karen Kiselewski, Cambridge Systematics. The other was a presentation from Taryn Sabia, Director of the Florida Center for Community Design and Research at the USF School of Architecture and Community Design. She presented their Transit Oriented Development and Value Capture Study. The Board also approved the Unified Planning Work Program (UPWP) for transmittal to state and federal review agencies. The Board also accepted the final audits on the MPO and PPC. The board also received a presentation from Heather Sobush, PSTA, on the Transit Development Plan.

4. **ELECTION OF A VICE-CHAIR**

Chair Mullins shared with the committee that Vice-Chair John Estok resigned from the committee just after the March 26 meeting. Therefore, the committee will need to elect a vice-chair. Nominations were requested, at which time Bob Henion nominated Tammy Vrana. Axl David nominated Mike Mannino. There was a question as to whether Mike Mannino could be nominated due to his length of service on the committee. A quick review of the bylaws by staff revealed that there were no requirements that would preclude him from being nominated. Therefore, the committee proceeded to cast their votes for one of the two nominations. After the votes were tallied, it was announced that Tammy Vrana received the most votes. Steve Graber made a motion to make Tammy Vrana Vice-Chair. It was seconded by Tracey Schofield and passed with a unanimous vote.

5. **FY 2019/20 – FY 2023/24 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)**

Jensen Hackett, Florida Department of Transportation (FDOT) District 7, presented a Transportation Improvement Program (TIP) modification for the current 2019/20-2023/24 Transportation Improvement Program. Forward Pinellas receives state and federal grant funding through the Florida Department of Transportation (FDOT) for its planning activities identified in the two-year Unified Planning Work Program (UPWP). Every two years, this funding is reviewed against current and anticipated UPWP projects. Any funds left over in the current fiscal year that would be used after July 1, need to be “deobligated”. This adjustment will move the funds from the current fiscal year into the new fiscal year. These changes have already been accounted for in the UPWP but must now be reflected in the TIP. In addition, the TIP must reflect the adjusted Metropolitan Planning (PL) fund amounts Forward Pinellas will budget in the UPWP regardless of the deobligation. A motion was made by Mike Mannino to recommend approval to the Forward Pinellas Board. It was seconded by Brian Scott and passed with a unanimous vote.

6. **ANNUAL ADOPTION OF PRIORITIES**

Chelsea Favero, Forward Pinellas staff, reviewed proposed changes to the Multimodal Project Priority List with the committee. Review of the Forward Pinellas priority lists occurs on an annual basis prior to the transmittal of the project priorities to FDOT for consideration in the development of their next five-year work program. Since the last update of the multimodal list in 2019, three projects were allocated funding for implementation and are being moved from the “unfunded” section. Several

projects, including one complete streets construction project, and a bicycle pedestrian project are being added as well as updating several project descriptions. Projects being proposed for addition to the list were identified as priorities in the recently adopted Advantage Pinellas Plan. Bill Jonson requested information as to why the Belcher Road/State Road 60 intersection improvements was not on this list. These improvements included a median U-turn design previously reviewed by the committee. It was indicated that the Board of County Commissioners had yet to approve this project. This needed to occur before the project could be added to the priority list. Discussion ensued resulting in a motion for the CAC Chair to compose a letter asking the Forward Pinellas Board to add the Belcher Road/SR 60 improvements to the Multimodal Priority List. A motion was made by Brian Scott to prepare and send the letter. It was seconded by Bill Jonson and passed with a 18-1 vote. A motion was made by Steve Graber to recommend approval to the Forward Pinellas Board to adopt the Multimodal Priorities. It was seconded by Luis Serna and passed with a vote of 18-1. Following this action, The Transportation Alternatives (TA) Program Priority list was approved by the committee at the March meeting but was reviewed as well to remind committee members of the proposed changes to that list. It was noted that no action was needed on the TA list at this time. Questions were taken and appropriately answered.

7. TBARTA REGIONAL RAPID TRANSIT PROJECT

Brian Pessaro, TBARTA Principal Planner, and Scott Pringle with WSP shared a power point presentation with the committee on the TBARTA Regional Rapid Transit (RRT) project. The Tampa Bay Regional Transit Authority (TBARTA) has been conducting a Project Development and Environment (PD&E) Study for the project. The RRT is a planned 41-mile bus rapid transit system that will operate on I-275 in Hillsborough, Pasco, and Pinellas counties with service from Wesley Chapel to downtown Saint Petersburg. The purpose of this project is to provide transportation for cross county commuters. This project began in May 2019 and should be completed by the summer of 2021. The TBARTA Board has approved 13 recommended station areas and directed WSP, the study consultant, to evaluate in greater detail five alignment alternatives. In March, TBARTA hosted a series of station charrettes where members of the public provided input on the preferred station typologies, features, and locations. Questions were taken and appropriately answered.

At this time Bill Jonson was asked to update the committee on the last TBARTA CAC Committee meeting. Bill Jonson shared that the TBARTA CAC met on April 15 via Zoom and the only action item was the Envision 2030 Plan. The draft final report was reviewed. The committee voted to recommend the adoption of the proposed Regional Transit Vision Network with modifications. There was also mention of Regional Transportation Disadvantaged network opportunities presented in the plan. The committee also heard an informational presentation on Commute Tampa Bay which is the new name for the Van Pool Service. The next meeting is scheduled for June 17, 2020.

8. PUBLIC PARTICIPATION RESOLUTION

Mr. Bartolotta addressed the committee regarding a draft Board resolution addressing public participation during the COVID-19 pandemic. The resolution supports the use of digital and online public involvement strategies that allow advisory committee meetings to be held virtually. It also supports the employment of these strategies to provide opportunities for public feedback on Forward Pinellas plans and programs. The resolution applies to the interim period while public safety directives associated with the COVID-19 virus are in effect. It will be presented to the Forward Pinellas Board at their next meeting on May 13, 2020. Questions were taken and appropriately answered.

9. FORWARD PINELLAS ANNUAL CERTIFICATION

Mr. Bartolotta reviewed the Annual Certification with the committee. As the metropolitan planning organization (MPO) for Pinellas County, Forward Pinellas is subject to an annual joint certification review with the FDOT District 7 office. The purpose of the certification review is to ensure that

Forward Pinellas is in compliance with federal and state requirements governing MPO planning processes. The certification review for 2019 was conducted in March and Forward Pinellas was found to be in compliance with state and federal requirements. Tracey Schofield made a motion for the Forward Pinellas Board to approve the Annual Certification. It was seconded by Bill Jonson and passed with a unanimous vote. Questions were taken and appropriately answered.

The Forward Pinellas Board held this public meeting virtually on Wednesday, May 13, at 1 p.m. to ensure public safety and comply with the Governor's Safer at Home order in response to the COVID-19 pandemic.

The Forward Pinellas Executive Director introduced the new Forward Pinellas Board Member, Commissioner Connor Donovan, representing the City of Tarpon Springs, City of Oldsmar and City of Safety Harbor.

The Forward Pinellas Board unanimously adopted Emergency Resolution 20-01 defining procedures for virtual meetings of the board and committees during the current, locally declared, state of emergency.

- The board will continue to hold virtual meetings through Zoom as long as the Governor's Safer at Home order is in effect at the time of the scheduled meeting.

The board unanimously approved a modification to the Transportation Improvement Program (TIP)

- The FDOT proposed a TIP modification, adjusting the yearly amount of Federal Highway Planning (PL) funds for 2020-2023(FY) to match the Unified Planning Work Program (UPWP).
 - FY 2020 PL funds are being adjusted from \$1,614,350 to \$1,392,350
 - FY 2021 PL funds are being adjusted from \$1,022,963 to \$1,219,948.
 - FY 2022 PL funds are being adjusted from \$1,022,963 to \$997,948

The board unanimously adopted the Transportation Priorities (Multimodal and Transportation Alternatives)

- The board, acting as the Pinellas County Metropolitan Planning Organization, adopted the annual priority lists of projects for state and federal funding. These include the Multimodal Priority List and the Transportation Alternatives Program Priority List.
- *Newly Funded Projects:*
 - 22nd Street South – St. Petersburg Complete Streets (FY 24/25)
 - PSTA Bus Replacements (FY 24/25)
 - Alt 19 @ Florida Avenue intersection modification (FY 21/22)
- *New projects proposed for funding*
 - Skinner Blvd (SR 580) Complete Streets (Agency Grant)
 - 18th Ave S Bike/Ped Facility (Advantage Pinellas Active Transportation Project)

- Gulf to Bay Blvd (SR 60)/Duke Trail Overpass (Advantage Pinellas Active Transportation Project)
- Gateway Intermodal Center (SPOTLight Priority)
- Pasadena Ave (SR 693) Operational Projects (SPOTLight Priority)
- Karen Mullins joined in as a participant and shared concerns about the Gulf to Bay and Belcher Road intersection not being shown on the priority list.

The board unanimously approved two land use amendments to the Countywide Plan:

- A land use amendment brought forward by the City of Clearwater to amend Public/Semi-Public to Office at 407 N. Belcher Rd., that will allow the property owner to lease the space for financial office rather than a medical office use.
- A land use amendment brought forward by the City of Safety Harbor to amend a parcel from Residential Low Medium to Recreation/Open Space, at 1550 Martin Luther King Jr. St. N. in order to expand the Folly Farms Nature Preserve.

The board approved (11 – 1) an amendment to Ordinance No. 15-30 of the Countywide Rules:

- This ordinance amends the Countywide Rules to adopt the Residential Rural land use category and updates definitions for Submerged Land and Agricultural-Light.

The board unanimously ratified an amendment to the Transportation Improvement Program and adopted amendments of the Internal Control Structure Policy Manual to allow for future TIP amendments to be handled administratively during emergencies:

- In March 2020, the Florida Department of Transportation (FDOT) proposed an emergency amendment to the FY 2019/20 – 2023/24 Transportation Improvement Program (TIP) in response to the COVID-19 pandemic. In order to complete planned projects, and ensure continued employment for Florida residents, this amendment enables FPN 445410-1 to proceed with a bid letting date of July 2020. This project will install an opaque visual barrier on top of the existing median barrier wall on US 19 from 126th Avenue North to South of Seville Boulevard.
- Forward Pinellas is ensuring it can continue to make amendments to the TIP during emergency situations by adding the following language to the Internal Control Structure Policy Manual: “In the event of a locally declared emergency which prevents the Forward Pinellas Board from convening, the Executive Director is authorized to approve amendments to the Transportation Improvement Program if said amendments either add a project already in the Long Range Transportation Plan to said Program, or to add projects or phases of a project with a construction budget of five million dollars or less. Such amendments shall not affect the allocation of funds to or by Forward Pinellas or approved project priorities and shall be subject to ratification by the Forward Pinellas Board.”

SPOTlight Update:

Gateway Area Mid-County Master Plan: The Executive Director provided an update on the transition of the Gateway Master Plan from a planning focus to an implementation focus through development of a memorandum of agreement between the five local government partners, including Forward Pinellas. The expectation is for the agreement to be approved by the respected governing bodies later this year.

US-19 Project: As an update on the US-19 project, adjacent land owners have asked the Florida Department of Transportation (FDOT) to reconsider the location of the pedestrian/bicycle underpass north of SR 580. The Forward Pinellas team is awaiting an analysis from FDOT and will report to the board in July. We will make sure to communicate this to local business owners and concerned citizens.

Waterborne Transportation Subcommittee: This meeting will be rescheduled during the summer due to the pandemic. Updates will be presented as soon as this is scheduled.

I-275 Supplemental Environmental Impact Study (SEIS) Update:

SEIS is a federal process for environmental considerations, including neighborhood and community impacts. This study covers I-275 in Hillsborough County from the Howard Frankland Bridge to Martin Luther King, Jr. Blvd, and I-4 from I-275 to East of 50th St. in Hillsborough County. Forward Pinellas is a partner in planning for the regional transportation network. SUMMARY

Forward Pinellas is required to adopt a fiscal year (FY) 2020/21 – FY 2024/25 Transportation Improvement Program (TIP) by July 1, 2020 for the county to receive state and federal funding for transportation projects. The TIP contains project descriptions, schedules, and corresponding funding allocations regarding scheduled transportation improvement projects for the 25 local governments of Pinellas County, the Pinellas Suncoast Transit Authority (PSTA), local airports, and the Port of St. Petersburg. The projects include new construction, reconstruction, capital purchases, and maintenance work associated with roads, sidewalks, trails, transit services, airports, the Port of St. Petersburg, and the Transportation Disadvantaged Program. Projects included in the TIP for state and federal funding must be in the adopted Long-Range Transportation Plan.

The annual TIP adoption process involves incorporating the attached Florida Department of Transportation (FDOT) FY 2020/21 – FY 2024/25 Final Tentative Work Program into the TIP. The FDOT Work Program includes a five-year schedule of state and federally-funded transportation projects, including new projects introduced in the fifth year (2024/2025). At its November 11, 2019 meeting, the Forward Pinellas Board approved the draft version of this document.

SUMMARY

The COVID-19 pandemic has had a dramatic impact on the way people get around and the transportation facilities they use. Changes have been noted on the usage of local multiuse trails, vehicular traffic volumes on major roadways, the number of users on the local transit system, and even on the number and severity of crashes countywide. SUMMARY

Rectangular Rapid Flashing Beacons (RRFBs) are traffic control devices typically installed at mid-block locations that provide significant safety benefits. They provide higher yielding for pedestrian rates as demonstrated by a study in 2016 conducted by the Texas A&M Transportation Institute (TTI). Factoring in appropriate design considerations as identified in the 2016 TTI study and compliance with Federal Highway Administration (FHWA) design conditions, RRFBs can increase pedestrian safety at marked crosswalks by 98%. The City of St. Petersburg's initiative to employ RRFBs at uncontrolled marked crosswalks over the past three years has resulted in increased yielding for pedestrian rates from 2% to a current 90% yielding rate.

RRFBs provide an economical and highly effective traffic control countermeasure that slows traffic and saves lives. Two proposed bills in the most recent Florida legislative session, Senate Bill 1000 and House Bill 1371, effectively disallowed RRFBs in the State. Enactment of the bills would have forced the removal of most, if not all, of the over 400 mid-block crossings in Pinellas County, substantially reducing the safety of pedestrians while imposing significant costs on tax payers. Forward Pinellas, and many other MPOs throughout the State, as well as local governments and other organizations voiced their opposition to SB 1000 and HB 1371 during the Legislative Session. Although neither of the bills were passed, they underscored the need for increased citizen education and awareness on RRFBs statewide and locally. Forward Pinellas staff will provide a presentation on this item.

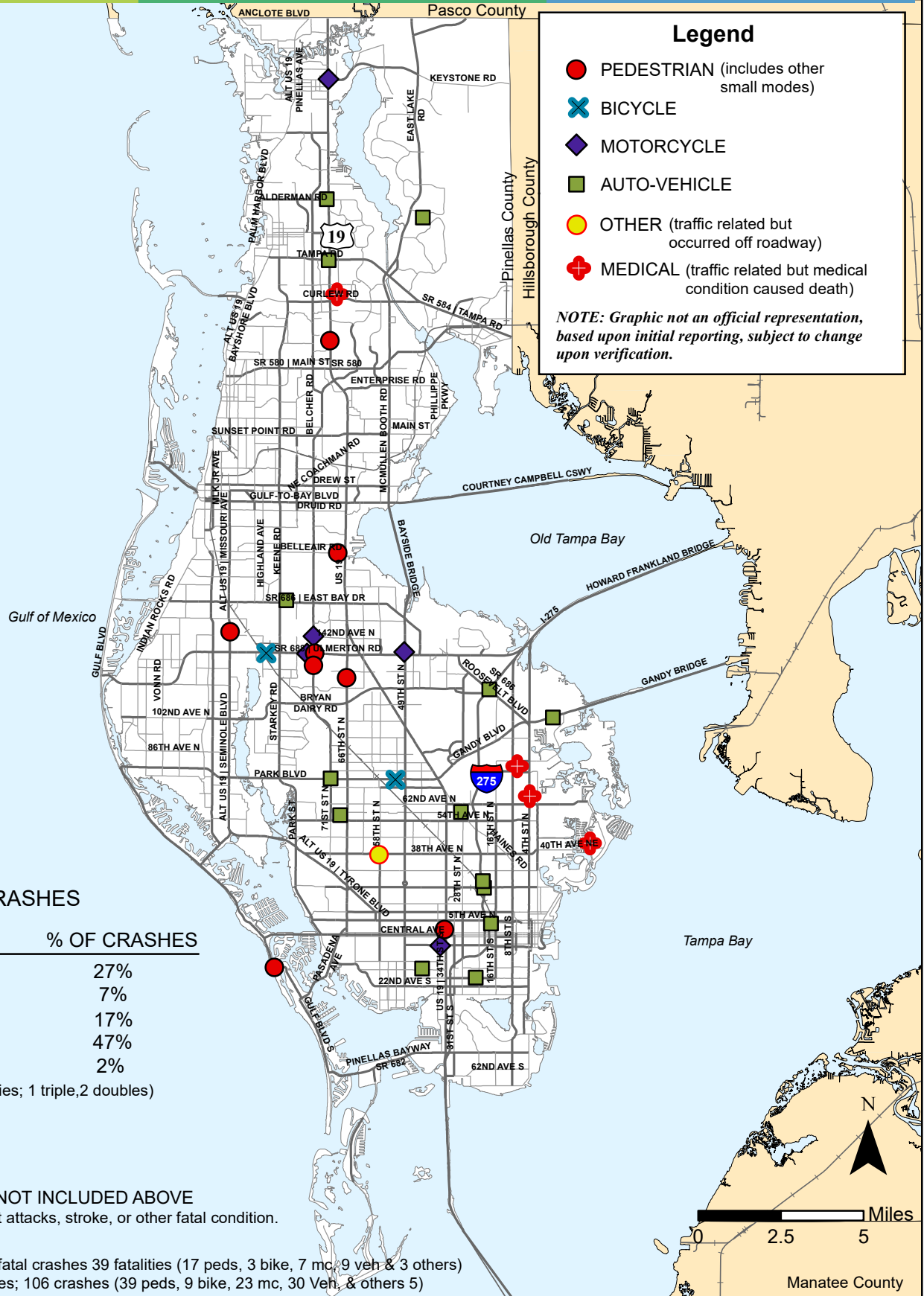
