1. CALL TO ORDER

Chair Paul Zagami called the meeting to order at 8:30 a.m. and the attendees in the room introduced themselves.

2. PUBLIC COMMENTS

Daniel Alejandro inquired as to if Brian Smith was recognized for his 10 years of service to the BPAC and it was confirmed that he was recognized at his last BPAC meeting, November 20, 2023 and at the January 10, 2024 Forward Pinellas Board meeting.

3. APPROVAL OF MINUTES

The summary from the November 20, 2023 meeting was approved with no corrections.

4. FORWARD PINELLAS ACTIONS & SPOTLIGHT

Kyle Simpson, Forward Pinellas staff, reviewed the January 10, 2024, Forward Pinellas Board summary. Brian Smith was recognized for his 10-year service as Chair to the Bicycle Pedestrian Advisory Committee. The Board endorsed the Regional Transportation Priorities, from the Transportation Management Area (TMA) Leadership Group, made up of Pasco, Hillsborough and Pinellas county MPOs. The Board also approved the Advantage Alt 19 Plan and Recommendations, looking at the Alt 19 corridor from St. Petersburg to Clearwater. The Board also approved the Complete Streets Grants, awarding St Petersburg \$100,000 in planning funds for 31st Street, and the \$1.5 million construction funds for curb extensions in the Grand Central District. Forward Pinellas staff provided an update on the Housing Action Plan, a Countywide Plan, trying to address the Affordable House challenges we see not only in the county, but in the Tampa Bay region.

Regarding the SPOTLight Emphasis areas. Staff is continuing to work with Honeymoon Island State Park on the turnarounds at the park entrance and working with Florida State Parks in hopes of getting some funding for this project. Forward Pinellas and FDOT are leading a survey, in the Gateway Area, of the major employers to form a transportation management group to help facilitate alternatives to single occupant vehicle trips for work purposes. Regarding Waterborne Transportation, PSTA received just under \$700,000 grant for ferry operations, to help restart Clearwater Ferry in the fall of 2024. Regarding US19 and the interchanges in North County, staff is working with FDOT to hold public meetings in the spring of 2024.

5. PROPOSED AMENDMENTS TO THE TRANSPORTATION IMPROVEMENT PROGRAM

Mr. Simpson noted this item should not have appeared here.

6. SAFTEY PERFORMANCE MEASURES

Ariane Martins, Forward Pinellas staff, shared a brief presentation on the Safety Performance Measures and Targets recommendation. There are five performance measures addressing safety: number and rate of fatalities, number and rate of serious

injuries, and number of non-motorized fatalities and serious injuries, combined. Staff is federally required to report on the measures each year and set targets. The data covers a five-year rolling average for 2018 – 2022. While Forward Pinellas recognizes that zero is a goal that everyone should strive for, staff recommends setting targets that are realistic and achievable. the adopted targets for nonmotorized serious injuries and fatalities has been achieved. Staff is recommending that new targets be set for this metric, utilizing the same methodology applied the last time targets were set. Given that there is still progress to be made toward achieving the targets set last year for the other measures, staff is recommending that these targets remain the same for the coming year. These targets are taken into consideration each year when Forward Pinellas advances transportation projects forward for funding. Discussion ensued where questions were taken and appropriately answered. Gordon Brown made a motion to recommend the Forward Pinellas Board approve the Safety Measures and Targets, as recommended. This was seconded by Stuart Schwartzreich and passed with a unanimous vote.

7. DUNEDIN CAUSEWAY

Tom Washburn, Pinellas County Public Works, shared a brief presentation on the recent changes to signage on the Dunedin Causeway. The Dunedin Causeway starts at Alt. 19 and runs west to Honeymoon Island State Park. The Royal Stewart Arms Condominiums are located at the end of the causeway just before Honeymoon Island State Park. The Causeway, which is owned by Pinellas County, features a multiuse trail that connects the Honeymoon Island State Park trail system to the Pinellas Trail. While the trail is typically built to current standards, there are three pinch points at the two tidal bridges and drawbridge on the Causeway where the trail width reduces to six feet. These pinch points have resulted in conflicts between people on bicycles and people walking. In January 2022, a complaint was received regarding dangerous interactions of pedestrians and bicyclist on the bridges. In April 2022, enforceable signage was posted for bicyclists to dismount and walk their bicycles across the bridges. In November 2022, a follow-up meeting was held with Forward Pinellas, Pinellas County staff, Dunedin staff and the Pinellas County Sheriff's Office to re-evaluate the signage. In February/March 2023, updated signs and markings were installed still indicating bicyclists must dismount and walk bikes across bridge. Bicyclists have an option to ride on the road, indicated by sharrow markings, but the bridge itself could be dangerous when wet, indicated by slippery when wet signs. Construction of a new bridge is scheduled for construction in FY26, with wider bicycle/pedestrian areas, at which time dismount signs will be removed. Questions were taken and appropriately answered. At this time, Ron Englert of the BPAC shared a presentation questioning why the "Yield to Pedestrians" signs were removed, and bicyclists now had to dismount and walk their bikes across the bridge. Mr. Englert feels this is unnecessary and taxing on the elderly and very young cyclists to walk their bikes this distance. Mr. Englert also discover these changes were made due to one citizen claiming to have been hit 19 times by bicyclist passing since 2020 on the Causeway bridges. Mr. Englert shared several options for sign placement that could be less confusing to the public and submitted a resolution to the BPAC asking the BPAC to urge Pinellas County to reconsider whether the signs ordering bicyclist to dismount are necessary and/or whether other means of addressing concerns of safety of pedestrians are available which do not have such a strong deterrent effect on bicyclist with to access the Dunedin Causeway and Honeymoon Island. After discussion, it was determined that the resolution cannot come from one person on the committee, it needs to come from the committee, addressed to the Forward Pinellas Board to ask the County to look into further solutions. The motion was made stating that the BPAC urges the Forward Pinellas Board to make a recommendation to the County to reconsider whether the signs ordering the

bicyclist to dismount are necessary and/or whether other means of addressing concerns of safety of pedestrians are available which do not have such a strong deterrent effect on bicyclist wishing to access the Dunedin Causeway and Honeymoon Island.

It is resolved that the BPAC urges the Forward Pinellas Board to work with the County to reconsider whether the signs ordering the bicyclist to dismount are necessary and to reevaluate the situation including the signs and other alternatives.

A motion was made to suggest this proposal to the Forward Pinellas Board by Ron Englert. This was seconded by Eric Sorenson and was passed with a unanimous vote.

8. PROPOSED REGIONAL MPO

Chelsea Favero, Forward Pinellas staff, provided an overview of the merging of the MPOs for Hillsborough, Pinellas, and Pasco counties. Federal law requires that each urban area with a population greater than 50,000, as determined by the US Census, be represented by a metropolitan planning organization (MPO) to bring local input to the allocation of state and federal transportation funding and to the overall transportation planning process. Since their original designations, the developed areas of Pinellas, Hillsborough and Pasco have grown together and the transportation networks of the three counties have been functioning as one, regional unit, instead of three separate ones. In 2023, as the MPOs discussed even more coordination opportunities, the Legislature required that the MPOs officially explore the feasibility of merging the three into a single regional MPO for the Tampa Bay area, Local and regional officials suggested that now may be the right time to move forward with looking into the merger of the three MPOs. A request from the legislature was received to formally document the benefits, costs and feasibility of a merged MPO. A report of the same was formally submitted to the legislature just last month. A two phased approach has been put together in moving forward with a merger. Phase I is approving an Apportionment Plan, which basically says how an MPO is going to vote; who does and does not have a voting seat; how do the smaller communities retain a voice and to make sure the Apportionment Plan meets state and federal laws. On February 16th, 2024 the first meeting of the TMA, to begin discussions of the Apportionment Plan, will be held at Tampa International Airport if members of the public would like to attend (there is a virtual option posted on the Forward Pinellas calendar). Questions were taken and appropriately answered.

Due to time constraints, Item 12B – 2024 Florida Legislative Session Update was presented by Whit Blanton, Forward Pinellas Executive Director, Mr. Blanton shared that Senate Bill (SB) 1032, filed by Senator Gruber from Sarasota, with a House Bill (HB) companion filed by Representative McFarlan from Sarasota, proposes to significantly revise MPO's and other statewide changes, requiring MPOs to adopt quality performance measures and to submit an annual report on those quality performance measures to include traffic flow and congestions and utilization transportation facilities. Also required is to submit those scores to the Florida Department of Transportation (DOT) to review and rate the MPOs with an A – F score. Failure to perform up to standard will allow the DOT Secretary to take over the MPO, fire staff, merge MPO's and reconstitute the board. A high score, perform really well, the MPO will receive \$5 million dollars. This is a violation of federal law. MPOs were created by federal law to counterbalance the state's department of transportation. Senator Hooper has filed a bill, SB 266, that would cap the amount of money to spend on transit, through the state's transportation trust fund, capping it at 20%. There is a minimum spend now of 15%. This sets up more barriers to get transit projects funded. Again, violates the purpose of having an MPO. A bill filed to reconstitute the

Pinellas Suncoast Transit Authority (PSTA), changing the board from 15 to 11. On the bike/ped front, there is HB 449 speeding by motor vehicles, which would increase the fine and create a felony situation for any drivers going 30 mph over the speed limit. SB 1528 violations against vulnerable road users, increasing the penalties for people found liable to cause serious bodily injury or death of a vulnerable road user. Questions were taken and appropriately answered.

9. ACTIVE TRANSPORTATION PLAN UPDATE

Mr. Simpson shared a presentation with the committee on the development of the current Active Transportation Plan (ATP) in conjunction with the Advantage Pinellas Long Range Transportation Plan (LRTP) process. Like the LRTP, the ATP identified a desired trail and bicycle facility network throughout Pinellas County, and then used a scoring system to develop a cost feasible list for projects through 2045. Forward Pinellas committed to funding ten corridors (\$62 million) and four overpasses (\$24 million) with its flexible funding over the life of the plan. Since development and adoption of the ATP, multiple corridors and overpasses have advanced for design and construction, while some need to be amended due to constraints identified after initial development of the plan. In conjunction with the ongoing Advantage Pinellas LRTP work with a 2050 planning horizon; Forward Pinellas is working with one of its general planning consultants to update the plan and extend the planning horizon from 2045 to 2050. One of the initial deliverables was the development of a Level of Traffic Stress map. The Level of Traffic Stress is a way to look at how comfortable it is to bike somewhere; how bad is the traffic where biking; how comfortable is the biker on the sidewalk in the area. The Level of Traffic Stress map shared showed neighborhood streets in blue, and arterials in red. This information will help in determining where the gaps are in the network and work to close those gaps. Staff will also be reviewing the projects that were prioritized and making sure the local governments still support the recommendations due changes in the funding components. Forward Pinellas committed to funding four overpasses in the current transportation plan, however two overpass projects have been deemed infeasible, the Duke Energy Trail at Drew Street and SR60, and staff would like to get the opinion of the committee to add two more potential overpasses for funding or to add one overpass and possibly at-grade projects around the county. Questions were taken and appropriately answered.

10. BUSINESS

A. Friends of the Pinellas Trail

Stuart Schwartzreich filled in for Scott Daniels, shared the board of directors has a meeting scheduled with the Parks and Conservation Department to discuss strategic and practical issues both groups are considering. January 30, 2024, the board of directors has an open public meeting at 6:00 pm, at the Largo Public Library. Chief Ranger Kent Cleveland will be speaking. Annual Trail Volunteers picnic will be in March, date to be determined. Friend Facebook page is approaching 10K members. Friends would be happy to advertise or promote trail events.

11. AGENCY REPORTS

Pinellas Trail Loop/Duke Energy Trail (North & South Gaps)

Ms. Joan Rice shared an update on the Pinellas Trail Loop. The bridge going over Lake Tarpon, construction is still planned for the spring. For the South Gap, south of Hanes Bayshore, south of Ulmerton Road is in design, construction still planned for 2026.

• Clearwater Bicycle Pedestrian Program

Jayme Lopko shared there were no updates.

• St. Petersburg Bicycle Pedestrian Program

Ms. Elisabeth Staten, St. Petersburg Transportation, the Safe Streets and Roads for All application did not receive full funding, but it did receive supplemental funding which will help update the Complete Streets Implementation Plan and adding a Traffic Safety in Equity component which will act as a Vision Zero component. St. Pete was also invited to submit a full proposal for the Better Bike Share program working with Lime and PSTA to help streamline the transportation disadvantaged application with Lime access program to help register people for lower cost micromobility trips in addition to their transportation disadvantage.

• Largo Bicycle Pedestrian Program

Whitney Clark shared that the Rosery Road LAP project is scheduled to begin mid-October. Just a sub-set of the entire project that extends from Long Bayou Creek to Eagle Lake Park.

• Oldsmar Bicycle Pedestrian Program

No one in attendance.

• Pinellas Park Bicycle Pedestrian Program

Tiffany Menard shared there were no updates.

• Dunedin Bicycle Pedestrian Program

Kathy Gademer shared there were no updates.

• Tarpon Springs Bicycle Pedestrian Program

Caroline Lanford shared there were no updates.

Mr. Simpson shared that Walk Audits are taking place today, January 22nd, on 49th

Street S, with the cities of Gulfport and St. Petersburg. A Forward Pinellas Safe Streets and Roads for All project. One Walk Audit will be from 2:00 to 4:00 pm and the other from 5:30 to 8:00 with the Business District Assoc., meeting at 1617 49th Street S, Gulfport Community Center.

On Saturday, February 17th, Forward Pinellas has planned a Target Enforcement Day on the Pinellas Trail. This was organized by the Pinellas Trail Security Task Force (PTSTF) committee made up of law enforcement members from municipalities that touch the Pinellas Trail. Officers will be out on the trail and at intersections enforcing the rules for trail users plus motorists at trail crossings, primarily purpose is education with enforcement, if necessary, from 9:00 am – 12:00 pm.

Bike Your City will be held on Saturday March 2nd in St. Petersburg. It will begin and end at the Childs Park Rec Center and the ride will begin at 9:30. More to come.

People for Bikes found out that FDOT did a project on the Bay Way, the Cycle Track, and it made the list of the best Bicycle Facilities in 2023.

Ms. Favero shared that Forward Pinellas is ramping up public outreach for the Long-Range Transportation Plan and trying to be at as many public events as possible. If anyone has an event, they would like to see Forward Pinellas at, please reach out to us.

Peter Wray shared on January 26 at 7:30 a speaker, Ray Delahanty, the Guy behind CityNerd, a nationally known Urbanist Transit, whom the St. Petersburg Chamber of Commerce will be bringing in to speak at the Chambers 125th Annual Meeting.

James Phillips with PSTA shared they are well on their way with community engagement with the PSTA Community Bus Plan. He would like to work with Forward Pinellas for recommendations on their Road Show in the April-May time period.

Daniel Alejandra shared an encouraging suggestion advocating for safety on the Trail is to consider a yellow dash sign in the middle of the Pinellas Trail with signs that state every two miles to keep right and pass on the left when it is safe to do so. Mr. Simpson shared that Brian Smith met with Parks on the very reason. Public Works is working right now to determine where to place the arrows.

A. Friends of the Pinellas Trails

A representative from Friends of the Pinellas Trail may take this opportunity to provide an update. Information on the Friends of the Pinellas Trail is available at FriendsOfThePinellasTrail.org.

B. Tri-County BPAC

The Tri-County BPAC is comprised of representatives from Forward Pinellas, Pasco MPO, and Hillsborough TPO and meets three times per year with each county hosting one meeting. The meetings take place in the evening and are scheduled for Thursday, February 15th in Pasco, Wednesday, July 10th in Hillsborough, and Tuesday, October 29th in Pinellas this year. Forward Pinellas staff are seeking at least two BPAC members to serve as Forward Pinellas BPAC representatives at the July and October Tri-County BPAC meetings.

C. Bike Your City 2024 - St. Petersburg - Saturday, March 2, 2024

Each year for Florida Bicycle Month Forward Pinellas hosts a community bicycle ride in different communities around Pinellas County. This year's ride will be in St. Petersburg, beginning and ending at the Child's Park Recreation Center. The ride begins at 9:30am and is a 9-mile, family-friendly loop.

D. Pinellas Trail Targeted Enforcement Day - Saturday, April 6, 2024

The Targeted Enforcement Day along the Pinellas Trail is rescheduled for April 6, 2024, due to inclement weather forecasted for February 17, 2024. Member organizations of the Pinellas Trail Security Task Force (PTSTF) are conducting a targeted education and enforcement campaign at select locations along the Fred Marquis Pinellas Trail. Member organizations of the Pinellas Trail Security Task Force (PTSTF) are conducting a targeted education and enforcement campaign at select locations along the Fred Marquis Pinellas Trail. Police Officers from the cities of Belleair, Clearwater, Largo, St. Petersburg, and Tarpon Springs, as well as Deputies with the Pinellas County Sheriff's Office, will be on the trail and at key roadway crossings to ensure motorist and trail users are complying with traffic laws. Forward Pinellas, Pinellas County, Friends of the Pinellas Trail, and the Center for Urban Transportation Research (CUTR) will also be in Downtown Dunedin and Downtown St. Petersburg distributing safety materials and safety devices.

The Pinellas Trail is the preeminent trail facility in Pinellas County and the Tampa Bay region, spanning from St. Petersburg to Tarpon Springs. The number of users on the Pinellas Trail increased by 51% between 2019 and 2020 to over two-million annual users. While most users have a positive experience on the trail, there has been an increase in

the number of complaints regarding trail user and driver behaviors. This effort is in tandem with Pinellas County's ongoing <u>Trail Courtesy Campaign</u> which reminds people how to share our trails in a courteous and safe manner.

<u>PTSTF</u> is comprised of all law enforcement agencies and County departments with jurisdiction over the Pinellas Trail and meets quarterly to ensure safe and comfortable conditions exist on the Trail. Any issues that are brought forth are addressed through a comprehensive, coordinated approach.












