We need to create and maintain neighborhoods that are safe, walkable, and affordable to a range of incomes, while respecting the uniqueness of each place and the rights of those who live there. To do that, we need the freedom to regulate local issues locally, while working together with our Legislative Delegation to tackle larger issues.

Homes For Pinellas

Pinellas County is graced with many vibrant neighborhoods. The design of homes and buildings are integral to the character that our residents love, while reasonable local regulation ensures that everyone is treated fairly. We need to ensure that our communities can continue to reflect the needs of the people who live there.

Like virtually every community, our most critical need is for more homes that residents can afford, at all income levels. This issue extends beyond the scope of any one county, and we'll need to work with the State and other partners to find funding to meet these challenges. We need to create new housing opportunities, from transit-friendly developments on major corridors to neighborhood-scale houses that can serve two or three families while fitting into the local character.

This year, we worked with local government partners to develop the Advantage Pinellas Housing Compact, an agreement that all communities in Pinellas will be encouraged to sign, pledging to work together as a county to create greater housing affordability.

Lastly, we need to protect opportunities for prosperity for all citizens. We need to set aside enough land for high-tech manufacturing, information technology, and other industries that provide high-paying jobs, while ensuring that they're in the right places and regulated fairly. We also need to make sure that residents in every neighborhood can efficiently reach jobs and education through reliable public transit.
