- Focus on safety and transformative land use change




Concept Planning Applications

Pinellas County	Requested: \$95,000	Local Match: \$0	Downtown Palm Harbor, West Florida Ave Corridor Enhancement and Parking Project
City of St. Petersburg	Requested: \$100,000	Local Match: Up to \$50,000	31 st Street Planning Study

West Florida Avenue Corridor Enhancement and Parking Project

- 0.16-mile segment of West Florida Avenue from Alt US 19 to 8th Street
- Intended to improve connectivity between the Pinellas Trail and Pop Stansell Park
 - Existing 4' shoulder and 4' sidewalks on both sides of roadway
- Implements recommendations from the 2023 Downtown Palm Harbor Streetscape and Parking Strategic Action Plan
 - New landscaping and 60-65 parking spaces in the median
- Complements the recently adopted form-based code
- Not located within a CRA or EJ/Low-Income/Minority Census Tract

RAIN GARDEN

31st Street Planning Study

- 4.33-mile segment of 31st Street from 1st Avenue North to Pinellas Point Drive
 - Passes through the Union Central District, Grand Central District, Skyway Marina District, and South St. Pete CRA, and is adjacent to the Warehouse Arts District
- Study will improve bicycle and pedestrian facilities on and intersecting 31st Street while addressing excessive speeding within the study area
- Most of the study area is within a Minority Only EJ area

Grand Central District Curb Extensions

- Includes the intersections of Central Avenue and 21st Street, 23rd Street, and 27th Street
- Implements projects identified in the Grand Central District Master Plan to improve pedestrian safety and comfort
 - Painted curb extensions with flex posts are intended to be installed as an interim measure
 - Builds upon successful speed moderation at other intersections in the district in the past



Grand Central District Curb Extensions

- Central Avenue is located on the City's High Injury Network
- Concrete curb extensions provide the opportunity for additional sidewalk café space or landscaping
- Located within the South St. Pete CRA, Intown Activity Center, and Minority No Vehicle Access and Population Below Poverty Above Average EJ Area



Review Subcommittee Recommendations

- Five-person committee comprised of TCC and PAC members that met on November 13, 2023
- Planning Grant
 - \$100,000 for the 31st Street Planning Study
- Construction Grant
 - \$1.5M for Grand Central District Curb Extensions



Forward Pinellas Committee Recommendations

TCC

- Recommends approval of the subcommittee recommendations by unanimous vote
- CAC
 - Recommends approval of the subcommittee recommendations by a vote of 15 to 1




