## 1. CALL TO ORDER

Bill Dudley, Chair, Pinellas County School Board, called the meeting to order at 9:00 a.m. and asked attendees to introduce themselves. At this time, Chair Dudley read a statement regarding allowing committee members present to make a motion to allow those members participating by Zoom (all names identified above) to participate and vote due to extenuating circumstances existing that make it impossible for some committee members to attend in person. A motion was made by Commissioner Jeff Gow that due to Covid-19, extenuating circumstances exist that prevent members from joining in person. Therefore, they will be allowed to participate and vote by phone since a quorum is represented in person. This was seconded by Vice Chair Carol Cook and passed with a unanimous vote.

## 2. APPROVAL OF MINUTES

The deferred minutes for March 3<sup>rd</sup>, June 2<sup>nd</sup>, & October 6<sup>th</sup>, 2021, were approved with no corrections.

### 3. SCHOOLBOARD RELATED ITEMS: Motorists Passing Stopped School Buses

Mr. Joseph Camera, Pinellas County Schools, shared that there are a number of repeat offenses, especially around 4<sup>th</sup> Street and 112<sup>th</sup> Avenue N, where motorists do not stop for the school buses when the stop arm is out. Additional incidents happen on Seminole Boulevard, especially in the afternoon when motorists run right though the bus stop arm. The School District has been working with bus drivers to make sure they are doing the stops correctly with plenty of notice to motorists.

Sandra Knoebel, Forward Pinellas staff shared that the CTST and STEPS committee met recently to discuss how COVID-19 has affected school drop-offs and pick-ups and discuss options to make this process easier.

Casey Morse, Pinellas County Public Works Traffic, shared that one of the most effective ways to reach the public with educational information is through social media. It is important to spread the word about traffic safety, school bus stopping rules, the need for bus drivers and how to continue to keep children safe while getting on the bus. Social media can provide so many different outlets to get the word out. Another effective way is television during the news casts. Chuck Henson, a Bay News 9 Reporter/Anchor, is a strong advocate for Pinellas County and child safety, bike and pedestrian safety and crossing school guards' safety. Ms. Morse is seeking to get approval from the committee to reach out to and address these concerns using the different social media platforms and Bay News 9. Also available to assist the School District, the Sheriff's Office and the Police Departments are the electronic messaging boards through Pinellas County Public Works. These could be placed at different locations with selective messages.

Commissioner Eggers noted that an increase in enforcement needs to be implemented in those areas where repeated offences occur in regard to motorists running the school bus stop arm. He also inquired as to the status of the 15 mph school zone speed, if all the school zones have been equipped with the materials needed to enforce this, and if all of the school zones consistent. Ms. Morse shared that FDOT did change their school zone regulations and there are still a few more years remaining to implement the consistency requirements. FDOT has offered to supply all of the equipment, however none of the cities has seen much equipment to date. Some cities have already made the changes to the

school zones in their districts to enforce the 15 mph speed when the lights are flashing, however, to go through all the school zones in Pinellas County is quite an extensive undertaking because in the requirement documents, public, private and charter schools must also be upgraded. Public Works has the equipment, and they are currently reviewing each school. As they continue their review, they encounter other school issues and must address all the issues identified as each school is evaluated. They have a list of schools they are currently working on and a list of schools yet to be addressed.

### 4. SCHOOL ZONE ENFORCEMENT ACTIVITIES

Deputy Howard Miller, Pinellas County Sheriff's Office, was invited to speak with the committee regarding speeding in school zones. He began with sharing his statistics from the last year, 270 speeding citations were issued in a school zone on Tampa and 19<sup>th</sup> Streets alone, near Palm Harbor Middle School. Deputy Miller also monitors school bus stops. On Harn and Belcher near Oak Grove Elementary, over 116 stopped school bus tickets were issued to motorists who failed to stop for the school bus stop arm. His suggestion is to activate strobe lights in and around the school zone signs. He has witnessed people stopping for the school buses that have the strobe lights on top that flash when they are stopped. He also suggested that LED lights could be placed on the stop arm to increase visibility. Anything to catch the attention of the drivers to remind them to stop or slow down. Another suggestion was to put yellow school zone stripes on the "end of school zone" signs to help motorists to know they are at the end of the school zone.

Chelsea Favero, Forward Pinellas staff suggested inviting FDOT to come to the next meeting to talk about school zone equipment and school zone safety.

Dunedin Commissioner Jeff Gow suggested the idea of Complete Streets treatments being implemented in the school zone areas which will force drivers to slow down, making these areas more multimodal and not as car centric, in an effort to give drivers a reason to change their behavior.

Ms. Favero asked members if they were aware of the legislation just passed to allow speed enforcement cameras in school zones.

Commissioner Eggers addressed the prior media question, inquiring what is needed to move forward with getting the message out. Carol Cook, School Board member suggested getting in touch with Beth Herendeen <u>Herendeene@pcsb.org</u>. Commissioner Eggers also requested to elevate this to the Forward Pinellas Board and have a subject matter conversation with FDOT and the Board, in the near future.

### 5. BAYCARE KIDS' WELLNESS AND SAFETY CENTER

Michelle Sterling with the BayCare Wellness and Safety Center addressed the committee, sharing information about the health and well-being of children and their families. The BayCare Wellness and Safety Center has been around for 30 years educating children and schools, resource centers on injury prevention for children. Their job, out in the community, is to help keep children safe by focusing on bike and pedestrian safety. They teach children how to be safe pedestrians, how to be safe bicyclists, how to look out for themselves and to pay attention to their own safety. The Center staff go out to the schools with programs that align with the school's curriculum, with grade specific educational practices. They provide

helmets to children without helmets. They also train PE teachers to be helmet fitters. Along with bike safety, they also provide educational programs for injury prevention, the importance of being active, good nutrition and water safety. Questions were taken and appropriately answered.

### 6. OTHER BUSINESS

#### A. Hazardous Walking Conditions Update

The Hazardous Walking Conditions review is beginning in the next few months. The routes are being analyzed based on the traffic counts in March and April, stats for the number of schools and funding for buses. The state has changed the rules to determine what is considered 'hazardous,' reducing the number of areas considered to have hazardous conditions, and therefore ineligible for state funding for busing. Funds have been set aside to repair sidewalks and other hazardous conditions at the County level so improvements may be coming.

### B. <u>Pinellas SPOTlight Emphasis Areas Update</u>

Regarding the SPOTLight emphasis areas, Beach Access there is a subcommittee looking into Waterborne Transportation, meeting regularly over the last year to identify potential opportunities for additional waterborne transportation. For US 19, the Curlew Interchange will be under construction within the next several months to include a pedestrian underpass at Republic Drive and a pedestrian overpass at Northside Drive. For the Innovations in Employment and Job Access, Forward Pinellas is currently working with a consultant on a Target Employment Industrial Land study to identify the right mix of industrial vs residential land uses.
