

- \$100K for Concept Planning
- \$1M for Construction
- Leverage transportation funding to bring about transformative land use change




Complete Streets Concept Award Rendering 78th Avenue, Pinellas Park, FL

Clearwater-Largo Road Multimodal Safety Improvements Project

- Expands a programmed capital project from 4th Avenue SW to 8th Avenue SW to include Mildred Helms Elementary School
- Potential treatments include:
 - Balanced/Unbalanced lane reallocation
 - Additional marked crosswalks
 - Lane width reduction
 - Access management
- Within the West Bay Drive CRA
- Supports multiple goals and objectives of the West Bay Drive Community Redevelopment Plan





60th Street North Complete Street Concept Plan


- Project Area: 60th Street from 70th Ave N to 82nd Ave N
- Central spine to the City's "City Center District"
- Primarily within the Pinellas
 Park CRA and complimentary
 to the City Center Plan,
 funded in part by a Planning
 and Placemaking Grant
 - The district is envisioned to be the civic and recreational "living room" for Pinellas Park.





Southern Skyway Marina District Complete Streets Concept Planning Application

- Roadway modification between core of Skyway Marina District and South Planning Area
 - Connected and comfortable bicycle routes
 - Multi-modal connectivity
- Concept plan based on a 1.15-mile segment of 31st St between 46th Ave S and Pinellas Point Dr.
- Facilitate and complete public discussion and analysis for design
- Supports the goals and objectives of the Skyway
 Marina District Plan



Construction Application

City of St. Petersburg

Request: \$460,755

Local Match: \$184,302 Minimum Request: \$460,755 1st Avenue South Bikeway Improvements Project

1st Avenue South Bikeway Improvements

- The project is located on 1st Avenue South in downtown St. Petersburg where the Pinellas Trail is co-located as a two-way bikeway along the one-way street, and includes intersection improvements at 7th Street, 5th Street, and 2nd Street.
- The project would permanently install the pilot project installed at 2nd Street as part of Safe Streets Pinellas.
- Located within an Activity Center and low-Income EJ area.
- Located in the Intown CRA
- Adjacent to the SunRunner

- Comprised of members from the TCC
- Met virtually on January 18, 2023
- Reviewed and discussed all applications received




