


MPO PROPOSED APPORTIONMENT PLAN

March 2023



MPO Apportionment - Overview

- Identifies the geographic area and voting membership of an MPO
- Federal law requires that every urbanized area greater than 50,000 residents be represented by an MPO
 - Urbanized areas are designated by the Census
- Apportionment plans must be reviewed after each Decennial Census
- Apportionment plans must be approved by a majority of the Forward Pinellas Board and approved by the Governor





MPO Voting Structure

- State law requires between 5 and 25 voting members representing local elected officials, public agencies that operate/administer major transportation systems
 - Exact number determined based on population ratio and agreement among local governments
 - Other MPO voting provisions:
 - Minimum number of County Commissioners (20% of votes)
 - Rotating/shared seats permitted

Proposed Changes

- Add a 3rd seat for the City of St. Petersburg
- North County seat term lengthened to 3 years from 2
 - Oldsmar, Safety Harbor and Tarpon Springs
- Split shared Inland Communities seat to increase opportunities for local governments to serve
 - Inland North (Belleair, Belleair Bluffs and Seminole)
 - Inland South (Gulfport, South Pasadena, Kenneth City)
 - Lengthen terms to 3 years from 2 years
- Require one BCC representative to be from an at-large District

Increases membership to 15 total voting members

Considerations

- Current shared seats have 2-year terms
 - Learning curve
 - Limited opportunities to attain leadership positions
 - Solution: Divide shared seats and increase term length to 3 years
- St. Petersburg
 - Share of population increasing
- Board of County Commissioners
 - Percentage of unincorporated population decreasing but remains high
 - BCC appointees may only represent certain geographical districts – not the entire county
