**BYLAWS OF THE  
FORWARD PINELLAS  
SCHOOL TRANSPORTATION SAFETY COMMITTEE**

**SECTION 1: NAME**

The name of this committee shall be the Forward Pinellas School Transportation Safety Committee, effective March 3, 2021.

**SECTION 2: PURPOSE**

The School Transportation Safety Committee (STSC) shall serve Forward Pinellas in its role as the Pinellas County Metropolitan Planning Organization (MPO) on an advisory basis. In order to assist the STSC in carrying out its vision and mission, Forward Pinellas shall provide appropriate staff support. All official actions of the STSC must be confirmed by Forward Pinellas.

The vision and mission of the STSC are as follows:

**Vision:** To improve the safety of pedestrians, bicyclists, cars, and buses as they travel to and from Pinellas County's schools through raising awareness, sharing information, and collaboratively working with partner agencies to improve critical transportation facilities.

**Mission:** To continuously review and evaluate all modes of public-school transportation in terms of safe routes and access and make recommendations to address current or future issues or needs. The scope of the STSC's purview includes but is not limited to; school bus stop locations, bicycle routing, walking conditions, transit, and transportation programming/policies/procedures.

**SECTION 3: MEMBERSHIP, COMPOSITION, APPOINTMENT, QUALIFICATIONS, AND TERMS**

A. The STSC shall be comprised of as many as sixteen (16) voting members and non-voting technical support members confirmed by Forward Pinellas during a regular meeting.

The voting and non-voting membership is as follows:

1. As many as sixteen (16) members confirmed by Forward Pinellas for the following municipalities, agencies and citizen groups:

2. Non-voting technical support members confirmed by the Forward Pinellas Board shall include a representative from Pinellas County Schools; the Pinellas County Public Works Department; local government staff; and local law enforcement personnel. "Technical Member" is defined as a person who possesses either academic, practical, or both types of special knowledge related to the profession of traffic engineering, public works, parks operations, or other recognized technical disciplines applicable to the work of the STSC.

- B. Each voting member shall have an equal vote.
- C. If a representative's term of office expires, the local agency must appoint a new member to fill that unexpired term of service as soon as practicable.

**SECTION 4: OFFICERS AND DUTIES**

The STSC shall have two officers, the Chairperson and Vice Chairperson, who shall be voting members.

- A. Officer Elections shall take place every two years at the last regularly scheduled meeting of the calendar year. Any member may nominate a voting member to be an officer. Such nominations shall not be made without agreement of the nominee(s) to serve, if elected.
- B. All elections shall be by the majority vote of STSC members present, except write-in votes may be accepted by Forward Pinellas staff prior to the meeting at which the election will be held. The Chairperson and Vice Chairperson shall hold office until their successors are elected.
- C. The Chairperson shall:
  - 1. Preside at and conduct all meetings.
  - 2. Approve STSC correspondence and information releases.
  - 3. Serve as a liaison between the STSC and Forward Pinellas whenever the need arises.
  - 4. Cancel or postpone a regular or special meeting if circumstances warrant it and, if necessary, set a new date, time, and place for the meeting.
- D. The Chairperson may create subcommittees and task teams and appoint their chairpersons and members.
- E. The Vice Chairperson shall, during the absence or inability of the Chairperson to serve, have and exercise all the duties and powers of the Chairperson. The Vice Chairperson shall also perform such other duties as may be assigned by the Chairperson.



- F. If both the Chairperson and Vice Chairperson are absent from a meeting, a temporary Chairperson shall be provided by majority vote of the members present.
- G. Any vacancy in office created by resignation or replacement of an officer shall be filled by a majority vote of members present at the next regular meeting. The officer so elected shall fill the remainder of the unexpired term of the vacant office.

**SECTION 5: MEETINGS**

- A. The business year for the STSC will run from January through December of each calendar year. The STSC shall conduct three to four regular meetings at a date, time, and place acceptable to a majority of the membership.
- B. The Chairperson may call emergency or special meetings when deemed necessary. Emergency or special meetings may be called with a minimum of one (1) day notice, indicating the reason for the meeting. The notice for emergency or special meetings may be conducted by means of electronic communication.
- C. Forward Pinellas staff shall prepare agendas prior to all meetings. Forward Pinellas staff's goal is to distribute hard copies of the agendas, including the minutes of the previous meeting, to members approximately seven (7) days prior to any regular meeting. The members will also receive, via e-mail, a link that will allow them to view the agenda, reports, studies, or other Committee notices on the Forward Pinellas website. Members may place items on the agenda with approval of the Chairperson.
- D. An item requiring action may be brought before the STSC by any member with the Chairperson's approval, even though it is not on the agenda. The Chairperson shall decide if action is to be taken at that meeting or at a subsequent meeting.
- E. A quorum shall consist of one-fourth of the appointed voting membership and shall be required for conduct of all official business.
- F. All meetings will be open to the public. Public participation shall be allowed at the discretion of the Chairperson.

**SECTION 6: FORWARD PINELLAS CONFLICT OF INTEREST POLICY**

- A. Conflicts of Interest
  - 1. Voting Conflicts

If a member of the STSC declares a voting conflict pursuant to Section 112.3143, Florida Statutes on a matter before Forward Pinellas or its advisory committees, that member may no longer participate in that matter before Forward Pinellas and local government board that has a member of Forward Pinellas on it, or any other committee of Forward Pinellas. For the purposes of this subsection, the term "participate" means any attempt to influence the decision by oral or written

communication, whether made by the member of Forward Pinellas or its advisory committee or at the member's direction.

In the event a member has a conflict of interest, they are required to complete Form 8B – Memorandum of Voting Conflict for County, Municipal, and Other Local Public Officers and turn it into Forward Pinellas staff for insertion in the minutes of the meeting where said conflict existed, in compliance with Section 112.3143, Florida Statutes.

## 2. Lobbying Policy

Lobbying of evaluation committee members, Forward Pinellas staff, or elected officials regarding Requests for Proposals, Requests for Qualifications, bids, or contracts during the pendency of bid protest by the bidder/proposer/ protestor, or any member of the bidder's/proposer's/protestor's staff, an agent of the bidder/proposer/protestor, or any person employed by the legal entity affiliated with or representing an organization that is responding to the Requests for Proposal, Requests for Qualification, bid or contract, or has a pending bid protest is strictly prohibited either upon advertisement or on a date established by Forward Pinellas and shall be prohibited until either an award is final or the protest is finally resolved by the Forward Pinellas Board or Executive Director, provided, however, nothing herein shall prohibit a prospective bidder/proposer from contacting the Forward Pinellas staff to address situations such as clarification and/or questions related to the procurement process. For purposes of this provision, lobbying activities shall include but not be limited to influencing or attempting to influence action or non-action in connection with any Requests for Proposals, Requests for Qualifications, bid or contract through direct or indirect oral or written communication or an attempt to obtain goodwill of persons and/or entities specified in this provision. Such action may cause any Requests for Proposals, Requests for Qualifications, bid, or contract to be rejected.

## **SECTION 7: AMENDMENTS**

These Bylaws may be amended by Forward Pinellas based on a recommendation and affirmative vote of a majority of the voting members of the STSC, provided a copy of the proposed amendment(s) shall have been sent to every member at least three (3) days before it is to be voted on. All proposed amendments shall be voted on at regular meetings; however, Forward Pinellas staff may accept write-in votes prior to the meeting.

### **1. CALL TO ORDER**

Bill Dudley, Chair, Pinellas County School Board, called the meeting to order at 9:00 a.m. and asked attendees to introduce themselves. At this time, Chair Dudley read a statement regarding allowing committee members present to make a motion to allow those members participating by Zoom (all names identified above) to participate and vote due to extenuating circumstances existing that make it impossible for some committee members to attend in person. A motion was made by Commissioner Jeff Gow that due to Covid-19; extenuating circumstances exist that prevent some members from joining in person. Therefore, they will be allowed to participate and vote by phone since a quorum is represented in person. This was seconded by Councilmember Mark Bunker and passed with a unanimous vote.

### **2. PUBLIC COMMENT**

Mr. Matt Croasmun addressed the committee and shared a PowerPoint titled Bus Route 519. On August 26, 2022, Ethan Weiser died after being hit by a car while trying to cross Belleair Road in Clearwater, to get to his school bus stop. Mr. Croasmun is the uncle of Ethan Weiser, and has been advocating for change since that day, seeking to have more transportation safety measures implemented in the area of the school bus stop crossing on Belleair Road. Mr. Croasmun shared suggestions he has developed to help improve safety at that location, as well as for school bus riders countywide. Committee members shared Mr. Croasmun's sense of urgency in improving safety at this location and for all students accessing school facilities. Following discussion, the Committee requested that District, County and Forward Pinellas staff further explore Mr. Croasmun's suggestions and strengthen coordination to improve student transportation safety. Questions were taken and answered appropriately.

### **3. APPROVAL OF MINUTES**

The minutes for June 01, 2022, were approved with no corrections.

### **4. SCHOOL SAFETY COORDINATION TOOLS AND TECHNIQUES**

Ms. Chelsea Favero shared a PowerPoint presentation with the committee on School Transportation Safety Tools. School District staff, Forward Pinellas and the local jurisdictions, particularly the County, coordinate regularly on issues related to the safety of school children traveling to/from school. Much of this coordination occurs in the background

and is not immediately apparent to the governing boards and the general public. This committee was organized in the early 2000s to coordinate student safety through the Safe Routes to School program, coming together on grant applications, identifying concerns with speeding in school zones and vehicles passing stopped school buses, crossing guard concerns and safety and bus access safety in multifamily communities. One of the current tools available is the STEPS Committee, which holds monthly meetings with members from Law Enforcement Organizations (LEO's), public works, FDOT, and decision makers. Their focus is on transportation safety to and from schools. Identified issues come to the STEPS committee where they are assigned to the proper department and resolved if warranted. Other student safety tools available are the Let's Talk App available to parents with students in public schools, the Travel to School safety concern form online that goes directly to the school transportation department, as well as direct phone calls. All concerns are investigated by District Staff. All bus stops are evaluated continuously with in-person site visits. Current Challenges include the receipt of redundant transportation safety concerns, expectations outside of immediate agency control and the dynamic nature of student transportation. STSC direction should enhance a student-based education program, directly targeting students through bus safety and crosswalk education. With funding opportunities available through Forward Pinellas, as new technology and equipment become available, the district is encouraged to coordinate with staff to prioritize where improvements should go on a more proactive basis. Questions were taken and appropriately answered. A comment was made about looking into inconsistencies with school zones, such as Eisenhower Elementary and Clearwater High School.

## **5. STUDENT CRASH ANALYSIS**

Ms. Favero shared that Forward Pinellas maintains a robust Crash Data Management System, a database of all crashes that occur on the roadways in Pinellas County. This system is utilized on a near-daily basis to provide reports and statistics to local partners, while also to assist us in monitoring crash trends countywide. The crashes included in the system are each tagged with a number of attributes to help analyze and understand the crashes happening throughout the county. Recently, Forward Pinellas has been analyzing the crash data to determine if it is possible to single out crashes that have involved students traveling to/from schools, and to evaluate if there are any trends or contributing factors to these types of crashes, that could be remedied through engineering, enforcement or educational solutions. Questions were taken and appropriately answered.

## **6. COMMUNICATIONS OPPORTUNITIES**

Ms. Favero shared that in early 2022, the School Transportation Safety Committee (STSC) requested that the communications staff of the District, Forward Pinellas and Pinellas County, coordinate more closely on external communications and to also identify additional opportunities to conduct outreach. In early October, the staffs from the three agencies were able to schedule a time to meet one another, discuss shared goals, strategize outreach opportunities, and to broadly discuss how the communications work we each do can complement, and strengthen, the communications work of the others. Questions were taken and appropriately answered.

Chair Dudley thanked Matt Croasmun for sharing his presentation, the committee has a lot of direction, the stakeholders are here and listening. This topic cannot be pushed aside; we need to make progress and at the next meeting, get an update.

Councilmember Eisner inquired about a timeline for implementation. Chair Dudley shared that the committee should focus on getting this fixed by next meeting. Pinellas County, Forward Pinellas and the School District will be working together to take the suggestions into consideration and focus on a resolution. The committee has given clear direction to empower Forward Pinellas to coordinate the education and the safety of the school bus stops, so the district, county and staff will work toward getting a resolution on this issue, as well as others, well in advance of the next meeting.

The Committee adjourned at 11:00 am. The next meeting will be held on March 1, 2023.

The Hazardous Walking Conditions evaluation will begin in March-April 2023. Each hazardous walk route will be discussed and determine if it is a hazard, and this report will be updated by July 2023.
