1. CALL TO ORDER

Bill Dudley, Pinellas County School Board, called the meeting to order at 9:00 a.m. and asked attendees to introduce themselves.

2. APPROVAL OF MINUTES

Carol Cook motioned approval of the summary of the October 2, 2019 meeting, seconded by Josh Shulman and the vote passed unanimously.

3. TRENDS AND CONDITIONS REPORT

Mr. Al Bartolotta, Forward Pinellas Division Manager, shared a presentation with the committee on the Countywide Trends and Conditions Report which is produced annually. The report serves as a

resource for local governments, providing them data on roadway conditions and trends, congestion levels, crash incidents, socioeconomic conditions and population. The report also serves as part of the agency's Congestion Management Process, a systematic approach that guides the management and monitoring of the county's multimodal transportation system. The Trends and Conditions Report also provides a means of measuring various performance metrics tied to the goals, objectives and policies of the LRTP and Countywide Plan and identifies where the transportation system is functioning properly and where improvements are needed. This report will also be used to help inform Safe Streets Pinellas, Forward Pinellas' Vision Zero initiative currently underway. Questions were taken and appropriately answered.

4. SAFE STREETS PINELLAS

Ms. Sarah Caper, Forward Pinellas, shared a presentation with the committee on Safe Streets Pinellas, the Forward Pinellas Vision Zero effort. Vision Zero is a strategy that approaches transportation safety from the perspective that no one should be killed or seriously injured using our roadways. It recognizes that people make mistakes and encourages a system where those mistakes can be minimized. A basic tenet of Vision Zero is that diverse stakeholders must come together to think about and work towards creating a transportation system that is safe for everyone. Success of this effort will depend on collaboration with partner agencies countywide and community involvement. Forward Pinellas is developing both an ambassador program and task force to engage with partners in our community. The first major event as part of Safe Streets Pinellas will be the Safe Streets Summit, to be held on March 31, 2020 at the St. Petersburg College EPI Center at 13805 58th Street, Clearwater. Discussion ensued where questions were taken and appropriately answered.

5. PSTA U-PASS PROGRAM

Ms. Heather Sobush with PSTA, shared a presentation with the committee regarding the U-Pass Program and the Pinellas County School Pilot Program. The U-Pass Program allows schools and businesses to pre-negotiate payment for employees, students and staff to ride the buses based on projected ridership. PSTA recently negotiated with the beach hotels that allowed hotel visitors and staff to use key cards to ride the buses. Currently, PSTA is implementing a smart card and mobile pay system called Flamingo Fares, a partnership with HART. People can either use their phone app to pay their bus fare or use a smart card for payment. Eventually, the U-PASS will be included with the Flamingo Card program. In terms of the pilot program PSTA is working with School Board staff to provide school transportation on PSTA buses. This helps the School System deal with a shortage of bus drivers. Plans to provide school trips on PSTA buses are in negotiations as staff representatives of both agencies seek to address various school board policies. PSTA is hoping to implement the pilot service next year. Discussion followed with questions taken and appropriately answered.

6. OTHER BUSINESS

A. <u>Hazardous Walking Conditions</u>

Casey Morse, STEP Chair, shared that many of the hazardous walking areas have been addressed either by being repaired or addressed with the municipality where the hazardous condition is located. Reviews will be done beginning in the spring. School Board staff is asking municipalities to make sure they are notified of construction projects affecting student walk routes. This will allow situation involving hazardous walking conditions to be addressed ahead of time. It was recommended by Commissioner Eggers that a letter be drafted to the different municipalities and the county asking them to assign engineering and law enforcement representatives to attend the monthly STEPS meetings to share information regarding construction projects that may affect walking conditions to school. The STSC Chair agreed to draft the letter.

B. <u>Pinellas SPOTlight Emphasis Areas Update</u>

Mr. Bartolotta updated the committee on the SPOTlight Emphasis areas. With regards to US 19, FDOT is reviewing alternative intersection design concepts north of SR 580. The LRTP has always identified above grade overpasses or interchanges at the major intersections on US 19 North, but north of Tampa Road, FDOT is looking at alternatives to the overpasses. In addition, FDOT design plans for future partially controlled access improvements will be including a pedestrian overpass or underpass crossing every half mile between the major intersections. Regarding Enhancing Beach Access, staff has completed the City of Indian Rocks Beach Vision Plan for Gulf Boulevard and adjacent land uses.

C. STEPS Program

Minutes and Agendas were provided in the agenda packets.

D. Safe Routes to School

Information on upcoming events for SRTS is provided in the agenda packets.

E. Follow-up on School Related Items

Mr. Bartolotta reminded the committee about the discussion in the last meeting regarding video footage on drivers passing stopped school buses and if the drivers could be warned using the video as evidence of the offense. T. Mark Hagewood shared that the School Board sends notices to local law enforcement agencies and to the State about the offense. The local governments notify the drivers in situations where they pass stopped school buses.

F. Requests for Future Agenda Topics

No suggestions were made for future agenda topics.

G. Comments

No suggestions were made at this time.

3. School Transporation Safety Committee Bylaws



SUMMARY

On occasion, Forward Pinellas staff review the bylaws of each of its advisory committees to ensure that the language contained continues to reflect the mission of the committee and is clear to all participants. During this review, several minor changes to the bylaws of the School Transportation Safety Committee (STSC) have been identified that staff is recommending for approval. These changes are intended to clarify the voting membership of the STSC while expanding the participation of non-voting technical support members. This expansion for non-voting members will allow for any local agency staff with a vested interest in school transportation safety to fully participate in the STSC without a limit of just six (6) persons.

Forward Pinellas staff will provide a brief overview of the proposed changes and seek approval to amend the bylaws of the STSC.

BYLAWS OF THE FORWARD PINELLAS SCHOOL TRANSPORTATION SAFETY COMMITTEE

BYLAWS OF THE FORWARD PINELLAS SCHOOL TRANSPORTATION SAFETY COMMITTEE

SECTION 1: NAME

The name of this committee shall be the Forward Pinellas School Transportation Safety Committee, effective October 11, 2017.

SECTION 2: PURPOSE

The School Transportation Safety Committee (STSC) shall serve Forward Pinellas in its role as the Pinellas County Metropolitan Planning Organization (MPO) on an advisory basis. In order to assist the STSC in carrying out its vision and mission, Forward Pinellas shall provide appropriate staff support. All official actions of the STSC must be confirmed by Forward Pinellas.

The vision and mission of the STSC are as follows:

Vision: To improve the safety of pedestrians, bicyclists, cars, and buses as they travel to and from Pinellas County's schools through raising awareness, sharing information, and collaboratively working with partner agencies to improve critical transportation facilities.

Mission: To continuously review and evaluate all modes of public school transportation in terms of safe routes and access and make recommendations to address current or future issues or needs. The scope of the STSC's purview includes but is not limited to; school bus stop locations, bicycle routing, walking conditions, transit, and transportation programming/policies/procedures.

SECTION 3: MEMBERSHIP, COMPOSITION, APPOINTMENT, QUALIFICATIONS, AND TERMS

A. The STSC shall be comprised of as many as sixteen (16) voting elected officials members and six (6) non-voting technical support members confirmed by Forward Pinellas during a regular meeting.

The voting and non-voting membership is as follows:

1. As many as sixteen (16) members confirmed by Forward Pinellas for the following municipalities, agencies and citizen groups:

- 2. As many as six (6) Nnon-voting technical support members confirmed by the Forward Pinellas Board shall include a representative from Pinellas County Schools; the Pinellas County Public Works Department; local government staff; and local law enforcement personnel. "Technical Member" is defined as a person who possesses either academic, practical, or both types of special knowledge related to the profession of traffic engineering, public works, parks operations, or other recognized technical disciplines applicable to the work of the STSC.
- B. Each voting member shall have an equal vote.
- C. If a representative's term of office expires, the local <u>government agency</u> must appoint a new member to fill that unexpired term of service as soon as practicable.

SECTION 4: OFFICERS AND DUTIES

The STSC shall have two officers, the Chairperson and Vice Chairperson, who shall be voting members.

- A. Officer Elections shall take place every two years at the last regularly-scheduled meeting of the calendar year. Any member may nominate a voting member to be an officer. Such nominations shall not be made without agreement of the nominee(s) to serve, if elected.
- B. All elections shall be by the majority vote of STSC members present, except write-in votes may be accepted by Forward Pinellas staff prior to the meeting at which the election will be held. The Chairperson and Vice Chairperson shall hold office until their successors are elected.
- C. The Chairperson shall:
 - 1. Preside at and conduct all meetings.
 - 2. Approve STSC correspondence and information releases.
 - 3. Serve as a liaison between the STSC and Forward Pinellas whenever the need arises.
 - 4. Cancel or postpone a regular or special meeting if circumstances warrant it and, if necessary, set a new date, time, and place for the meeting.
- D. The Chairperson may create subcommittees and task teams and appoint their chairpersons and members.
- E. The Vice Chairperson shall, during the absence or inability of the Chairperson to serve, have and exercise all the duties and powers of the Chairperson. The Vice Chairperson shall also perform such other duties as may be assigned by the Chairperson.

- F. If both the Chairperson and Vice Chairperson are absent from a meeting, a temporary Chairperson shall be provided by majority vote of the members present.
- G. Any vacancy in office created by resignation or replacement of an officer shall be filled by a majority vote of members present at the next regular meeting. The officer so elected shall fill the remainder of the unexpired term of the vacant office.

SECTION 5: MEETINGS

- A. The business year for the STSC will run from January through December of each calendar year. The STSC shall conduct three to four regular meetings at a date, time, and place acceptable to a majority of the membership.
- B. The Chairperson may call emergency or special meetings when deemed necessary. Emergency or special meetings may be called with a minimum of one (1) day notice, indicating the reason for the meeting. The notice for emergency or special meetings may be conducted by means of electronic communication.
- C. Forward Pinellas staff shall prepare agendas prior to all meetings. Forward Pinellas staff's goal is to distribute hard copies of the agendas, including the minutes of the previous meeting, to members approximately seven (7) days prior to any regular meeting. The members will also receive, via e-mail, a link that will allow them to view the agenda, reports, studies, or other Committee notices on the Forward Pinellas website. Members may place items on the agenda with approval of the Chairperson.
- D. An item requiring action may be brought before the STSC by any member with the Chairperson's approval, even though it is not on the agenda. The Chairperson shall decide if action is to be taken at that meeting or at a subsequent meeting.
- E. A quorum shall consist of one-fourth of the appointed voting membership and shall be required for conduct of all official business.
- F. All meetings will be open to the public. Public participation shall be allowed at the discretion of the Chairperson.

SECTION 6: FORWARD PINELLAS CONFLICT OF INTEREST POLICY

A. Conflicts of Interest

Voting Conflicts

If a member of the STSC declares a voting conflict pursuant to Section 112.3143, Florida Statutes on a matter before Forward Pinellas or its advisory committees, that member may no longer participate in that matter before Forward Pinellas and local government board that has a member of Forward Pinellas on it, or any other committee of Forward Pinellas. For the purposes of this subsection, the term "participate" means any attempt to influence the decision by oral or written communication, whether made by the member of Forward Pinellas or its advisory committee or at the member's direction.

In the event a member has a conflict of interest, they are required to complete Form 8B – Memorandum of Voting Conflict for County, Municipal, and Other Local Public Officers and turn it into Forward Pinellas staff for insertion in the minutes of the meeting where said conflict existed, in compliance with Section 112.3143, Florida Statutes.

2. Lobbying Policy

Lobbying of evaluation committee members, Forward Pinellas staff, or elected officials regarding Requests for Proposals, Requests for Qualifications, bids, or contracts during the pendency of bid protest by the bidder/proposer/ protestor, or any member of the bidder's/proposer's/protestor's staff, an agent of the bidder/proposer/protestor, or any person employed by the legal entity affiliated with or representing an organization that is responding to the Requests for Proposal, Requests for Qualification, bid or contract, or has a pending bid protest is strictly prohibited either upon advertisement or on a date established by Forward Pinellas and shall be prohibited until either an award is final or the protest is finally resolved by the Forward Pinellas Board or Executive Director, provided, however, nothing herein shall prohibit a prospective bidder/proposer from contacting the Forward Pinellas staff to address situations such as clarification and/or questions related to the procurement process. For purposes of this provision, lobbying activities shall include but not be limited to influencing or attempting to influence action or non-action in connection with any Requests for Proposals, Requests for Qualifications, bid or contract through direct or indirect oral or written communication or an attempt to obtain goodwill of persons and/or entities specified in this provision. Such action may cause any Requests for Proposals, Requests for Qualifications, bid, or contract to be rejected.

SECTION 7: AMENDMENTS

These Bylaws may be amended by Forward Pinellas based on a recommendation and affirmative vote of a majority of the voting members of the STSC, provided a copy of the proposed amendment(s) shall have been sent to every member at least three (3) days before it is to be voted on. All proposed amendments shall be voted on at regular meetings; however, Forward Pinellas staff may accept write-in votes prior to the meeting.

4. School Board Related Items



SUMMARY

A. Motorists Passing Stopped School Buses

In 2019, the committee addressed the problem of motorists passing buses that have stopped to pick up or drop off students. School Transportation staff will provide an update on this issue at the meeting.

B. Health and Safety Protections Implemented in Response to COVID-19

Pinellas County Schools have taken extensive measures to reduce the exposure of its students, faculty and staff to COVID-19. This item is intended to provide an opportunity for a School Board representative to speak to the committee about these measures and related issues.

C. Hazardous Walking Conditions Update

Rule 6A-3.0171, Florida Administration Code (F.A.C.), requires local school districts to ensure that County and City officials are advised of hazards involving students walking to and from school. Through its Hazardous Walk Review Team, School Transportation staff surveys and inspects the surrounding areas of the county's public schools and produces an annual report on walking conditions.

Students residing within two miles of their assigned schools are required to walk there unless a hazardous condition on their route is identified. In such cases the affected students must be provided with a bus to school.

School Transportation staff will update the committee on activities related to the hazardous walk review.

5. Rectangular Rapid Flashing Beacons (RRFBs)



SUMMARY

Rectangular Rapid Flashing Beacons (RRFBs) are pedestrian activated traffic control devices typically installed at mid-block crosswalk locations that help people safely cross the street. Florida Law requires motorists to stop for a pedestrian who enters a crosswalk. An RRFB helps to protect the pedestrian using a crosswalk by alerting oncoming motorists of their presence with flashing lights.

There are currently over 400 RRFBs in Pinellas County, with many directly around public school facilities used by students on their way to and from school.

The RRFBs have proven to be highly effective in Pinellas County and around the country. A 2016 Texas A&M Transportation Institute (TTI) RRFB study showed a motorist yielding rate as high as 98% under certain roadway design conditions. The rate of motorists yielding for pedestrians at mid-block crossings in the City of St. Petersburg increased from 2% to 90% over a three-year period after the RRFBs were installed.

Despite the proven effectiveness of the RRFBs, Senate Bill 1412 by Representative Perry and House Bill 1113 by Representative Fine were filed during the recent 2021 Florida Legislative Session. The proposed bills would effectively invalidate the existing design for RRFBs and result in removal of many existing RRFBs due to the inability of government entities to finance required retrofits. The removal of the RRFBs would result in pedestrian crosswalks without the enhancement of flashing lights and additional signage which provides vital signals to motorists of the presence of a pedestrian and their intent to cross the road. Albeit Florida law requires motorists to yield to pedestrians when they are using a crosswalk, empirical and quantitative data has demonstrated low compliance rates in mid-block and pedestrian crosswalks from motorists without the augmentation of additional enhancements such as RRFBs. Forward Pinellas is collaborating with other MPOs in the state, local governments, and other organizations on joint opposition regarding these bills.

Forward Pinellas staff will provide an overview of RRFBs and previous legislative efforts to remove them.










January Trail Users by Counter Location








Monthly Trail Counts 2017 - 2020

7. Safe Streets Pinellas



SUMMARY

Safe Streets Pinellas is the Forward Pinellas Vision Zero effort. Over the past year, efforts to develop a Safe Streets Action Plan have been underway. The Action Plan includes collision data analysis, the identification of a High Injury Network (HIN), engineering and non-engineering countermeasures and implementable strategies to move towards zero deaths and serious injuries on the Pinellas roadway network. A 16-member task force with a representative from each Forward Pinellas committee assisted in the development of the Action Plan. A public outreach campaign was conducted in Summer 2020 and all Forward Pinellas committee members were invited to learn more and provide input at a December 2nd workshop.

Forward Pinellas staff will present key information from the Safe Streets Pinellas Action Plan and early implementation steps. The Action Plan will be updated once all the demonstration projects are completed and is intended to be evaluated on a regular basis so adjustments can be made as needed.


SUMMARY

Through active citizen engagement and educational outreach, the Move Safe, Pinellas program is targeting behavior changes and working to influence good habits in bicyclist and pedestrian safety. A program developed by Pinellas County Public Works, messages are being communicated in a number of ways, including through the Move Safe, Pinellas educational activity book. The activity book tells a story of what kids should know before heading out to bike or walk to school, a friend's house or around the neighborhood. It includes checklists, a variety of challenging and fun games and activities, and on the final pages - allows kids to test their skills to see all that they learned throughout the book. The activity book is accompanied by the Move Safe bookmark/ruler that also features informative safety messaging directed toward kids.

Pinellas County staff will provide an overview of the Move Safe, Pinellas program and highlight the tools being used to communicate safety messages to kids in the community.

SUMMARY

The Pinellas Suncoast Transit Authority (PSTA) coordinates with Pinellas County Schools on a number of programs that facilitate better access to schools for both students and employees. 






Number of Crashes by Day of Week




Crashes by Time of Day



Portland Metro Ballot Measure Would Boost Active Transportation and Transit

We have been working with the Getting There Together coalition for the past two years to push for a transportation ballot measure in Portland that prioritizes walking, biking, transit, and safety in the communities most in need. The Metro Council has just approved referring the Get Moving 2020 regional transportation investment measure to the voters, who will decide in November 2020 whether to proceed. If approved, it would invest \$7 billion over the next 20 years in the greater Portland region, including funding Safe Routes to School at \$4.5 million per year, free youth transit passes, and significant investments in safety, transit, and active transportation.

Unfortunately, the gains for active transportation and safety for people walking and biking that we won in the House and Senate transportation bills are at risk. Congress has not been able to get a final bill over the finish line, and with less than a month till the FAST Act expires, an extension of current law is most likely. Call for Communities to Participate in Routes of Health: A Community-Based Legal & Policy Framework for Prioritizing Health in Traffic Routing Systems Drivers are using navigation apps (Waze, Google Maps, etc.) because they are looking for a logical way to avoid sitting in traffic, but the result is a shift in the usage of our streets. In many communities, altered traffic patterns are undermining active transportation progress in neighborhoods and near schools, parks, senior centers, community centers, and other community hubs.

The Safe Routes Partnership is looking to work with five communities across the country to understand the effects that navigation apps are having on walkability, bikeability, and overall livability. Learnings from the five communities and parallel data and policy analyses will be compiled in a framework and report with recommendations for the local communities and other communities around the country to use in addressing these challenges.


Fact Sheet: Influencing Complete Streets at the Regional Level
