1. CALL TO ORDER

TCC Chair, Joan Rice called the meeting to order at 2:00 p.m. and asked everyone to introduce themselves. At this time, Chair Rice read a statement regarding committee members present voting to allow those members participating by Zoom (all names identified above) to participate and vote due to existing extenuating circumstances that make it impossible for some committee members to attend in person. A motion was made by Barry Westmark that due to Covid-19, extenuating circumstances exist that prevent some members from attending in person. Therefore, virtual attendees will be allowed to participate and vote by phone since a quorum is present in person. This was seconded by Cheryl Stacks and passed with a unanimous vote.

2. APPROVAL OF SUMMARY

The summary of the March 23, 2022, meeting was approved with no corrections.

3. FY 2019/20 – FY 2023/24 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENT

There were no proposed TIP amendments.

4. ANNUAL ADOPTION OF TRANSPORTATION PRIORITY LISTS

Ms. Chelsea Favero, Forward Pinellas Staff, shared a presentation on the Draft 2022 Priority List. Forward Pinellas adopts the project priority lists for the Transportation Improvement Program (TIP) on an annual basis. These lists are used for the allocation of federal funding and once approved, are used by the Florida Department of Transportation (FDOT) in the development of its Five-Year-Work-Program. When a project appears on the priority list, it stays on the list until it is completed. Each list was presented separately and is summarized as follows:

1) Multimodal Priority List is the most expansive list which includes roadway, transit, bicycle and pedestrian projects. It is the broadest in terms of the types of funding these projects are eligible for. The top part of the list consists of funded projects, and the bottom are unfunded projects. A new column has been added to the list, the Source of the Project, to show where the projects came from. If a project appears shaded, there was a change to the project's status from the last update, such as the project has been completed or advanced due to funding received or is currently underway. Projects were reviewed and questions were taken and appropriately answered. There is no action today for this item, it will return next month for action.

2) Transportation Alternatives (TA) Program Priority List is for specific projects such as trails, sidewalks and access to trail improvements. Like the Multimodal Priority list, shaded projects indicate a change to the project since the last list was presented. Two projects have come off the list as they have been completed, the Oldsmar Trail Phase 6 extension and the Phase 1 (North Gap) Pinellas Trail crossing at Sunset Point Road. Five projects have been moved to the funded list from the unfunded list. There are four new projects added to the unfunded list. Projects were reviewed and questions were taken and appropriately answered.

3) Regional Transportation Priorities List: at the regional level, the Sun Coast Transportation Planning Alliance (SCTPA), consists of all the MPO's to include Hernando/Citrus, Sarasota/Manatee, Polk, Hillsborough, Pinellas County and Pasco counties. The focus of the SCTPA is to come together to develop one set of regional

priority projects, then work as a region to advocate for project funding at both the state and federal level. The Tampa Bay Transportation Management Area (TMA) is made up of three counties, Hillsborough, Pasco and Pinellas, whose major focus is on the transportation issues of the urbanized forum. The TMA has developed a list of priorities for the urban core, which is sent up to the broader region (SCTPA), to add their priorities and bring the lists together. Projects were reviewed and questions were taken and appropriately answered.

5. FINAL UNIFIED PLANNING WORK PROGRAM

Ms. Favero shared a presentation on the final draft of the Unified Work Program. The Unified Planning Work Program (UPWP) is a two-year plan that identifies a metropolitan planning organization's (MPO) transportation planning activities and associated funding. State and federal transportation funding agencies provide guidance on required elements and timeframes for review and adoption of the UPWP, but the way the MPO allocates its funding for the various planning activities is at the discretion of the MPO. The review of the draft UPWP for July 1, 2022 – June 30, 2024, was presented to the TCC in February 2022, sharing the MPO's functions and planning priorities. In early April, Forward Pinellas received comments back from the state and federal agencies on that draft and have integrated those comments into the final UPWP. Ms. Favero reviewed the task pages and budget information that details staff support activities, consultant work and associated grant funding. Questions were taken and appropriately answered. A motion was made by Cheryl Stacks to approve the FY2022-23 – 2023/24 UPWP. This was seconded by Caroline Lanford and passed with a unanimous vote.

6. SUNRUNNER RISING DEVELOPMENT STUDY UPDATE

Rodney Chatman, Forward Pinellas staff, shared a presentation on the SunRunner Rising Development Study. In working with local partners from Pinellas Suncoast Transit Authority (PSTA), City of St. Petersburg and City of South Pasadena, this study is a federally funded project through the Federal Transit Administration's (FTA)'s Transit-Oriented Development Pilot Program. The goal of this pilot program is to integrate land use and transportation planning through new transit capital investment and complementary redevelopment policy. Studies funded through the program must examine ways to improve economic development and ridership, foster multimodal connectivity and accessibility, improve transit access for pedestrians and bicyclists, engage the private sector, identify infrastructure needs, and enable mixed-use development near transit stations. SunRunner "Beach to 'Burg" is a Bus Rapid Transit (BRT) project, a fixed route of 26 stations running east/west from St. Pete Beach, through South Pasadena, into downtown St. Petersburg, with built in infrastructure and stations. It involves a streamlined construction timeline and lower implementation cost compared to rail. It enhances mobility for employees, students and visitor and creates more predictable travel patterns. The project approach was in four phases: 1) existing conditions and best practice review, holding many listening sessions; 2) Redevelopment Vision, identifying challenges to development and how development can be supported and virtual community workshops; 3) Station TOD Framework Plans with station area stakeholder meetings discussing redevelopment, infrastructure and partnership strategies in each station area; and 4) Implementation Plan discussing regulatory recommendations and funding strategies. Stakeholder feedback discussions showed that people were focused on ensuring that the development that would occur on the route was pedestrian oriented to make it a multimodal environment with active public spaces and esthetically pleasing store fronts

while making sure everyone can benefit from the redevelopment opportunity. Also taken into consideration with a deeper dive into the corridor, what existing physical characteristics are along the corridor. It was determined to be four place types, Downtown, Urban, Village and Neighborhood, based on the intensity and density of the place. TOD readiness was taken into consideration using GIS analysis as well as existing conditions such as market force, surface parking, supportive zoning, building age and land to building value. Next steps include South Pasadena evaluation and appraisal review, and how the SunRunner recommendations will influence the Investment Corridor Transition Plan, Tropicana Field Redevelopment Plan, Forward Pinellas TEILS Study and 22nd Street Corridor Study. Questions were taken and appropriately answered.

7. PUBLIC OUTREACH QUARTERLY COMMUNICATIONS

Ms. Amy Elmore, Forward Pinellas Communications and Outreach Manager, shared a presentation/quarterly report on the public outreach completed by Forward Pinellas. Ms. Elmore provided the committee with a comprehensive view of the communications and outreach initiatives and the way in which the agency engages and serves the community as well as how outreach can be accelerated in the future. Since January, Forward Pinellas has reached 121,000 people on social media channels. The agency has been featured in more than 32 news stories and has begun monthly e-newsletters and created 15 different campaigns. Forward Pinellas has worked with many local, regional and state partners on different events including Bike Your City, St. Petersburg and Clearwater Police Department School Crossing Guard Day, Pinellas County Job Fair and City of Dunedin Trail Safety Day, to name a few. Educational Outreach is very important to Forward Pinellas, and staff has participated in Pinellas School In-Service Day sharing presentations on the City by Design curriculum to teachers. The City by Design curriculum was developed and designed by a Forward Pinellas Intern, Austin Britt. We also created a Bike Safety Teacher Toolkit, that allowed over 500 kids to celebrate Florida Bike month. Questions were taken and appropriately answered.

8. MULTIMODAL IMPACT FEE ORDINANCE DISCUSSION

Scott Swearingen, Pinellas County Planning, began the discussion noting that the Multimodal Impact Fee Ordinance is due for review. Planning is preparing to move forward in the short term to allow for a fee waiver for affordable housing developments, which was presented at the Board of County Commissioners work session, receiving good feedback. In the long term, a larger more strategic ordinance update, that would include a reassessment and a reevaluation of the fees that are in the ordinance, will be undertaken. Since this could be a costly effort, and is not currently in the FY 2023 Planning budget, discussions need to continue with County Administration to help them understand the importance of what it would entail. Members comments, ideas and thoughts would be greatly appreciated as Planning looks to scope this project out. Mr. Chatman shared that Forward Pinellas sat down with the County Administrator recently and the impact fee ordinance was part of the conversation and shared that Forward Pinellas had the ability provide some supplemental funding. If the local partners want to see this happen, then the local partners' ability to bring some dollars to the table would be a huge factor in getting the County Administration on board with moving forward with the project. Questions were taken and appropriately answered.

9. INFORMATIONAL ITEMS

A. SPOTlight Emphasis Areas update.

For U.S. 19, construction will begin this year on US19, north of SR 580 and will include the Curlew interchange. TBARTA is currently leading a study on the feasibility on Rapid Transit within the corridor from the Gateway Area to Pasco County along US19. The next meeting of the Gateway Partnership is on June 3, 2022. Staff is currently researching Transportation Management Organizations to see how one could look in the Gateway area. Staff is also working with St. Petersburg and Pinellas Park to identify some gaps that the Chambers are not currently filling in the area to come up with a framework of what a TMO could look like. With regards to the Beaches, a presentation on the SunRunner update was given and the amendments to the LRTP with Waterborne Transportation were finalized.

4. Adoption of the FY 2022/23 – FY 2026/27 Transportation Improvement Program (TIP)



SUMMARY

Forward Pinellas is required to adopt a fiscal year (FY) 2022/23 – FY 2026/27 Transportation Improvement Program (TIP) by July 1, 2022 for the county to receive state and federal funding for transportation projects. The TIP contains project descriptions, schedules, and corresponding funding allocations regarding scheduled transportation improvement projects for the 25 local governments of Pinellas County, the Pinellas Suncoast Transit Authority (PSTA), local airports, and the Port of St. Petersburg. The projects include new construction, reconstruction, capital purchases, and maintenance work associated with roads, sidewalks, trails, transit services, airports, the Port of St. Petersburg, and the Transportation Disadvantaged Program. Projects included in the TIP for state and federal funding must be in the adopted Long-Range Transportation Plan.

The annual TIP adoption process involves incorporating the attached Florida Department of Transportation (FDOT) FY 2022/23 – FY 2026/27 Final Tentative Work Program into the TIP. The FDOT Work Program includes a five-year schedule of state and federally funded transportation projects, including new projects introduced in the fifth year (2026/2027). At its January 12, 2022 meeting, the Forward Pinellas Board approved the draft version of this document.

Please note that the tables included summarize projects included in FDOT's 2022/23-2026/27 Work Program. Shaded projects have been modified from last year's tables. This could include a change in limits, improvement type, a change to the project timeline, or the addition of a new project. The link provided below provides a map of all projects in the FDOT Work Program. Forward Pinellas staff will present highlights of the projects included in the Work Program and request a recommendation from the committee on adoption of the TIP.

SUMMARY

Forward Pinellas adopts project priority lists for its Transportation Improvement Program (TIP) on an annual basis. These lists are used for the allocation of federal funding. These lists include Multimodal Transportation Priority, Transportation Alternatives (TA) Program Projects, and Regional Transportation Priority Projects. The approved priority lists are used by the Florida Department of Transportation (FDOT) in the development of its Five-Year Work Program. A description of these lists and proposed changes to each are provided in the discussions that follow.

A. Multimodal Priority List

Since the last update of this list in 2021, four projects were allocated funding for implementation and are being moved from the 'Unfunded' section of the list and one funded project has been completed and is being removed from the list. Staff is also proposing to add several projects, including one complete streets construction project, two projects from the Active Transportation Plan and two projects that applied for funding through the Multimodal Priority List Call for Projects. Several project descriptions of existing priorities are also being updated. Projects shaded in gray on the table indicate a change to the status or details of the project have been made. The relative ranking of some priorities has been adjusted to account for the needs of each project. Projects struck through are proposed to be removed. Staff has also added a column to note the source of each project on the list, highlighted how the project relates to agency planning activities. Forward Pinellas staff will provide an overview of proposed changes to the list.

B. Transportation Alternatives (TA) Program Priority List

Since the last update to this list in 2021, six projects were allocated full funding, with five being moved from the 'unfunded' portion of the list to the 'programmed' portion. Staff is proposing to add four new projects for which applications were received during the Call for Projects issued in 2021. These project applications were evaluated and scored using a set of criteria approved by the Forward Pinellas Board. These projects are proposed to be added to the TA priority list according to the number of points they each received. These projects are being added to the bottom of the list, not to supersede the projects already on the list. Forward Pinellas will provide an overview of the proposed changes to the list.

C. Regional Transportation Priorities

On December 10, 2021, the Sun Coast Transportation Planning Alliance held a meeting to discuss their Regional Transportation Priority Projects list.

First, the Tampa Bay Transportation Management Area (TMA) Leadership Group met to discuss their top priorities for transportation projects in the Tampa Bay area. A subcommittee of the SCTPA, the TMA Leadership Group includes representatives from the Pinellas, Hillsborough and Pasco County MPO boards, and considers transportation priorities important to the urban core of the region. The TMA Leadership Group establishes those priorities for the three county area, and then forward those priorities to the broader SCTPA board for inclusion in the regional priority list.

The SCTPA is made up of elected officials from each of the MPOs within its eight-county region, including Hernando, Citrus, Hillsborough, Pasco, Polk, Sarasota, Manatee and Pinellas. The SCTPA membership also includes representatives of the areas regional planning councils, FDOT Districts 1 and 7 and the Florida Turnpike Enterprise. The SCTPA met immediately after the TMA Leadership Group and took action to fully incorporate the TMA priorities, as well as adding in the regional priorities of the other MPOs in the region.

In accordance with the processes established through the SCTPA, the regional priority lists are formally endorsed by the governing body of each member MPO.

SUMMARY

As one of Florida’s most unique and vibrant communities, demand for office, housing and services in downtown St. Petersburg, or DTSP, continues to grow. At the same time, people are looking for more ways to travel in and around the community in a safe and efficient manner. To ensure inclusive economic growth and to sustain downtown’s mix of uses, it’s critical to understand the ways in which the transportation network can help meet the area’s needs for improved access, connectivity, and mobility.

Forward Pinellas, the City of St. Petersburg, and the Florida Department of Transportation (FDOT) worked together on an analysis of the Downtown St. Petersburg transportation network as part of the Downtown St. Petersburg (DTSP) Mobility Study. The purpose of the mobility study is to understand the context and vision for multimodal mobility in DTSP, conduct conceptual planning and evaluation of multimodal improvement options, and prioritize short- and long-term projects. The study is focusing on defining and evaluating improvement projects that affect the overall network in DTSP, including potential projects that affect roadway capacity, operations, safety, and connectivity for pedestrians, bicyclists, transit users, and drivers. The intent of the study is to identify and evaluate project concepts and improvements to the network including two-way street conversions, redesign of the interstate spurs, transit, bicycle and pedestrian infrastructure improvements, and other safety and mobility enhancements. The study officially launched in early 2020 and is scheduled to conclude in early 2022.

During this update, Forward Pinellas staff will provide an overview of the study process and key project concepts that were identified for consideration as well as next steps.

Recent crash data trends in Pinellas County are unacceptable. Every day in 2021, 3 people were either killed or seriously injured on our roadways, most of them on bicycles or walking. As the engineering and planning professionals representing the local communities of Pinellas County, the Technical Coordinating Committee (TCC) has the important role of providing technical advice to Forward Pinellas on matters related to our transportation system. In this role, we are writing this memo to request that Forward Pinellas do more to improve the safety of our transportation network.

Forward Pinellas has already taken significant steps in the process to improve safety and should be commended for that. The Transportation Project Priority List has included bicycle, pedestrian and transit projects since 2016, prior to which only roadway capacity projects were submitted to the Florida Department of Transportation. Forward Pinellas has invested significant resources in the development of the Safe Streets Pinellas program, funding demonstration projects and encouraging all of your partners to work together to advance more projects focused on safety. The agency has demonstrated a commitment to provide more resources for local government partners to advance safety projects through the allocation of resources in the next two-year budget. The Complete Streets grants have been a significant benefit in help us advance safety improvements in our own communities. In addition, the agency has adopted a target to reduce fatalities on our transportation network by 20% in the next two years.

Yet despite all of this, the fatalities and serious injuries continue to add up. Only 7 of the 25 local governments have signed the Safe Streets Pinellas resolution. At the TCC, we receive regular updates on projects that were intended to improve safety but were then scaled back or stopped outright because they had the potential to slow drivers down. As technical professionals, we have no intention of asking people to stop driving and we recognize that some roadways should be built and maintained to move vehicles as efficiently as possible. However, the transportation network should be balanced and safe for everyone. Some roadways should have slower vehicle speeds and they need to be re-engineered to accomplish that.

Considering this, we request that the Forward Pinellas Board not just continue the work it has been doing, but to do more. We request the following:

1. Forward Pinellas develop a program for local governments to receive funding for dedicated safety projects in their communities.
2. Forward Pinellas provide planning support to local governments to identify safety projects in their communities that the local governments can then implement.
3. Forward Pinellas prioritize the safety of the most vulnerable roadway users when reviewing and approving transportation projects.
4. Anything else?

Safety improvements should not just be a promise on paper. Funding for projects that improve safety must be prioritized and our elected officials must take action to support projects that improve mobility and safety for everyone, not just those trying to drive to their destinations as fast as they possibly can.

THE PLANNING COUNCIL AND METROPOLITAN PLANNING ORGANIZATION FOR PINELLAS COUNTY

The Forward Pinellas Board held this public meeting in person on May 11, 2022, at 1 p.m. in the Palm Room at the Pinellas County Communications Building.

The board unanimously approved the FY 23-24 Unified Planning Work Program

The board unanimously approved the FY 2022/23-2023/34 Unified Planning Work Program (UPWP), a two-year budget plan that identifies a metropolitan planning organization's (MPO) transportation planning activities and associated funding. State and federal transportation funding agencies provide guidance on the required elements and timeframes for review and adoption of the UPWP, but the way the MPO allocates its funding for the various planning activities is at the discretion of the MPO.

- Commissioner Eggers confirmed with staff that the item in the UPWP regarding waterborne transportation included the oversight of the newly adopted phased implementation plan, as well as working with local and regional partners to secure funding and seek grants for services.
- Commissioner Long requested the Waterborne Committee research the viability of electric-powered vessels for future waterborne transportation services, and the executive director confirmed that could be included in the work activities.

The board unanimously accepted the SunRunner Rising Development Study

The board unanimously accepted the final recommendations from the "SunRunner Rising" Development Study, which outlined actions to create redevelopment along the [SunRunner Corridor](#) that is transit-supportive, vibrant, safe, and accessible for everyone along the new bus rapid transit line serving St. Petersburg, South Pasadena, and St. Pete Beach. These recommendations reflect the community's ideas and feedback received through various listening sessions and forums. One common theme from the stakeholders was to ensure that an interconnected network is created within the SunRunner corridor to allow people to easily get to work, restaurants, shopping, and recreation.

Highlights from the recommendations of the SunRunner Rising Study include:

- Create transit-supportive redevelopment opportunities within the station areas to promote ridership
- Create wayfinding to SunRunner stops
- Increase bike and pedestrian connections from adjacent neighborhoods
- Promote housing affordability through density bonuses and height increases
- Increase public-private partnerships, especially to address rent stabilization
- Foster workforce development partnerships by increasing educational opportunities

- Commissioner Merz clarified with PSTA staff that the downtown area included a minimum of two stories within the downtown station areas and a max of eight stories within the village and station areas. These recommendations are merely strategies and the local community will be able to tailor these to their unique needs.
- Commissioner Eggers also clarified that any zoning changes will include local community input.
- Councilmember Gabbard noted that the next steps are for municipal staff to identify zoning classifications for each station and bring these back to their respective boards for consideration and adoption.
- Councilmember Driscoll acknowledged that staff has set up this project with a well-rounded approach that enhances the quality of life and economic development. She expressed praise for the work performed by the project staff and consultants.
- Mr. Blanton noted that these recommendations serve as a useful guide for other areas in the county, including the Alt. 19 corridor. In the coming months, we will begin work on the Alt. 19 Corridor Transition Plan, which will develop a framework to use high-quality transit to better connect jobs, job training opportunities, and housing.

The board approved three amendments to the Countywide Plan Map

- The board recommended approval of three amendments:
 - An amendment from the City of Largo to amend the property at 1199 East Bay Drive from Retail & Services to Public/Semi-Public to allow for the expansion of an existing religious institution.
 - An amendment from the City of Largo to amend the property at 350 Seminole Blvd. from Residential Low Medium, Residential Medium, Retail & Services, and Activity Center to Recreation/Open Space and Activity Center to allow for the expansion of the existing Bayhead Park.
 - An amendment from the City of Largo to amend the property at 10050 Ulmerton Road to bring an existing non-conforming restaurant use into compliance.

Alex Burns, USF Intern, presented on the Pinellas Trail Speed Study

The board heard a presentation from Alex Burns, University of South Florida Intern, on the Pinellas Trail Speed Study. With the rise in popularity and new technologies like electric bicycles, concern about users speeding on the Pinellas Trail has increased. The Forward Pinellas team heard this concern and partnered with Pinellas County Public Works to determine if people are speeding on the trail. Forward Pinellas staff analyzed data from the permanent trail counters to gain a better understanding of speed conditions on the trail and supplemented this data with in-person outreach where staff measured the speed of trail users with radar guns during peak use hours at four of the busiest trail counters. Overall, nearly all of the trail users followed the posted 20 mph speed limit. In order to address the perception of speeding on the trail, Forward Pinellas has committed to working with our partners to evaluate the adherence to the current speed limit along the trail and to increase community awareness and

education of trail issues and proper trail usage. For more information, visit:

- Mayor Buljalski requested staff look at options for a physical separation of pedestrians and bicyclists.
- Commissioner Eggers requested staff look at speed reduction measures (signage and/or education) within high usage areas, especially throughout downtown Dunedin.
- Mr. Blanton noted that the next steps include continual partnership and discussions with Pinellas County and other local governments.

Chelsea Favero presented the Draft Transportation Priorities

Forward Pinellas adopts project priority lists for its Transportation Improvement Program (TIP) annually to ensure that the county is eligible to receive state and federal funding for transportation projects. These lists include Multimodal Transportation Priority, Transportation Alternatives (TA) Program projects, and Regional Transportation Priority projects. The approved priority lists are used by the Florida Department of Transportation (FDOT) in the development of its Five Year Work Program. Final lists will be brought back to the board for action in June.

- Mayor Buljalski clarified with staff that the Skinner Blvd Complete Streets project has been moved to FY24.
- Commissioner Eggers would like to see the Duke Energy Trail overpass across SR580 move to a higher priority. He also clarified with Mr. Blanton that other trail bridge crossings on the priority list include overpasses at Roosevelt, SR 60, and Gandy Blvd.

SPOTlight Updates

- Mr. Blanton wrote a letter to the Florida Division of State Parks to request funding for design and construction for the Honeymoon Island State Park roundabout at the park's entrance.
- The next Gateway Partnership meeting on June 3 will discuss further implementation steps and possible projects that could be funded under the FDOT Commute Options Funding Program.

Other Items

- Public Comment:
 - Mr. Todd Pressman requested the board hear a future presentation on an adjustment to a pedestrian crossing on US 19 near Republic Drive associated with a programmed construction project. Mr. Blanton and FDOT District 7 Secretary Gwynn advised that any new design proposals would need to go through all advisory committees and FDOT before coming back to the Forward Pinellas Board and could result in additional costs and delays as the US 19 design is complete. The board voted, four to seven, to deny this request.

- PSTA has increased eligibility opportunities for Transportation Disadvantaged residents. In addition, the City of Dunedin hosted a block party to announce the new Autonomous Vehicle Advantage (AVA) shuttle.
- TBARTA is leading a Regional Rapid Transit project connecting Pasco and Pinellas along US 19, and an executive team meeting is planned this month to refine the number and location of proposed stations along the corridor.
- The MPOAC recently voted to approve statewide freight project priorities.
- Through the Bipartisan Infrastructure Law, the Notice of Funding Opportunity for the Safe Streets For All program has been issued. Forward Pinellas staff will also learn more about the Reconnecting Communities Grant program for possible future grant opportunities including the Downtown St. Pete Mobility Study.
- With the completion of the Pinellas Planning Council audit, Forward Pinellas staff is reevaluating options for the FY23 budget to ensure that projected revenues cover the agency's expenses. The final audit showed a significantly lower carryover balance from the prior fiscal year, and even with a higher property valuation, this results in an operating deficit for FY23. Staff updated the board on some of the scenarios Forward Pinellas is considering as it develops the final budget for board approval in June.
 - Overall, the board showed support for additional funding options and noted the cut in millage rate that occurred in the past was not intended to be permanent.
 - Commissioner Merz agreed that reserve funds should not be cut and he requested that staff explore options to lower the cost of Intergovernmental Service Charges.
 - The board also expressed strong support for salary adjustments for agency staff in light of inflation costs to help retain and recruit high-performing employees.

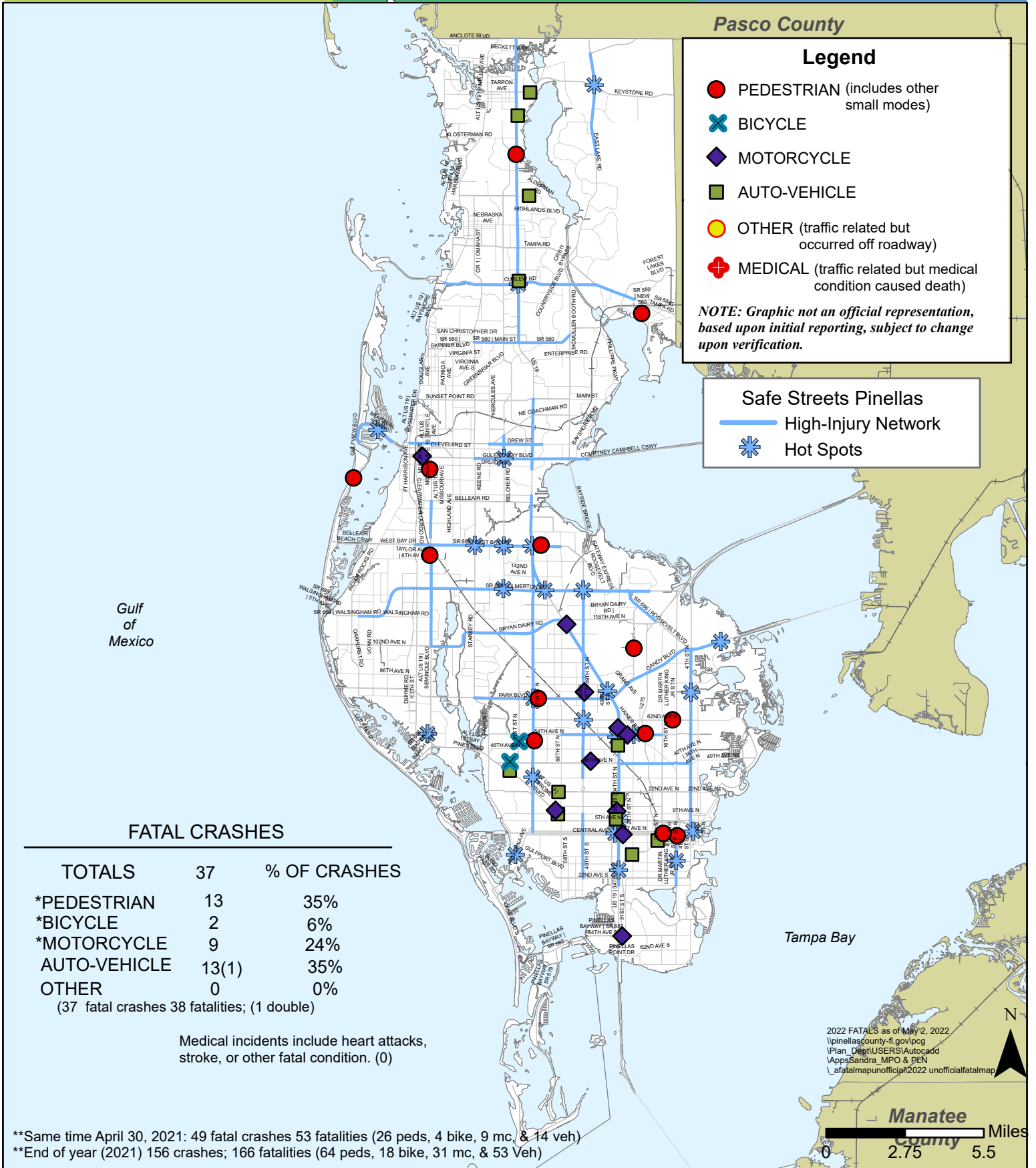
