1. CALL TO ORDER

Chairman Brian Smith called the meeting to order at 8:35 a.m. and the attendees in the room introduced themselves.

2. PUBLIC COMMENTS

Eric Sorenson shared concern with the recent deaths that have happened to pedestrians due to electric scooters and electric bicycles.

Paul Wray shared that on November 19th, a World Day of Remembrance service will be held in Treasure Island at 9:00 am.

3. APPROVAL OF MINUTES

The summary from the September 18, 2023 meeting was approved with no corrections.

4. FORWARD PINELLAS ACTIONS & SPOTLIGHT

Chelsea Favero, Forward Pinellas staff, reviewed the October 11, 2023 Forward Pinellas Board summary. The Board received the Skinner Boulevard presentation and the Bayway Cycle Track presentation from the Florida Department of Transportation (FDOT). The Memorandum of Understanding (MOU) for creating a Tampa Bay Regional MPO, was the main topic of discussion. As of October 12, 2023, Hillsborough, Pasco and Pinellas County MPOs have all approved the MOU and work will move forward toward exploring the establishment of a regional MPO. At the next meeting of the Tampa Bay Transportation Management Area Leadership Group, to be held December 1, 2023, the formal transmittal of the report regarding the feasibility of forming a regional MPO to the Florida Legislature will be discussed.

Ms. Favero continued with the SPOTLight Emphasis areas. Regarding Waterborne Transporation, PSTA has been awarded a Service Development Grant from the state to help pay for the operation of waterborne ferry services. A competitive procurement must be conducted first. The City of Clearwater received a grant from the legislature to purchase a new ferry vessel to serve the area as well, however a competitive procurement must also be done for this project. With operational and capital funding, work will begin with our partners at PSTA to identify the required local match and other steps to get the service running. Regarding US 19, in the Draft Tentative Work Program, a couple of projects have been deferred. The Curlew Road interchange is currently under construction. As soon as this segment has been completed, construction on the Tampa/Nebraska Road interchanges will begin. Because the other areas are not ready for construction, they have been deferred out of the Work Program at this time. Staff is meeting with FDOT next month to discuss the future of the interchanges north of Nebraska Road.

5. FALL UPDATE OFTHE TIP

Ariane Martins, Forward Pinellas staff, shared a presentation on the Fall Update of the Transporation Improvement Program (TIP). Each year, Forward Pinellas is required by federal law to update the TIP in order to receive federal funds for transportation projects. In July 2023, the FY2023/24 – FY 2027/28 TIP was adopted, making the transportation projects contained within eligible to receive state and federal funding. The Fall Update includes the transportation sections of the local governments municipal work programs, PSTA work programs and grants, various local airport work programs, and the Pinellas County Capital Improvement Program (CIP). Ms. Martins reviewed the summary tables showing the Pinellas County Capital Improvement projects as well as maps and indicated that there is an interactive map online that highlights all of the County's projects, in addition to the maps and tables included in the agenda packet. Questions were taken and appropriately answered. Gordon Brown made a motion for the committee to recommend approval of the Fall Update of the FY 2023/24- FY 2027/28Transportation Improvement Program by the Forward Pinellas Board. This was seconded by Charlie Guy and passed with a unanimous vote.

6. COUNTYWIDE TRENDS AND CONDITIONS REPORT

Mr. Rob Feigel, Forward Pinellas staff, shared information with the committee on the Countywide Trends and Conditions Report. The Trends and Conditions Report provides an annual snapshot of the county's transportation system, including roads, trails, sidewalks, bike lanes, and transit services. In addition, the report provides data on economic and land use activity, waterborne transportation, and emerging technologies. The report serves as a tool to evaluate progress toward achieving the objectives of the Long-Range Transportation Plan, identify projects to address safety concerns and congestion problems, inform transportation safety studies and transportation project design, and target law enforcement activities related to safety. Questions were taken and appropriately answered.

7. DRAFT TENTATIVE WORK PROGRAM

Mr. Jensen Hackett, FDOT staff, shared that the Florida Department of Transportation (FDOT) District 7 is developing the Five-Year Tentative Work Program for Fiscal Years 2024/25 through 2028/29. The Work Program outlines the federal- and state-funded transportation projects for the next five years that include the new projects introduced in the new fifth year (2028/29). Development of the Tentative Work Program considers the project priorities adopted annually by Forward Pinellas and becomes a major part of the MPO's Transportation Improvement Program. Projects include public transit, seaport, airport and rail projects as well as transportation planning, intelligent transportation, highway design, right of way acquisition and construction activities. Mr. Hackett reviewed the projects with the members showing new projects added, new funded project phases, deferred projects and projects of interest. Mr. Hackett shared that a public website is available to receive public comments on the Draft Tentative Work Program, with comments due by November 13, 2023. Furthermore, an Open House will also be held on October 26th from 9 a.m. to 6 p.m. at the FDOT District 7 office. More information on the Draft Tentative Work Program can be found at www.fdot.gov/wpph/district7. Questions were taken and appropriately answered. A motion was made by Charlie Guy to recommend approval of the FDOT FiveYear Tentative Work Program to the Board. This was seconded by Stuart Schwartzreich and passed with a unanimous vote.

8. BPAC BUSINESS

A. Friends of the Pinellas Trail

Scott Daniels, President of Friends of the Pinellas Trail, shared that on October 24th, Friends of the Pinellas Trail will be holding their next meeting at the Largo Public Library at 6:00 pm. The Friends is always looking for volunteers and provided a phone number, 727-487-1221 for citizens to either volunteer time, share information and ideas, and ask questions.

Mr. Schwartzreich shared that Friends also has a Facebook page and if there are any events Friends can share, or have questions, comments, stories or concerns to share, please send an email and pictures to <u>friendsofthepinellastrail.org</u>.

Mr. Peter Wray inquired as to the status of painting a stripe down the center of the Trail. Ms. Joan Rice, Pinellas County Public Works Traffic, explained that depending on the location of the area in question, it could be the City's responsibility or the Parks Department's responsibility. A request needs to be submitted to the proper authority of that jurisdiction. Mr. Daniels suggested he get in touch with Lyle Fowler or Paul Cozzie to make sure they are aware of Mr. Wray's concern.

A suggestion was made to write an informal letter to Paul Cozzie, Pinellas County Parks & Conservation Resources (PCR) from the BPAC requesting his help in trying to identify how additional pavement markings in between intersections along the trail could be added. A motion was made to write an informal letter to Paul Cozzie, from the BPAC by Peter Wray. This was seconded by Charlie Guy and passed with a unanimous vote.

8. AGENCY REPORTS

• Pinellas Trail Loop/Duke Energy Trail (North & South Gaps)

Ms. Joan Rice shared an update on the Pinellas Trail Loop. There have been no changes and the project is still in the design phase from 126th Ave to Haines Bayshore. Construction is scheduled for 2026. The next priority will be to pursue SunTrail funding. The SunTrail grant has been opened and Pinellas County has until December 20th to complete.

- Clearwater Bicycle Pedestrian Program Jayme Lopko shared there were no updates.
- St. Petersburg Bicycle Pedestrian Program Ms. Maika Arnold, St. Petersburg Transportation, shared that the city is continuing to work on grant applications. One application is for a pilot program to put a rubber type curbing on the bike lanes.
- Largo Bicycle Pedestrian Program Whitney Clark shared that there were no updates.

5. Complete Street Grant Applications

SUMMARY

Forward Pinellas provides funding to its local government partners through a variety of competitive grant programs. Now in its eighth year, the Complete Streets Grant Program provides annual allocations for concept planning and construction projects. This year, up to \$150,000 is available for concept planning projects and up to \$1.5 million is available for construction projects. Forward Pinellas released a Call for Projects in the summer of 2023 and the submittal deadline for the grant program was October 6th, 2023.

Forward Pinellas received two applications for concept planning funding and one application for construction funding. The applications received are:

- Pinellas County request for \$95,000 for the Downtown Palm Harbor, West Florida Avenue Corridor Enhancement and Parking Project
- City of St. Petersburg request for \$100,000 for the 31st Street Planning Study
- City of St. Petersburg request for \$1,500,000 to construct Curb Extensions in the Grand Central District

The applications for the projects listed above have been posted to the Forward Pinellas website and are available here: <u>https://forwardpinellas.org/programs/complete-streets-program/</u>. A subcommittee has been established with Forward Pinellas staff and agency stakeholders from the Planners Advisory Committee and Technical Coordinating Committee to review the applications and develop recommendations for funding. Following review and ranking of the applications by the subcommittee, recommended awards will be brought to the board for approval in early 2024. Forward Pinellas staff will provide an overview of the applications received.

6. Complete Street Before/After Studies



SUMMARY

In 2017, Forward Pinellas developed the Complete Streets Grant Program to provide funding to local government partners for the planning and implementation of Complete Streets projects. In order to gauge the effectiveness of the agency's investments in the Complete Streets Program, Forward Pinellas is conducting an analysis of the 'before' conditions for the corridors listed below. The projects have been advancing through the FDOT Work Program and are planned to go under construction in early 2024. Each City was awarded \$1 million to provide complete streets treatments along the following corridors:

- Rosery Road (Largo, FL) from Missouri Avenue to Eagle Lake Park (awarded in 2018)
- Skinner Blvd (Dunedin, FL) from Alternate 19 to Bass Blvd to Main Street (awarded in 2019)
- St. Petersburg Drive (Oldsmar, FL) from Bayview Blvd to Dartmouth Ave (awarded in 2018)

Metrics will include four-day video data collection at multiple intersections within each of the selected corridors, vehicular speed data, transit travel time (where applicable), and land use and economic data. Forward Pinellas staff will provide an overview of the ongoing studies and provide context on the metrics to be analyzed.

7. Transportation Alternatives Applications

SUMMARY

The Transportation Alternatives (TA) Program uses federal funds to construct pedestrian and bicycle projects, as well as infrastructure to improve non-driver access to transit. This application process includes scoring and ranking criteria for projects being considered for TA Program funding. Each local government may submit up to three project applications, for projects that cost between \$300,000 and \$3,000,000. Projects selected through this competitive process will be advanced to FDOT in priority order for funding consideration in the summer of 2024.

This year Forward Pinellas received three applications from the City of St. Petersburg. Applications will be reviewed by Forward Pinellas staff, who will make award recommendations to the Forward Pinellas Board. Forward Pinellas staff will provide an overview of the TA applications received this cycle.




September Totals by Counter Location*







We met today to define the approach to directional markings on the Pinellas Trail concerning keeping to the right, which is the current policy. We already have defined the keep right program at the intersections with arrows and modification of the bollard locations. With that done, we needed to treat the open stretches between those intersections. At our meeting today we identified an approach where the stretches of a half mile or more would be marked with a set of directional arrows. We also identified a treatment for the divided pavement sections. At those locations at the beginning of the divided pavement keep right arrows will be installed. It should be noted that this is a joint venture between Pinellas County Public Works and Pinellas County Parks who will work together on implementation of this initiative. We will provide this information to the BPAC at its November meeting. Brian
