1. CALL TO ORDER/PLEDGE TO FLAG/INTRODUCTIONS

Caron Schwartz, Chair, called the meeting to order at 7:00 pm. and the Pledge of Allegiance was recited. Attendees in the room and on Zoom introduced themselves. A physical quorum was met at 7:15, therefore the Chair moved back to item one and read the extenuating circumstances letter. The Chair advised the committee that Florida law requires a quorum of the CAC to be physically present to conduct business. However, the law provides an exception for some members to participate by non-physical means if a quorum is physically present and if the physical quorum present decides that there are extraordinary circumstances. At this time, Chair Schwartz read a statement regarding allowing committee members present to make a motion to

allow those members participating by Zoom (all names identified above) to participate and vote due to the fact that extenuating circumstances exist making it impossible for some committee members to attend in person. A motion was made by Bob Henion that due to Covid-19, extenuating circumstances exist that prevent members from joining in person. Therefore, they will be allowed to participate and vote by phone since a quorum is represented in person. This was seconded by Paul Wallace and passed with a unanimous vote.

2. PUBLIC COMMENTS

David Ballard Geddes Jr. inquired as to why trams, similar to those used at Busch Gardens, weren't being used within cities. He noted that these types of vehicles are easy to fix and to adjust in length.

3. APPROVAL OF MINUTES

The summary of the September 22, 2022 meeting was approved with no corrections.

4. FORWARD PINELLAS ACTIONS

Robert Feigel, Forward Pinellas staff, reviewed the highlights of the Forward Pinellas Board meeting for October 12, 2022. Forward Pinellas staff presented draft recommendations for the Target Employment Industrial Land (TEILS) Study. TBARTA staff and consultants presented on the Pinellas Gondola Feasible Study. Councilmember David Allbritton commented that the City of Clearwater received the same presentation, and it was well received. The Board approved the election of Mayor Bujalski as Secretary, with the departure of Commissioner Seel. Councilmember Patti Reed was selected as the Chair for the Legislative Committee. One of the legislative priorities being looked into is an exemption of advisory board committees, such as the CAC, from having a physical quorum present, and to allow voting by virtual communications.

5. OVERVIEW OF THE CAC'S ROLE IN THE PLANNING PROCESS - PART 2

Mr. Feigel shared a PowerPoint on the Role of the CAC. At the September meeting, what is the MPO, the role of the CAC, membership and attendance, representation, term limits, sunshine law and types of agenda items were covered. Some of the major functions of the MPO includes the development and maintenance of the Transportation Improvement Program (TIP), Unified Planning Work Program (UPWP), and Congestion Management Process (CMP). The process CAC members will go through as an advisory committee, is to help to develop transportation priorities, in light of the fact that there are typically more projects to be done than the funding to do them all, so priorities lists are created, and the CAC advises on these lists. FDOT's state work program plays an important part of the allowable funding for these priorities. Members were asked to email questions to regigel@forwardpinellas.org.

6. FY 2019/20 - FY 2023/24 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

There were no proposed TIP amendments.

7. TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENTS

Ariane Martins, Forward Pinellas staff, shared information on the Fall Update to the FY2022/23 – FY2026/27 Transportation Improvement Program (TIP). On July 2022, the FY2022/23 – FY 2026/27 TIP was adopted, identifying the transportation projects eligible to receive state and federal funding. This Fall Update includes the transportation sections of the local governments

municipal work programs, PSTA work programs and grants, various local airport work programs, the Port of St. Petersburg work program and the Pinellas County Capital Improvement Program (CIP). Committee members were directed to the Forward Pinellas website for an interactive TIP map of the various projects, under Building Your Future/Transportation Improvement, identifying information about the various projects. If approved by the Forward Pinellas Board on November 10, 2021, the County CIP and local Work Programs will be incorporated into the current TIP. Questions were taken and appropriately answered. A motion was made by Brian Scott to recommend the board approve the Fall update to the Transportation Improvement Program. This was seconded by Chris Griffin and passed with a unanimous vote.

8. (9) COUNTYWIDE TRENDS AND CONDITIONS REPORT

Rob Feigel, Forward Pinellas staff, shared a presentation on the Trends and Conditions Report. The Trends and Conditions Report provides an annual snapshot of the county's transportation system, including roads, trails, sidewalks, bike lanes, and transit services. In addition, the report provides data on economic and land use activity, waterborne transportation, and emerging technologies. The report serves as a tool to evaluate progress toward achieving the objectives of the Long Range Transportation Plan, identify improvements needed to address safety concerns and congestion problems, inform transportation safety studies and transportation project design, and target law enforcement activities related to safety. Working from home trends are increasing since the pandemic, from 7% in 2019 to 21% in 2021. However, even with more people working from home, the traffic on the roads has only decreased by 5%., In Pinellas County, based on a five-year rolling average, crashes are down 2.5%, injuries are down 8%, and fatalities are up by 6%. Data from the current year through September 30th, shows fatal crashes being down for pedestrians, bicyclists, and motorists compared to the same time period in 2021, however motorcycle crashes are up 23%. Forward Pinellas initiatives to reduce crashes include: 1) Integrate Safety into all Aspects of Planning; 2) Active Transportation Plan; 3) Complete Streets Projects; 4) Crash Data/Technical Assistance; 5) School Transportation Safety Committee; 6) Safe Streets Pinellas (Vision Zero). The agency's goal is to eliminate transportation-related fatalities and serious injuries by 2045. Questions were taken and appropriately answered.

9. (8) TARGET EMPLOYMENT INDUSTRIAL LAND USE STUDY (TEILS) UPDATE

Jared Austin, Forward Pinellas staff shared an update on the Target Employment and Industrial Land Study (TEILS) study with the committee. Due to the lack of vacant greenfield land in Pinellas County, market forces have made the development of residential and commercial property more lucrative to the landowner/developer than industrial development, creating pressure to convert industrial parcels to other uses. At the same time, there is not enough developable target employment land to accommodate many of the target employers who wish to move into the county. This has been a challenge for Pinellas County since the 2008 Target Employment and Industrial Lands Study (TEILS) was commissioned. However, these challenges have been exacerbated by the recent passage of Senate Bill 962, which allows the governing body of a county or municipality to approve a residential development on any parcel designated for residential, commercial, or industrial use if at least 10 percent of the residential units built are designated for affordable housing. Since January of 2022, Forward Pinellas, in partnership with Pinellas County Economic Development, Pinellas County Housing and Community Development, Renaissance Planning Group, and SB Friedman Development Advisors, has been working to update the TEILS to address many of these countywide land use challenges. The TEILS work has since identified several key target industry clusters throughout the county that in addition to paying higher than average wages, are export-oriented and contribute substantially to the gross

regional product (GRP) of Pinellas County. In order to address the challenge of continuing to foster a healthy economy amidst competing interests for limited land, the TEILS update has begun to narrow its focus on the market demand and suitability of existing class A office space and industrial lands throughout Pinellas County and their ability to support the identified target employment clusters for many years to come. Questions were taken and appropriately answered.

The group drafted and adopted a recommended proposed resolution to the Board. At the Board meeting, it was announced that TBARTA is not getting funding and need to rethink their future.

THE PLANNING COUNCIL AND METROPOLITAN PLANNING ORGANIZATION FOR PINELLAS COUNTY

The Forward Pinellas Board held this public meeting in person on November 9, 2022, at 1 p.m. in the Palm Room at the Pinellas County Communications Building.

Forward Pinellas Staff updated the board on the status of the Target Employment and Industrial Land Study (TEILS) Update.

Forward Pinellas, Pinellas County Economic Development, Pinellas County Housing and Community Development, Renaissance Planning Group, and SB Friedman Development Advisors, have been working to update the TEILS to address present challenges and identify strategies that can more effectively balance competing countywide interests. The TEILS work has identified several key target industry clusters throughout the county that pay higher than average wages, are export-oriented, and contribute substantially to the gross regional product of Pinellas County.

Jared Austin of Forward Pinellas provided an overview of the work completed to date, including draft recommendations and positive feedback from project stakeholders, and discussed the next steps in the update. The final TEILS report will be presented at the January 2023 board meeting for acceptance and endorsement of its recommendations. Based on report findings, updates to the Countywide Plan will be incorporated in spring 2023.

- Councilmember Driscoll and Commissioner Cliff Merz stated that nuances can be lost when multiple industries and skills are lumped into categories in this way (e.g., Microelectronics/Aviation and Aerospace Defense category).
- Commissioner Cliff Merz recommended a more flushed-out statement regarding Medical Technologies/Life & Marine Sciences as "not competitive with surrounding metropolitan areas" would be beneficial.
- Mayor Cookie Kennedy, Chair, requested meeting notifications and the final report be sent to board members who are leaving the board this year.
- Commissioner Dave Eggers and Mayor Julie Bujalski noted that it will be important to have guidance prepared for cities for industrial lands not included in the TECs.

The board unanimously approved the Countywide Trends and Conditions Report.

Robert Feigel of Forward Pinellas presented highlights of the updated Countywide Trends and Conditions Report. The Forward Pinellas Countywide Trends and Conditions Report provides a high-level, annual snapshot of the county's transportation system. Notable trends from 2017-2021 include: traffic decreased 5%, crashes were down 2.5%, fatalities were up 6%, and injuries were down 8%.

The board unanimously approved the Nominating Committee recommendation for the 2023 Executive Committee membership.

At the October board meeting, pursuant to the Forward Pinellas Board Operating Procedures, the board established a Nominating Committee. Nominating Committee members include Councilmember Bonnie Noble, Mayor Cookie Kennedy, and Commissioner Cliff Merz, and met on October 24th to develop a recommended slate of officers for consideration by the full board:

- Chair Commissioner Janet Long, Pinellas County
- Vice Chair Vice Mayor Michael Smith, City of Largo
- Secretary Mayor Julie Bujalski, City of Dunedin
- Treasurer Councilmember David Allbritton, City of Clearwater

The board unanimously agreed with the Nominating Committee's recommendations to appoint members to the Transportation Management Area (TMA) Leadership Group, Sun Coast Transportation Planning Alliance (SCTPA), and the Metropolitan Planning Organization Advisory Council (MPOAC).

Forward Pinellas Board members play a vital role in serving on a variety of other boards and committees addressing regional and statewide transportation matters. At the end of each calendar year the board makes or re-affirms appointments to these boards and committees.

TMA Leadership Group acts on behalf of each of the three MPOs serving the Tampa-St. Petersburg Urbanized Area (Hillsborough, Pasco and Pinellas) to coordinate transportation plans and build consensus on regional transportation priorities. Nominees include Rep — Commissioner Dave Eggers, Rep — Commissioner Janet Long, and Rep — Councilmember Gina Driscoll. Any board member can substitute and vote in place of the TMA Leadership Group Representatives.

SCTPA is comprised of MPO board members from the 8-county West Central Florida region to establish regional transportation priorities for funding and coordinate plans across county and urban area boundaries. The voting members are the delegates for each represented MPO, including Forward Pinellas, Hernando/Citrus, Hillsborough, Pasco, Polk, and Sarasota/Manatee. The nominee selected is Councilmember Gina Driscoll.

MPOAC represents Florida's 27 MPOs with an executive director, a committee of staff directors and a governing board comprised of statewide MPO board members. Together, they provide input on federal and statewide transportation policy, establish legislative priorities, and align policy among the MPOs in the state. Nominees included: Rep – Commissioner Dave Eggers, First Alt – Vice Mayor Smith, Second Alt – Councilmember Richie Floyd.

The board unanimously approved the 2023 Forward Pinellas Legislative Priorities and Platform.

The Forward Pinellas Legislative Committee met on October 12th and November 9th to discuss the draft 2023 policy positions and develop recommendations for the full board's consideration, as well as the top three legislative priorities for the year.

- 1. Strong local communities: support the rights of communities to govern themselves according to the wishes of their residents.
- 2. Safe, effective transportation: support flexible, sustained transportation funding that meets the needs of all users, based on community context, and ensures that our streets are safe.
- 3. Robust citizen participation: support increased citizen involvement in local government planning.
- The possible formation of a regional MPO was not included in the legislative priorities at this time but will be continued to be discussed among regional partners and at the local level in each county.

The board unanimously approved the Fall Update of the FY 2022/23 – FY 2026/27 Transportation Improvement Program (TIP).

Ariane Martins of Forward Pinellas presented the Fall Update of the FY 2022/23- FY 2026/27 Transportation Improvement Program. Each year in the fall Forward Pinellas updates the TIP to include the recently adopted transportation capital work programs of the local governments, including local airports, Port of St. Petersburg, Pinellas Suncoast Transit Authority (PSTA) and Federal Transit Administration (FTA) Section 5310 Grant Program allocations.

- In response to questions from Commissioner Eggers, Erin Lawson, with Public Works and Transportation Engineering, clarified the Sunset Point Road improvement includes sidewalks and enhancements to the roadway, with no widening. Erin also noted a guardrail design is complete and out for bid for the Keystone Rd corridor adjacent to the Tri County Trail connection. It is a traditional guard rail set on the side of the road, between the trail and the road.
- Vice Mayor Michael Smith and Mayor Julie Bujalski inquired about projects involving West Bay Drive, Starkey Road and the Dunedin Causeway Bridges, and county staff provided responses on anticipated timing for design and construction, respectively.

The board recommended approval of three amendments to the Countywide Plan Map.

The board recommended approval of three amendments:

Case CW 22-21 – A request from Pinellas County to amend a 13.1-acre property at 10055
 Seminole Blvd. from Office and Preservation to Employment and Preservation. The property consists of a 60,000 square-foot office building and the applicant proposes to utilize the

- property for light manufacturing, assembly, and processing. The proposed amendment would designate the 5.5 acres of uplands to the Employment category while maintaining the Preservation designation for existing wetlands.
- Case CW 22-22 A request from the City of Safety Harbor to amend a 3.6-acre property located at 3404 and 3406 Enterprise Rd, a property comprised of two parcels located on the corner of Enterprise Rd. and a CSX Railroad line, from Residential Very Low to Residential Low Medium. It is the intent of the applicant to develop single-family detached dwellings on the property at a higher density.
- Case CW 22-23 A request from the City of Clearwater to amend two properties totaling 0.891 acres located at 110 N. McMullen Booth Road from Residential Low Medium to Public/Semi-Public. The proposed amendment requests to revise and expand the parking lot for a church to create a more comprehensive parking plan.

The board presented Staff Service Awards to Linda Fisher and Sandra Knoebel.

Forward Pinellas staff members Sandra Knoebel and Linda Fisher were presented Staff Service Awards for 35 years and 25 years, respectively, of service to the citizens of Pinellas County. Thank you to Sandra and Linda for their hard work and dedication.

SPOTlight Updates

- Executive Director Whit Blanton provided updates on US 19 construction projects with FDOT.
 - The pedestrian underpass, south of Republic Drive, will add just over \$1-2 million to the total cost of a \$242 million capacity project. This project includes one underpass, one overpass, and one shared access at Boy Scout Rd., along with the construction of an interchange at Curlew Rd.
 - Forward Pinellas staff met with FDOT about future interchanges on US 19 north of Curlew and Tampa Road. Questions persist for the necessary treatments at Alderman Road, Klosterman Road, Tarpon Avenue, and Alternate US 19. FDOT conducted an evaluation upon request and has presented its findings to Forward Pinellas staff. The department recommended Alderman and Klosterman would likely need to be interchanges as well, with potential at-grade improvements at the Tarpon Road and Alt 19 intersections. This will be discussed in more detail at an upcoming board meeting or workshop.
 - Commissioner Dave Eggers stressed the importance of interchanges to keep traffic moving without adding lanes, as well as the use of new technologies.
 - Forward Pinellas' LRTP has funding allocated for technology investments that could be considered to complement Pinellas County's work on a Connected Communities grant project.

- Sidewalk improvement plans for Gulf Boulevard in the Town of Indian Shores are still in progress. The town is working with FDOT to reduce the overall project cost estimate by identifying potential ways to reduce right-of-way costs.
- Outreach activities are underway for the Advantage Alt 19 Investment Corridor Plan. Board members are encouraged to attend and/or promote future workshops. Information about the plan is available at: <u>Advantage Alt 19</u>. The results of the community outreach will be shared with the board in early 2023.

PSTA Report

- O Pinellas County funding for Clearwater Transit Center: Debbie Leous, Chief Financial Officer, gave a presentation on an interlocal funding agreement with Pinellas County. PSTA has developed a project budget of \$44.5 million, including contingency for the design and construction of the Clearwater Transit Center. An estimated \$10 million funding gap exists and the County, recognizing the benefits of the transit center to the entire county, agreed to provide up to \$8 million of any final funding gap. The PSTA board unanimously approved the agreement.
- O PSTA's state lobbyist outlined the 2023 State Legislative priorities, which were approved unanimously. Highlights include Electric Transit Vehicle Infrastructure, maintenance, and enhancement of the Regional TD Tampa Bay Program, and added flexibility of State Transportation funding to allow it to be used for transit and to allow for pre-award authority for state grants.
- o PSTA's federal lobbyist outlined the 2023 Federal Legislative Priorities, which were approved unanimously. Highlights include:
 - Passage and signing into law FY23 Appropriations Bills to secure funding for solar-powered electric bus and facility charging infrastructure and to ensure the highest possible FTA funding levels.
 - Maintenance of existing, fair regional funding split for FY2023 Federal Funds.
 - Prioritization of funding from USDOT grants for a Congressional Directed Spending request for Battery storage and electric bus charging infrastructure. Also, prioritization of LONO funding, Bus & bus facility funding, ferry service capital investment, and other federal funding for transit.
- O PSTA's Heather Sobush and Whit Blanton of Forward Pinellas will be presenting a statewide webinar Monday, November 14, at the request of the FDOT on best practices in MPO and Transit Agency Coordination, particularly as it relates to the Transit Asset Management Plan and Public Transportation Safety Management Plan. It is a recognition of best practice in Florida for the high level of coordination between Forward Pinellas and PSTA.

• TBARTA Report

 Commissioner Janet Long reported that TBARTA is becoming insolvent due to a lack of state funds and withdrawal of contributions from member jurisdictions and will

- request the legislature repeal the agency. A plan to discontinue operations will be presented at the January board meeting.
- O She said a representative from CSX attended TBARTA's November board meeting to share information about their plans in Tampa Bay. It was suggested the MPOs carry the discussion forward.
- She discussed the US 19 Regional BRT project that will now be transitioned to the MPOs and transit agencies.
- O Work is complete on the Pinellas Aerial Gondola Feasibility Study. Clearwater City Council will discuss in the coming months whether to advance a project or not.
- O Demand for the vanpool program, Commute Tampa Bay, continues to grow. There were 194 vanpools in October, an all-time high.
- The Gulf Coast Safe Streets Summit Vision Zero Hero Award was given to Mike Riordon at the summit on November 3rd.
- The Board recognized veterans in attendance for their service in celebration of Veterans Day: Councilmember Bonnie Noble, Mike Riordon, Rodney Chatman, and Robert Feigel.
- Outgoing Board Members Mayor Cookie Kennedy, Commissioner Cliff Merz, and Councilmember Bonnie Noble will be recognized at the Forward Pinellas Workshop in December.
- The Executive Director commended Commissioner Karen Seel for recently receiving the prestigious Outstanding Elected Official Leadership award from the Association of Metropolitan Planning Organizations (MPOs).

7. Public Participation Plan Update

SUMMARY

On October 11th, Forward Pinellas opened the public comment period for the new Public Participation Plan (PPP). The PPP is a federally required, and organizationally responsible, document that outlines the various methods that Forward Pinellas will utilize to engage and seek feedback from the public. The PPP is being completely re-written to incorporate new public participation strategies while also being developed in a more public-friendly format. 8. Overview of the Complete Streets Projects



SUMMARY

Forward Pinellas provides funding to its local government partners through a variety of competitive grant programs. Now in its 7th year, the Complete Streets Grant Program provides annual allocations of up to \$100,000 for concept planning projects and up to \$1 million for construction projects. Forward Pinellas released a Call for Projects in the summer of 2022 and the submittal deadline for the grant program was November 2022.

Forward Pinellas received three applications for concept planning funding and one application for construction funding. The applications received are:

- City of Largo request for \$75,000 for the Clearwater-Largo Road Multimodal Safety Improvements Project.
- City of Pinellas Park request for \$60,000 for the 60th Street North Complete Street Concept Plan Project.
- City of St. Petersburg request for \$100,000 for the Southern Skyway Marina District Complete Streets Concept Project.
- City of St. Petersburg request for \$460,755.17 to construct the 1st Avenue South Bikeway Improvements Project.

The applications for the projects listed above will be posted to the Forward Pinellas website. A subcommittee will be established with Forward Pinellas staff and agency stakeholders to review the applications and develop recommendations for funding. Following review and ranking of the applications by the subcommittee, recommended awards will be brought to the board for approval in early 2023. Forward Pinellas staff will provide an overview of the applications received and answer any committee member questions.

SECTION I: NAME

The name of this committee shall be the Citizens Advisory Committee (CAC).

SECTION II: PURPOSE

The Committee shall serve Forward Pinellas, in its role as the Pinellas County Metropolitan Planning Organization, in an advisory capacity pursuant to Federal Regulations (CRF), Title 23, Chapter 1, Part 450, Subpart A, Section 450.120, which requires the provision of public involvement within the Urban Transportation Planning Process and Coordination of Land Use.

A. The functions and responsibilities of the Committee shall include, but not be limited to, the following major areas:

1. Information

- Relate overall community needs and values, relative to planning goals and to future land use and transportation patterns.
- Establish comprehension and promote credibility for the planning process.
- Provide Citizen Committee knowledge of the planning process into local citizen group discussions and meetings.
- Promote better public dissemination of general information through mass circulation methods.

2. Issue Clarification and Problem Solving

- Evaluating and proposing solutions and alternatives on major transportation proposals and critical transportation issues.
- Determining general citizen attitudes and response to planning and programming issues.
- Articulating and interpreting the goals of the PATS program in program evaluation and information dissemination.
- Identification of existing transportation problem areas of general citizen concern.

SECTION III: MEMBERSHIP, COMPOSITION, APPOINTMENT, QUALI-FICATIONS, AND TERMS

A. The Citizens Advisory Committee shall be composed of one representative from the Pinellas Suncoast Transit Authority's (PSTA) Transit Riders Advisory Committee (TRAC) and twenty-six (26) appointed persons from designated areas in the County as follows:

Anyone interested in serving on the CAC must complete a Forward Pinellas Advisory Committee Member application and attend at least one CAC meeting in order to be considered for appointment. This includes individuals recommended by Forward Pinellas Board members. Elected officials are not eligible to serve on the Committee. Considerations in the appointment of CAC members are listed below in order of priority.

- <u>1.</u> Minority representation as reflected in population data for Pinellas County and the Forward Pinellas Board Title VI Plan.
- 2. Effect on balance of age and gender of the Committee.
- 3. Whether the candidate previously served on the Committee. Individuals without prior experience on the Committee shall be given preference over those who previously served.

- 4. For at-large positions, consideration shall be given to how the individual would affect the balance of geographic representation on the Committee. The geographical representation of at-large Committee members should be equitable to the fullest extent possible.
- B. A member having three or more consecutive absences or four or more absences during a twelve-month period shall require reconfirmation by the Forward Pinellas Board or membership shall be terminated. The reconfirmation process may make allowance for absences due to a major health-related condition.

Forward Pinellas shall appoint members of the Committee by affirmative action of the Forward Pinellas Board with the recommendation made by either the Board Chair, a member of the Board, or the Forward Pinellas Director.

The term of appointment for each member shall be four years in duration unless the member resigns or until the membership is withdrawn by the Forward Pinellas Board. Members shall be limited to no more than two terms. An individual having served two terms may be appointed to another term or terms but must wait at least one year between appointments.

To initiate the term of office procedure, the Forward Pinellas Board will establish a staggered set of terms of 1, 2, 3, and 4 years using membership seniority, with the term of appointment starting January 1, 2005.

Concerning reappointment, that action would take into consideration the member's Committee participation, attendance, and the interest of other individuals in that membership.

SECTION IV: OFFICERS AND DUTIES

A. A Chair and Vice Chair of the Committee shall be a citizen member and shall be elected at the last regularly-scheduled meeting of each calendar year and shall hold office for one year and until their successors are elected. The Chair may not serve more than two terms. The Chair must have been a committee member for at least two years, and the Vice Chair must have been a Committee member for at least one year except under conditions described in IV(D).

- B. Any member may nominate a citizen member to be an Officer. All elections shall be by the majority vote of regular members present.
- C. The Chair shall preside at all meetings and shall be responsible for the agenda minutes and conduct of all meetings. The Chair shall be responsible for pertinent Committee correspondence and information releases. The Chair shall approve, with any necessary modifications, the agenda tentatively developed for him by Forward Pinellas Staff at least seven (7) days prior to any scheduled meeting. The Chair shall also serve as a liaison between the Citizens Committee and the Metropolitan Planning Organization, whenever the need arises. Subcommittees and their Chair may be appointed by the Chair, with the approval of the Committee.
- D. The Vice Chair shall, during the absence of the Chair or his inability to serve, have and exercise all the duties and powers of the Chair regardless of the Vice Chair's length of service. The Vice Chair shall also perform such other duties as may be assigned him by the Chair.
- E. If both the Chair and Vice Chair are absent from a meeting, a temporary Chair shall be provided by a majority vote of the members present. Any vacancy in office created by resignation or replacement of the Officer by the appointing Agency shall be filled by a majority vote of members present at the next regular meeting. The Officer so elected shall fill the remainder of the unexpired term of the vacant office.
- F. If, at any time, the Committee feels that an Officer is not performing his duties in accordance with Section 4, Subsection C, that Officer may be removed from office by a two-thirds vote of the members present at a regular meeting, provided that an item to that effect has been distributed in accordance with Section 4, Subsection C, of these Bylaws.

SECTION V: MEETINGS

A. The Committee shall meet monthly at a date, time, and place acceptable to a majority of the membership. The date or time may be changed by a majority vote of the regular members if ten (10) days notice is given to the members. (If circumstances warrant, the Chair may cancel or postpone a regular or special meeting and, if necessary, set a new date, time, and place for the meeting.)

- B. The Chair may call special meetings whenever deemed necessary.
- C. A seven (7) day notice shall be given for regular meetings. Emergency or Special Meetings may be called with a minimum of three (3) days notice, indicating the reason for the meeting. The three (3) days notice for Emergency or Special Meetings will be conducted by telephone. Agendas shall be prepared prior to all meetings. Agendas should be mailed with meeting notices and minutes of the previous meeting approximately seven (7) days prior to any regular meeting and three (3) days prior to any Emergency or Special Meeting. Members may place items on the mail-out agenda with approval of the Chair. Any item requiring Committee action may be brought before the Committee by any member with the Committee's approval, even though it is not on the agenda. The Committee shall decide if action is to be taken at that meeting or at a subsequent meeting.
- D. Whenever reports are to be given, copies will be prepared for each member of the Committee. When possible, said copies should be mailed with meeting notices.
- E. Each member shall have an equal vote.
- F. A quorum shall consist of one-third of the voting membership and shall be required for conduct of all official business. A majority of the quorum shall be necessary to decide an issue before the Committee.

SECTION VI: AMENDMENTS

These Bylaws may be amended by the affirmative vote of a majority of the regular members of the Committee, provided a copy of the proposed amendment(s) has been sent to every member approximately seven (7) days before it is voted on. All proposed amendments shall be voted on at regular meetings.


