## 1. CALL TO ORDER

TCC Chair, Joan Rice called the meeting to order at 2:00 p.m. and asked everyone to introduce themselves. At this time, Chair Rice read a statement regarding committee members present voting to allow those members participating by Zoom (all names identified above) to participate and vote due to existing extenuating circumstances that make it impossible for some committee members to attend in person. A motion was made by Kevin Jackson that due to Covid-19, extenuating circumstances exist that prevent some members from attending in person. Therefore, virtual attendees will be allowed to participate and vote by phone since a quorum is present in person. This was seconded by Frances Leong-Sharp and passed with a unanimous vote.

## 2. <u>APPROVAL OF SUMMARY</u>

The summary of the August 24, 2022, meeting was approved with no corrections.

## 3. <u>FY 2019/20 – FY 2023/24 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)</u> <u>AMENDMENT</u>

There were no proposed TIP amendments.

## 4. FALL UPDATE FOR THE TRANSPORTATION IMPROVEMENT PROGRAM

Ms. Ariane Martins, Forward Pinellas staff, shared information on the Fall Update to the FY2022/23 – FY2026/27 Transportation Improvement Program (TIP). In July 2022, the FY2022/23 – FY 2026/27 TIP was adopted, identifying the transportation projects that would receive state and federal funding. This Fall Update incorporates the transportation sections of the local governments municipal work programs, PSTA work programs and grants, various local airport work programs, the Port of St. Petersburg work program and the Pinellas County Capital Improvement Program (CIP) into the TIP. Members were directed to an interactive TIP map on the forwardpinellas.org website, under Building Your Future/Transportation Improvement, that displays information on the various projects. If approved by the Forward Pinellas Board on November 10, 2022, the County CIP and local Work Programs will be incorporated into the current TIP. Questions were taken and appropriately answered. A motion was made by Frances Leong-Sharp to recommend the board approve the Fall update to the Transportation Improvement Program. This was seconded by Kevin Jackson and passed with a unanimous vote.

## 5. TRENDS AND CONDITIONS REPORT

Rob Feigel, Forward Pinellas staff, shared a presentation on the Trends and Conditions Report. The Trends and Conditions Report provides an annual snapshot of the county's transportation system, including roads, trails, sidewalks, bike lanes, and transit services. In addition, the report provides data on economic and land use activity, waterborne transportation, and emerging technologies. The report serves as a tool to evaluate progress toward achieving the objectives of the Long Range Transportation Plan, identify improvements needed to address safety concerns and congestion problems, inform transportation safety studies and transportation project design, and target law enforcement activities related to safety. Working from home trends are increasing since the pandemic, from 7% in 2019 to 21% in 2021. However, even with more people working from home, the traffic on the roads has only decreased by 5%., In Pinellas County, based on a five-year rolling average, crashes are down 2.5%, injuries are down

8%, and fatalities are up by 6%. Data from the current year through September 30<sup>th</sup>, shows fatal crashes being down for pedestrians, bicyclists, and motorists compared to the same time period in 2021, however motorcycle crashes are up 23%. Forward Pinellas initiatives to reduce crashes include: 1) Integrate Safety into all Aspects of Planning; 2) Active Transportation Plan; 3) Complete Streets Projects; 4) Crash Data/Technical Assistance; 5) School Transportation Safety Committee; 6) Safe Streets Pinellas (Vision Zero). The agency's goal is to eliminate transportation-related fatalities and serious injuries by 2045. Questions were taken and appropriately answered.

## 6. 2021 LEVEL OF SERVICE REPORT

Kyle Simpson, Forward Pinellas staff, shared information on the 2021 Level of Service (LOS) Report. The LOS Report is produced annually as a tool to help monitor the county's major roadways. The report provides attribute and performance data. The attribute data includes facility types (e.g., freeway, signalized arterial, signalized collector, etc.), lane arrangements, jurisdictions, traffic volumes and signals per mile. Regarding performance, the report identifies volume to capacity (v/c) ratios and letter grades for each road section included in the major road network. Road sections operating at LOS E, F and/or v/c ratios of 0.9 or greater are considered deficient. Questions were taken and appropriately answered.

## 7. PINELLAS AERIAL GONDOLA FEASIBILITY STUDY

Mr. Simpson shared information on the Pinellas Aerial Gondola Feasibility Study. The feedback received from the public outreach was positive and indicated that there was a purpose and need to build such a transit system over the Clearwater Memorial Causeway. The study showed that gondolas were well-suited to the Tampa Bay area; suitable alignments exist to connect downtown Clearwater to Clearwater Beach; the routes are technically feasible; the project is financially viable, and the public is supportive of the project. Questions were taken and appropriately answered

## 8. TARGET EMPLOYMENT INDUSTRIAL LANDUSE STUDY (TEILS) UPDATE

Rodney Chatman, Forward Pinellas staff shared an update on the Target Employment and Industrial Land Study (TEILS) study with the committee. Due to the lack of vacant greenfield land in Pinellas County, market forces have made the development of residential and commercial property more lucrative to the landowner/developer than industrial development, creating pressure to convert industrial parcels to other uses. At the same time, there is not enough developable target employment land to accommodate many of the target employers who wish to move into the county. This has been a challenge for Pinellas County since the 2008 Target Employment and Industrial Lands Study (TEILS) was commissioned. However, these challenges have been exacerbated by the recent passage of Senate Bill 962, which allows the governing body of a county or municipality to approve a residential development on any parcel designated for residential, commercial, or industrial use if at least 10 percent of the residential units built are designated for affordable housing. Since January of 2022, Forward Pinellas, in partnership with Pinellas County Economic Development, Pinellas County Housing and Community Development, Renaissance Planning Group, and SB Friedman Development Advisors, has been working to update the TEILS to address many of these countywide land use challenges. The TEILS work has since identified several key target industry clusters throughout the county that in addition to paying

higher than average wages, are export-oriented and contribute substantially to the gross regional product (GRP) of Pinellas County. In order to address the challenge of continuing to foster a healthy economy amidst competing interests for limited land, the TEILS update has begun to narrow its focus on the market demand and suitability of existing class A office space and industrial lands throughout Pinellas County and their ability to support the identified target employment clusters for many years to come. Questions were taken and appropriately answered.

## 9. SAFETY LETTER TO FORWAD PINELLAS BOARD

Following a discussion about the setting of safety targets, the TCC requested a letter be sent to the Forward Pinellas Board to address the committee's concern that not enough is being done to address the safety of the transportation network in Pinellas County. The letter was presented to the committee at the May 25, 2022 meeting where several revisions were requested. Upon completion of the revisions, the letter was brought before the committee for additional feedback and approval before being sent to the board. Cheryl Stacks requested confirmation of the board's awareness of the letter coming to them. Cheryl made a motion to recommend the letter be sent to the board as drafted, with the condition that the board members are made aware the letter is coming. This was seconded by Caroline Lanford and passed with a unanimous vote.

## 10. ELECTION OF A NEW VICE-CHAIR

Brent Hall nominated Frances Leong-Sharp to fulfill the Vice Chair role for the remainder of 2022. Ms. Leong-Sharp accepted the nomination and was appointed by the committee with a unanimous vote.

## 11. INFORMATIONAL ITEMS

A. SPOTlight Emphasis Areas update.

Mr. Simpson shared information regarding the SPOTLight emphasis areas. With regards to Enhancing Beach Access, since the board meeting, FDOT and Whit Blanton met with Indian Shores regarding the sidewalk project on Gulf Boulevard. Officials are going to meet with Indian Shores property owners to ask them to donate the easements to reduce the cost of the project. If they are not successful, the project will have five-foot sidewalks instead of ten-foot sidewalks with shared lane markings in the travel lanes for bicyclists. Regarding Waterborne Transportation, FDOT has a new policy with district dedicated revenue now being available to cover transit operating costs. Current five-year work program funds are spoken for; however, it is possible to add funding for this service in the next new 5<sup>th</sup> year of the Work Program. The cost would be 100% covered in year one of its operation and reduce over a five year period by 20% each year with the fifth year being 100% local funding for transit operation.

Oldsmar allows golfcarts on streets with a 25 mph speed limit and under. State law allows 14 year olds to drive a golfcart, however the city requires a driver's license to drive a golfcart. A 14 year old was ticketed for not having a license and now the city has been challenged and tasked with finding out what other municipalities require. After looking at other municipalities, it was found that they either did not allow golfcarts or drivers are required to have a driver's license.

On October 11<sup>th</sup>, Forward Pinellas opened the public comment period for the new Public Participation Plan (PPP). The PPP is a federally required, and organizationally responsible, document that outlines the various methods that Forward Pinellas will utilize to engage and seek feedback from the public. The PPP is being completely re-written to incorporate new public participation strategies while also being developed in a more public-friendly format. One of the biggest additions to the document is the incorporation of audience-sensitive tools that agency staff can reference when targeting specific demographic groups. Forward Pinellas staff will provide an overview of the outreach tools included in the final PPP, and summarize the public comments received to date. The final PPP will be presented to the Forward Pinellas board for adoption in January 2023.

Forward Pinellas provides funding to its local government partners through a variety of competitive grant programs. Now in its 7th year, the Complete Streets Grant Program provides annual allocations of up to \$100,000 for concept planning projects and up to \$1 million for construction projects. Forward Pinellas released a Call for Projects in the summer of 2022 and the submittal deadline for the grant program was November 2022.

Forward Pinellas received three applications for concept planning funding and one application for construction funding. The applications received are:

- City of Largo request for \$75,000 for the Clearwater-Largo Road Multimodal Safety Improvements Project.
- City of Pinellas Park request for \$60,000 for the 60<sup>th</sup> Street North Complete Street Concept Plan Project.
- City of St. Petersburg request for \$100,000 for the Southern Skyway Marina District Complete Streets Concept Project.
- City of St. Petersburg request for \$460,755.17 to construct the 1<sup>st</sup> Avenue South Bikeway Improvements Project.

The applications for the projects listed above will be posted to the Forward Pinellas website. A subcommittee will be established with Forward Pinellas staff and agency stakeholders to review the applications and develop recommendations for funding. Following review and ranking of the applications by the subcommittee, recommended awards will be brought to the board for approval in early 2023. Forward Pinellas staff will provide an overview of the applications received and answer any committee member questions. Staff will also be seeking non-applicant representatives to serve on the subcommittee to review the applications.

Since the adoption of the Safe Streets Pinellas Resolution by the Forward Pinellas Board in July 2021, Forward Pinellas staff has been working to implement the Safe Streets Pinellas Action Plan to improve the safety of our county's transportation network. Forward Pinellas staff will provide a brief update on Safe Streets activities, highlighting some noteworthy projects underway or recently completed.

## TECHNICAL COORDINATING COMMITTEE PINELLAS AREA TRANSPORTATION STUDY

## SECTION I: NAME

The name of this Committee shall be the Technical Coordinating Committee, effective April 20, 1983.

## SECTION II: PURPOSE

The Committee shall serve Forward Pinellas, in its role as the Pinellas County Metropolitan Planning Organization (MPO) in an advisory capacity on technical matters.

- A. The functions of the Committee shall include, but not be limited to, the following:
  - 1. To promote communication among members and the identification and resolution of common problems.
  - 2. To develop transportation work programs.
  - 3. To promote the coordination of transportation planning and programming.
  - 4. To review and advise Forward Pinellas of the technical sufficiency, accuracy, and completeness of studies; plans; programs; or public information documents.
  - 5. To make priority recommendations to the Forward Pinellas Board and/or other agencies responsible for transportation plan and program implementation based upon the needs as determined by technical status, and the results of the Congestion Management System Process.
  - 6. To present, when appropriate, technical responses to recommendations on requests made through the citizen's input mechanism.
  - 7. To serve as a transportation Technical Advisory Committee to any and all duly constituted areawide transportation authorities and/or boards, as well as areawide planning boards or councils for physical development, health/social or comprehensive planning upon direct request for such boards or councils.

## SECTION III: MEMBERSHIP, COMPOSITION, APPOINTMENT, QUALIFICATIONS AND TERMS

A. Membership shall include, but not be limited to, agencies with responsibility for the planning, operations, development, or improvement of transportation within the study area. Each member agency shall be represented by at least one technically qualified representative of that agency, who shall be duly

appointed by that agency. Each representative shall serve at the pleasure of the member agency. The Committee shall be notified in writing of the appointment, reappointment, or replacement of a member agency's representative.

- B. Agencies, representatives and alternates recommended for membership on the Committee shall be confirmed by the Forward Pinellas Board.
- C. The Technical Coordinating Committee shall be composed of Regular and Advisory members. Regular members shall be voting members. Advisory members shall be nonvoting members, recommended for membership as the Committee deems necessary. Advisory members may include representatives of the Federal Highway or Federal Transit Administrations, state, regional and local agencies that are not able to participate as regular members, and Forward Pinellas and other technical support personnel as deemed necessary by the Committee.
- D. Alternates may be designated to act on behalf of Regular and Advisory members with all the privileges accorded thereto, provided the Alternate is another employee of the member agency.
- E. If the representative of a member agency has three or more consecutive absences, the Executive Director of Forward Pinellas will be advised for the purpose of sending a letter to the municipality advising of the situation and to request if membership on the Committee is still desired.

## SECTION IV: OFFICERS AND DUTIES

- A. A Chair and Vice Chair of the Committee shall be elected at the last regularly-scheduled meeting of each calendar year and shall hold office until their successors are elected.
- B. Any regular member may nominate or be nominated as an Officer. All elections shall be by the majority vote of Regular Members present.
- C. The Chair shall preside at all meetings and shall be responsible for the conduct of all meetings. The Chair shall be responsible for the approval of pertinent Committee correspondence and information releases.

Forward Pinellas staff shall coordinate the preparation of the Committee Agendas with the Chair. The Chair shall also serve as a liaison between the Technical Committee and the Forward Pinellas Board whenever the need arises. Subcommittees and their Chair may be appointed by the Chair, with the approval of the Committee.

- D. The Vice Chair shall, during the absence of the Chair, have and exercise all the duties and powers of the Chair. The Vice Chair shall also perform such other duties as may be assigned by the Chair. In the absence of the Chair, his/her alternate may sit as a regular Committee member.
- E. If both the Chair and Vice Chair are absent from a meeting, a temporary Chair shall be provided by majority vote of the members present. Any vacancy in office created by resignation or replacement of the Officer by the appointing Agency shall be filled by a majority vote of members present at the next regular meeting. The Officer so elected shall fill the remainder of the unexpired term of the vacant office.
- F. If, at any time, the Committee feels that an Officer is not performing his duties in accordance with Section IV., Subsection C, that Officer may be removed from office by a two-thirds vote of the members present at a regular meeting, provided that an item to that effect has been placed on the Agenda and has been distributed in accordance with Section V. Subsection C. of these Bylaws.

#### SECTION V: MEETINGS

- A. The Committee shall meet monthly, on the fourth Wednesday of each month, at 2:00 p.m., in the 1<sup>st</sup> floor "Planning" Conference Room, 310 Court Street, Clearwater, Florida. The date or time may be changed with reasonable notice provided to the Members.
- B. The Chair may call Special Meetings when deemed necessary or when two or more Member Agencies request a meeting.
- C. A seven (7) day notice shall be given for regular meetings. Emergency or Special Meetings may be called with a minimum of three (3) days notice, indicating the reason for the meeting. Agendas shall be prepared prior to all meetings. Agendas should be electronically distributed, with minutes of the previous meeting, approximately five (5) days prior to any regular meeting and at least three (3) days prior to any

Emergency or Special Meeting. Members may place items on the agenda with approval of the Chair. Any item requiring Committee action may be brought before the Committee by any member, even though it is not on the Agenda. The Committee shall decide if action is to be taken at that meeting or at a subsequent meeting.

- D. Whenever reports are to be provided, copies will be distributed electronically along with the Agenda if available, separately in electronic form prior to the meeting, or as a hard copy at the time of the meeting.
- E. Each member agency shall have an equal vote, which shall be one vote for each representative.
- F. A quorum shall consist of at least ten (10) of the voting membership or their alternates and shall be required for conduct of all official business. A majority of the quorum shall be necessary to decide an issue before the Committee.
- G. All meetings will be open to the public. Public participation shall be at the discretion of the Chair.

## SECTION VI: MPO CONFLICT OF INTEREST POLICY

- A. Conflicts of Interest
  - 1. Voting Conflicts

If a member of the TCC declares a voting conflict pursuant to Section 112.3143, Florida Statutes on a matter before Forward Pinellas or its advisory committees, that member may no longer participate in that matter before Forward Pinellas and local government board that has a member of Forward Pinellas on it, or any other committee of the Forward Pinellas organization. For the purposes of this subsection, the term "participate" means any attempt to influence the decision by oral or written communication, whether made by the member of Forward Pinellas or its advisory committee or at the member's direction. In the event a member has a conflict of interest, he/she is required to complete Form 8B – Memorandum of Voting Conflict for County, Municipal, and Other Local Public Officers and turn it into the Forward Pinellas staff for insertion in the minutes of the meeting where said conflict existed, in compliance with Section 112.3143, Florida Statutes.

#### 2. Lobbying Policy

Lobbying of evaluation committee members, the Forward Pinellas staff, or elected officials regarding Requests for Proposals, Requests for Qualifications, bids, or contracts during the pendency of bid protest by the bidder/proposer/ protestor, or any member of the bidder's/proposer's/protestor's staff, an agent of the bidder/proposer/protestor, or any person employed by the legal entity affiliated with or representing an organization that is responding to the Requests for Proposal, Requests for Qualification, bid or contract, or has a pending bid protest is strictly prohibited either upon advertisement or on a date established by Forward Pinellas and shall be prohibited until either an award is final or the protest is finally resolved by the Forward Pinellas Board or Executive Director, provided, however, nothing herein shall prohibit a prospective bidder/proposer from contacting the Forward Pinellas staff to address situations such as clarification and/or questions related to the procurement process. For purposes of this provision, lobbying activities shall include but not be limited to influencing or attempting to influence action or non-action in connection with any Requests for Proposals, Requests for Qualifications, bid or contract through direct or indirect oral or written communication or an attempt to obtain goodwill of persons and/or entities specified in this provision. Such action may cause any Requests for Proposals, Requests for Qualifications, bid, or contract to be rejected.

## THE PLANNING COUNCIL AND METROPOLITAN PLANNING ORGANIZATION FOR PINELLAS COUNTY

The Forward Pinellas Board held this public meeting in person on November 9, 2022, at 1 p.m. in the Palm Room at the Pinellas County Communications Building.

# Forward Pinellas Staff updated the board on the status of the Target Employment and Industrial Land Study (TEILS) Update.

Forward Pinellas, Pinellas County Economic Development, Pinellas County Housing and Community Development, Renaissance Planning Group, and SB Friedman Development Advisors, have been working to update the TEILS to address present challenges and identify strategies that can more effectively balance competing countywide interests. The TEILS work has identified several key target industry clusters throughout the county that pay higher than average wages, are export-oriented, and contribute substantially to the gross regional product of Pinellas County.

Jared Austin of Forward Pinellas provided an overview of the work completed to date, including draft recommendations and positive feedback from project stakeholders, and discussed the next steps in the update. The final TEILS report will be presented at the January 2023 board meeting for acceptance and endorsement of its recommendations. Based on report findings, updates to the Countywide Plan will be incorporated in spring 2023.

- Councilmember Driscoll and Commissioner Cliff Merz stated that nuances can be lost when multiple industries and skills are lumped into categories in this way (e.g., Microelectronics/Aviation and Aerospace Defense category).
- Commissioner Cliff Merz recommended a more flushed-out statement regarding Medical Technologies/Life & Marine Sciences as "not competitive with surrounding metropolitan areas" would be beneficial.
- Mayor Cookie Kennedy, Chair, requested meeting notifications and the final report be sent to board members who are leaving the board this year.
- Commissioner Dave Eggers and Mayor Julie Bujalski noted that it will be important to have guidance prepared for cities for industrial lands not included in the TECs.

## The board unanimously approved the Countywide Trends and Conditions Report.

Robert Feigel of Forward Pinellas presented highlights of the updated Countywide Trends and Conditions Report. The Forward Pinellas Countywide Trends and Conditions Report provides a highlevel, annual snapshot of the county's transportation system. Notable trends from 2017-2021 include: traffic decreased 5%, crashes were down 2.5%, fatalities were up 6%, and injuries were down 8%.

# The board unanimously approved the Nominating Committee recommendation for the 2023 Executive Committee membership.

At the October board meeting, pursuant to the Forward Pinellas Board Operating Procedures, the board established a Nominating Committee. Nominating Committee members include Councilmember Bonnie Noble, Mayor Cookie Kennedy, and Commissioner Cliff Merz, and met on October 24th to develop a recommended slate of officers for consideration by the full board:

- Chair Commissioner Janet Long, Pinellas County
- Vice Chair Vice Mayor Michael Smith, City of Largo
- Secretary Mayor Julie Bujalski, City of Dunedin
- Treasurer Councilmember David Allbritton, City of Clearwater

The board unanimously agreed with the Nominating Committee's recommendations to appoint members to the Transportation Management Area (TMA) Leadership Group, Sun Coast Transportation Planning Alliance (SCTPA), and the Metropolitan Planning Organization Advisory Council (MPOAC).

Forward Pinellas Board members play a vital role in serving on a variety of other boards and committees addressing regional and statewide transportation matters. At the end of each calendar year the board makes or re-affirms appointments to these boards and committees.

**TMA Leadership Group** acts on behalf of each of the three MPOs serving the Tampa-St. Petersburg Urbanized Area (Hillsborough, Pasco and Pinellas) to coordinate transportation plans and build consensus on regional transportation priorities. Nominees include Rep – Commissioner Dave Eggers, Rep – Commissioner Janet Long, and Rep – Councilmember Gina Driscoll. Any board member can substitute and vote in place of the TMA Leadership Group Representatives.

**SCTPA** is comprised of MPO board members from the 8-county West Central Florida region to establish regional transportation priorities for funding and coordinate plans across county and urban area boundaries. The voting members are the delegates for each represented MPO, including Forward Pinellas, Hernando/Citrus, Hillsborough, Pasco, Polk, and Sarasota/Manatee. The nominee selected is Councilmember Gina Driscoll.

**MPOAC** represents Florida's 27 MPOs with an executive director, a committee of staff directors and a governing board comprised of statewide MPO board members. Together, they provide input on federal and statewide transportation policy, establish legislative priorities, and align policy among the MPOs in the state. Nominees included: Rep – Commissioner Dave Eggers, First Alt – Vice Mayor Smith, Second Alt – Councilmember Richie Floyd.

## The board unanimously approved the 2023 Forward Pinellas Legislative Priorities and Platform.

The Forward Pinellas Legislative Committee met on October 12<sup>th</sup> and November 9<sup>th</sup> to discuss the draft 2023 policy positions and develop recommendations for the full board's consideration, as well as the top three legislative priorities for the year.

- 1. Strong local communities: support the rights of communities to govern themselves according to the wishes of their residents.
- 2. Safe, effective transportation: support flexible, sustained transportation funding that meets the needs of all users, based on community context, and ensures that our streets are safe.
- 3. Robust citizen participation: support increased citizen involvement in local government planning.
- The possible formation of a regional MPO was not included in the legislative priorities at this time but will be continued to be discussed among regional partners and at the local level in each county.

# The board unanimously approved the Fall Update of the FY 2022/23 – FY 2026/27 Transportation Improvement Program (TIP).

Ariane Martins of Forward Pinellas presented the Fall Update of the FY 2022/23- FY 2026/27 Transportation Improvement Program. Each year in the fall Forward Pinellas updates the TIP to include the recently adopted transportation capital work programs of the local governments, including local airports, Port of St. Petersburg, Pinellas Suncoast Transit Authority (PSTA) and Federal Transit Administration (FTA) Section 5310 Grant Program allocations.

- In response to questions from Commissioner Eggers, Erin Lawson, with Public Works and Transportation Engineering, clarified the Sunset Point Road improvement includes sidewalks and enhancements to the roadway, with no widening. Erin also noted a guardrail design is complete and out for bid for the Keystone Rd corridor adjacent to the Tri County Trail connection. It is a traditional guard rail set on the side of the road, between the trail and the road.
- Vice Mayor Michael Smith and Mayor Julie Bujalski inquired about projects involving West Bay Drive, Starkey Road and the Dunedin Causeway Bridges, and county staff provided responses on anticipated timing for design and construction, respectively.

## The board recommended approval of three amendments to the Countywide Plan Map.

The board recommended approval of three amendments:

• Case CW 22-21 – A request from Pinellas County to amend a 13.1-acre property at 10055 Seminole Blvd. from Office and Preservation to Employment and Preservation. The property consists of a 60,000 square-foot office building and the applicant proposes to utilize the property for light manufacturing, assembly, and processing. The proposed amendment would designate the 5.5 acres of uplands to the Employment category while maintaining the Preservation designation for existing wetlands.

- Case CW 22-22 A request from the City of Safety Harbor to amend a 3.6-acre property located at 3404 and 3406 Enterprise Rd, a property comprised of two parcels located on the corner of Enterprise Rd. and a CSX Railroad line, from Residential Very Low to Residential Low Medium. It is the intent of the applicant to develop single-family detached dwellings on the property at a higher density.
- Case CW 22-23 A request from the City of Clearwater to amend two properties totaling 0.891 acres located at 110 N. McMullen Booth Road from Residential Low Medium to Public/Semi-Public. The proposed amendment requests to revise and expand the parking lot for a church to create a more comprehensive parking plan.

## The board presented Staff Service Awards to Linda Fisher and Sandra Knoebel.

Forward Pinellas staff members Sandra Knoebel and Linda Fisher were presented Staff Service Awards for 35 years and 25 years, respectively, of service to the citizens of Pinellas County. Thank you to Sandra and Linda for their hard work and dedication.

## SPOTlight Updates

- Executive Director Whit Blanton provided updates on US 19 construction projects with FDOT.
  - The pedestrian underpass, south of Republic Drive, will add just over \$1-2 million to the total cost of a \$242 million capacity project. This project includes one underpass, one overpass, and one shared access at Boy Scout Rd., along with the construction of an interchange at Curlew Rd.
  - Forward Pinellas staff met with FDOT about future interchanges on US 19 north of Curlew and Tampa Road. Questions persist for the necessary treatments at Alderman Road, Klosterman Road, Tarpon Avenue, and Alternate US 19. FDOT conducted an evaluation upon request and has presented its findings to Forward Pinellas staff. The department recommended Alderman and Klosterman would likely need to be interchanges as well, with potential at-grade improvements at the Tarpon Road and Alt 19 intersections. This will be discussed in more detail at an upcoming board meeting or workshop.
    - Commissioner Dave Eggers stressed the importance of interchanges to keep traffic moving without adding lanes, as well as the use of new technologies.
    - Forward Pinellas' LRTP has funding allocated for technology investments that could be considered to complement Pinellas County's work on a Connected Communities grant project.

- Sidewalk improvement plans for Gulf Boulevard in the Town of Indian Shores are still in progress. The town is working with FDOT to reduce the overall project cost estimate by identifying potential ways to reduce right-of-way costs.
- Outreach activities are underway for the Advantage Alt 19 Investment Corridor Plan. Board members are encouraged to attend and/or promote future workshops. Information about the plan is available at: <u>Advantage Alt 19</u>. The results of the community outreach will be shared with the board in early 2023.

## **Other Items**

- PSTA Report
  - Pinellas County funding for Clearwater Transit Center: Debbie Leous, Chief Financial Officer, gave a presentation on an interlocal funding agreement with Pinellas County. PSTA has developed a project budget of \$44.5 million, including contingency for the design and construction of the Clearwater Transit Center. An estimated \$10 million funding gap exists and the County, recognizing the benefits of the transit center to the entire county, agreed to provide up to \$8 million of any final funding gap. The PSTA board unanimously approved the agreement.
  - PSTA's state lobbyist outlined the 2023 State Legislative priorities, which were approved unanimously. Highlights include Electric Transit Vehicle Infrastructure, maintenance, and enhancement of the Regional TD Tampa Bay Program, and added flexibility of State Transportation funding to allow it to be used for transit and to allow for pre-award authority for state grants.
  - PSTA's federal lobbyist outlined the 2023 Federal Legislative Priorities, which were approved unanimously. Highlights include:
    - Passage and signing into law FY23 Appropriations Bills to secure funding for solar-powered electric bus and facility charging infrastructure and to ensure the highest possible FTA funding levels.
    - Maintenance of existing, fair regional funding split for FY2023 Federal Funds.
    - Prioritization of funding from USDOT grants for a Congressional Directed Spending request for Battery storage and electric bus charging infrastructure. Also, prioritization of LONO funding, Bus & bus facility funding, ferry service capital investment, and other federal funding for transit.
  - PSTA's Heather Sobush and Whit Blanton of Forward Pinellas will be presenting a statewide webinar Monday, November 14, at the request of the FDOT on best practices in MPO and Transit Agency Coordination, particularly as it relates to the Transit Asset Management Plan and Public Transportation Safety Management Plan. It is a recognition of best practice in Florida for the high level of coordination between Forward Pinellas and PSTA.
- TBARTA Report
  - Commissioner Janet Long reported that TBARTA is becoming insolvent due to a lack of state funds and withdrawal of contributions from member jurisdictions and will

request the legislature repeal the agency. A plan to discontinue operations will be presented at the January board meeting.

- She said a representative from CSX attended TBARTA's November board meeting to share information about their plans in Tampa Bay. It was suggested the MPOs carry the discussion forward.
- She discussed the US 19 Regional BRT project that will now be transitioned to the MPOs and transit agencies.
- Work is complete on the Pinellas Aerial Gondola Feasibility Study. Clearwater City Council will discuss in the coming months whether to advance a project or not.
- Demand for the vanpool program, Commute Tampa Bay, continues to grow. There were 194 vanpools in October, an all-time high.
- The Gulf Coast Safe Streets Summit Vision Zero Hero Award was given to Mike Riordon at the summit on November 3<sup>rd</sup>.
- The Board recognized veterans in attendance for their service in celebration of Veterans Day: Councilmember Bonnie Noble, Mike Riordon, Rodney Chatman, and Robert Feigel.
- Outgoing Board Members Mayor Cookie Kennedy, Commissioner Cliff Merz, and Councilmember Bonnie Noble will be recognized at the Forward Pinellas Workshop in December.
- The Executive Director commended Commissioner Karen Seel for recently receiving the prestigious Outstanding Elected Official Leadership award from the Association of Metropolitan Planning Organizations (MPOs).


