#### 4B. Gulf Coast Safe Streets Summit Awards



#### **SUMMARY**

Each year, one of the members of the Sun Coast Transportation Planning Alliance hosts the Gulf Coast Safe Streets Summit. As a part of that Summit, each member awards someone from their community with either a "Vision Zero Hero" or a "Bob the Builder" award. These awards are intended to recognize the outstanding contribution of our community members in helping to advance improvements to safety in their community and throughout the region.

This year, Forward Pinellas is the host agency for the Gulf Coast Safe Streets Summit. Agency staff is recommending that the members of our community listed below be recognized. These community leaders will be attending the board meeting to formally accept their awards and will also be recognized during a virtual ceremony at the Summit itself. A brief description of each individual, along with the rationale behind their nomination, is listed below.

**Ms. Veatrice Farrell** is the Executive Director of the Deuces Live, Inc., a nonprofit organization dedicated to promoting positive growth and financial revitalization to the 22<sup>nd</sup> Street South corridor in the City of St. Petersburg. The 22<sup>nd</sup> Street South corridor, affectionately known as "The Deuces," operates as the heart of a historically and culturally rich African-American community on the south side of St. Petersburg. The mission of Deuces Live, Inc., is to utilize positive land use transformation and financial opportunities to restore the 22<sup>nd</sup> Street South corridor to its previous vibrancy. Ms. Farrell provides strategic planning and innovative leadership in her role with Deuces Live to encourage roadway safety through partnership on the 22<sup>nd</sup> Street South Complete Streets project. Forward Pinellas in its 2020 Complete Streets program provided the City of St. Petersburg with a \$1 million grant in support for the City's work to develop 22nd Street South into a more livable, safer, and welcoming street. Ms. Farrell has provided support and advocacy for the entire Deuces Live area and specifically, dedication to improve safety within the 22<sup>nd</sup> Street South corridor.

Ms. Heather Richardson is on the Board of Directors, and is the leading artist, at the Safety Harbor Art and Music Center (SHAMC). The SHAMC is a nonprofit organization whose mission is to promote knowledge of and education in the fine arts, the visual arts, and the performing arts. Ms. Richardson with SHAMC has been integral to several recent Safe Streets Pinellas initiatives. Specifically, she has provided creative ideas, supplies, a venue, and leadership on community-based public art experiences that connect people through tangible experiences with art and shared roadway responsibility. These events include the 2020 and 2021 Bike Your City events held in Safety Harbor and on the Pinellas Trail respectively, as well as a recent Pop-up Demonstration Art project in Largo. Ms. Richardson has graciously provided her time and knowledge to help connect people through art and bring about awareness to the Safe Streets Pinellas campaign. Through the support of Ms. Richardson and the SHAMC, Forward Pinellas has engaged thousands of people on our Safe Streets Pinellas mission.

## Board Meeting Minutes September 8, 2021

#### THE PLANNING COUNCIL AND METROPOLITAN PLANNING ORGANIZATION FOR PINELLAS COUNTY

The Forward Pinellas Board held this public meeting in person on September 8, 2021 at the Pinellas County Cooperative Extension. The meeting was called to order at 1:03 p.m. by Councilmember Darden Rice, Forward Pinellas Chair.

### The board unanimously approved amendments to the Transportation Improvement Program (TIP)

The board approved amendments including the reconciliation of projects included in year one (2021/22) of the TIP with projects in year one (2021/22) of the FDOT work program; the addition of a southbound left-turn lane on US 19 at the intersection of Gandy Blvd.; and the acceptance of a \$4.6 million federal grant awarded to Pinellas County from the U.S. Department of Transportation (DOT) for a "Connected Community" project to expand connected vehicle roadside units along US 19 and SR 60 along with predictive analytics for incident and congestion risk predictions. These new innovative technologies will measure and manage congestion, and help to create a safer roadway.

- Commissioner Merz clarified that these amendments would not affect any current priorities or projects in the TIP.
- Commissioner Eggers clarified with Pinellas County staff that the innovative technologies include software and roadside units located throughout the SR 60 corridor and on US 19 through the Largo and north county area to manage the traffic system more efficiently.

## The board approved three amendments to the Countywide Plan Map

- The board recommended approval of three amendments:
  - An amendment from Pinellas County to amend the property at 20<sup>th</sup> Terrace SW from Residential Low Medium to Residential High to allow for single-family attached residential subdivision. (10-0)
  - O An amendment from Pinellas County to amend the property at 8119 46<sup>th</sup> Avenue North from Residential Low Medium to Retail & Services to allow for the development of a pool contractor office and warehouse. (10-0)
  - An amendment from Pinellas County to amend the property at 1201 Gooden Crossing from Retail & Services to Residential Low Medium to allow for the development of three single-family detached homes. (10-0)

#### **SPOTlight Updates**

- The expansion of the entrance to Honeymoon Island State Park is expected to be completed by March 2022. In addition, Forward Pinellas and partners are developing design concepts to improve safety and manage congestion at Alt. US 19 and Curlew Road, and along Causeway Boulevard.
- Forward Pinellas is working with FDOT and the City of Clearwater to discuss design options and questions about the Drew Street Concept Plan, and will hold public meetings as the design phase begins, with a focus on safety issues brought forward by residents.
- Forward Pinellas is beginning a safety study on Gulf Boulevard with the City of St. Pete Beach to identify speed management solutions, improve safety at roadway crossings and encourage people to travel in a safe manner. The study is scheduled to be completed in late 2022.
- Forward Pinellas will conduct a "before and after" safety study analyzing traffic behavior
  associated with the rectangular rapid flashing beacon at the crossing of the Duke Energy Trail at
  Sunset Point Road in Clearwater. The analysis will address the effects of modifications to the
  crossing.

- Forward Pinellas staff launched the Gateway Master Plan Dashboard to track progress on the implementation of the Gateway Master Plan. View the dashboard here: www.GatewayMasterPlan.org
- The Downtown St. Pete Mobility Study will be holding community outreach events in October to get feedback on recommended strategies and scenarios. Staff will present an action plan and recommendations to the City Council and the Forward Pinellas board in coming months.

#### **Updates**

- As a result of the Legislative Committee workshop on August 11, 2021, entitled Finding
  Common Ground: A Conversation with State Legislators, a number of legislators have pledged
  to work more closely with Pinellas local governments during the 2022 legislative session
  especially on four key topics: How do we keep our streets safe, fund our transportation system,
  make housing more affordable, and adapt to a changing climate.
- In January 2021, a team of reviewers from the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) conducted a certification review of Forward Pinellas' plans and programs. They found four noteworthy practices, including outreach flexibility using virtual and hybrid public involvement; complete streets grant funding; Long Range Transportation Plan 2045 Advantage Pinellas; and the 2020 Excellence in Regional Transportation Award for the LRTP. They recommended staff review the Public Participation Plan and conduct an Equity Assessment, which are both currently underway. There was one corrective action identified, and that action was remedied by Forward Pinellas shortly after the site visit and before the final Certification Report was completed.
- FDOT is updating the Strategic Intermodal System (SIS) Policy Plan, Florida's high priority network of transportation facilities which are vital to moving people and freight, linking Florida's regions, and investing in strategic transportation facilities. Mr. Blanton, Chair Rice, and Commissioner Eggers expressed their hope for more flexibility in SIS funding especially related to transit operations and parallel, arterial roads that could relieve traffic stress on SIS corridors. FDOT staff will provide specific details and recommended changes in 2022.

- Partially funded through Forward Pinellas' Complete Streets Grant, the City of Clearwater developed a Complete Streets Concept Plan for the Fort Harrison Avenue corridor from Belleair Road to Myrtle Avenue/Alt. 19, connecting three major destinations, Morton Plant Hospital Campus, Downtown, and the North Marina Area. After two walking audits and several public meetings, the visioning team identified improvements that improve multimodal connections, create a gateway, encourage economic vitality, and attract investment and development. The City of Clearwater plans to complete the design of the northern section and construct the demonstration projects by Fall 2022.
  - Mr. Blanton reinforced that complete streets projects focus on adapting a roadway to make it safe and accessible for all users within the context of the roadway, and eliminating travel lanes is only one tool in the toolbox. Staff will be working to provide

- consistent communication about complete streets as well as analyzing projects before and after a complete streets conversion to ensure we're improving areas strategically.
- O City of Clearwater Planning Director Lauren Matzke supported additional traffic analyses to ensure improved roadway functions in daily and emergency conditions.
- Commissioner Albritton stated that every street has a different personality and the location of the Fort Harrison Complete Streets Concept Plan was ideal. In addition, demonstration projects allowed the City of Clearwater to test and refine possible solutions before significant investment and construction.
- In response to the many benefits of micromobility devices and share programs, the vastly growing popularity, and the regulatory challenges, Forward Pinellas Principal Planner Angela Ryan has developed a new Knowledge Exchange Series module devoted to micromobility, or small, lightweight transportation devices, such as electric bicycles, electric scooters, and electric skateboards. The goal of this research is to provide a proactive and collaborative approach to providing a regulatory framework for micromobility in Pinellas County.   - With the increase of micromobility on our trails, Commissioner Eggers requested we manage safety concerns through continued analysis and education.
  - O Angela Ryan noted that Forward Pinellas is currently conducting a speed study on the Pinellas Trail confirming people using micromobility on trails are staying under 20mph. However, the increased usage on the trails since March 2020, along with some users not following trail rules, is leading to a negative perception. Mrs. Ryan highlighted Pinellas County's upcoming trail courtesy campaign that will help educate trail users about being respectful and sharing the trails.
  - O Mr. Blanton agreed that education and communication can go a long way and suggested trail rangers help spread the message of safety and sharing the trail. Mr. Blanton noted with the unprecedented trail usage due to the pandemic, we must be mindful to manage a spectrum of different users on the trails.

#### **Other Items**

- PSTA, in partnership with Forward Pinellas, held virtual outreach for the Transit-Oriented
  Development pilot project entitled SunRunner Rising, studying how people could get to and
  from the SunRunner transit stations. PSTA is also celebrating their 1M Flamingo Fares
  passenger this week. Learn more about Flamingo Fares here: <a href="https://flamingofares.com/">https://flamingofares.com/</a>
- TBARTA approved a scope of work to advance regional public transportation through a study for regional rapid transit on US 19 between SR 54 in Pasco County and the Gateway area in Pinellas County.
- Mr. Blanton is drafting a letter to the Florida Legislature dissuading the restriction of -mid-block crossings and rapid rectangular flashing beacons due to the damaging impacts this would have on safety and equity throughout Pinellas County.
- PSTA is currently requesting funding from partners and local governments to resume regular operations of the Clearwater Ferry. In the future, PSTA will also request funding for the

- expansion of ferry services. In addition, the Cross Bay Ferry interlocal agreement is currently moving forward.
- Forward Pinellas is seeking an elected official to chair the Transportation Disadvantaged Local Coordinating Board. Thank you Commissioner Michael Smith for your service.
- We are delighted to welcome Alex Burns aboard our team as an Intern through our partnership with the Masters of Urban and Regional Planning Program at the University of South Florida.

## 6A. Proposed Amendment to the FY 2021/22-2025/26 TIP

#### **SUMMARY**

The Florida Department of Transportation (FDOT) is requesting that Forward Pinellas, in its role as the metropolitan planning organization, approve three amendments to the Transportation Improvement Program (TIP). These projects include lane continuity and express lane improvements along I-275/SR 93 from N of 54th Ave S to N of 4th St, otherwise referred to as Section 2 of the Tampa Bay Next program. These projects were previously included in the TIP, but were removed due to projected budgetary impacts related to the COVID-19 pandemic.

The TIP amendments for 424501-7 and 449109-2 involve federal funds, which require not only a TIP amendment with Forward Pinellas' current TIP, but also with the State TIP (STIP). For project 449109-1 from 54th Ave N to N of 4th St N, state funds are being used for the design work, which does not require a TIP/STIP amendment; however, for federal consistency purposes, Forward Pinellas staff is recommending amending this project into the MPO's TIP during this amendment process. These amendments will not affect any other projects in the TIP.

**Amendment # 1 – FPN 424501-7**, I-275/SR 93 from N of 54th Ave S to I-375: \$5,601,000 is being added to the TIP to design lane continuity improvements and noise walls along the corridor.

**Amendment # 2 – FPN 449109-2**, I-275 (SR 93) from N of I-375 to 54th Ave N; \$4,701,000 is being added to the TIP to design lane continuity improvements and 2 express lanes in each direction along the corridor.

**Amendment # 3 – FPN 449109-1**, from 54th Ave N to N of 4th St N: \$5,601,000 is being added to the TIP to design an additional express lane along the project corridor in each direction. One express lane in each direction is already under construction as a part of the Gateway Expressway project.

# 7C. Approval of Scope of Services for the Target Employment and Industrial Land Study Update

## **SUMMARY**

Due to the lack of vacant greenfield land in Pinellas County, market forces have made the development of residential and commercial property more lucrative to the landowner/developer than industrial development, creating pressure to convert industrial parcels to other uses. At the same time, there is not enough developable industrial land to accommodate many target employers who wish to move into the county.

In response to those conditions, the Pinellas Planning Council initiated the Target Employment and Industrial Land Study in 2008 to develop a series of objectives and strategies, including enacting land use policies that preserve property that can be used for target employment needs. Aviation/aerospace, financial services, high tech industries, information technology, marine science, medical technology, microelectronics, modeling/simulation, optics/photonics, research/development, and wireless technology companies are examples of target employers that the current Countywide Plan policies attempt to attract and retain. These policies were subsequently adopted into the Countywide Plan and have reinforced Pinellas County's economic and redevelopment strategy.

The policies that preserve land for high-wage primary employment opportunities have been in place for over 11 years. Over that period, changes in technology and logistics, workforce development needs, business operating characteristics, regulatory policy pre-emption by the State of Florida (e.g., HB 1339), and other factors have compelled Forward Pinellas to commission a new study. This effort seeks to accomplish several objectives, including an examination of the effectiveness of the target employment preservation policies, an assessment of the needs and criteria for the establishment and expansion of target employment clusters, and a determination if new policy tools should be enacted. Simply put, this study will ascertain whether the current supply of land that could accommodate target employment in the county is sufficient to fulfill the needs of existing and potential target employers over the next 20 years, and identify the most effective strategies to achieve that goal.

## TARGET EMPLOYMENT AND INDUSTRIAL LAND STUDY UPDATE SCOPE OF SERVICES

#### INTRODUCTION

A major focus of the Countywide Plan for Pinellas County is the retention and attraction of companies providing high-wage primary employment opportunities, known as target employers. Target employers are vital to the economic health of Pinellas County because these businesses and industries produce goods or services for statewide, national or international markets. The goods and/or services are exported to consumers outside of the region, resulting in a stream of new dollars coming into the local economy and ultimately a distribution of wealth occurs through wages paid to employees, a stronger supply chain, and increases in local government tax revenues.

Businesses providing these types of jobs include those that typically locate on land classified for industrial use, even though few of those types of uses create the negative impacts associated with traditional heavy industrial uses. These are the so-called "clean" industries desired by communities throughout the nation. Previous studies conducted by Forward Pinellas and Pinellas County Economic Development have identified a clear need to retain industrially-designated land for both the expansion of existing firms and for the location/relocation of firms coming to the county. Conversely, not all target employers need to be located on land designated for industrial use and not all industrially-designated land is viable for these types of firms. Dramatic changes in technology, product and service delivery, automation, digitization, etc. have enabled some of these businesses to thrive in a variety of areas and districts.

Due to the lack of vacant greenfield land in Pinellas County, market forces have made the development of residential and commercial property more lucrative to the landowner/developer than industrial development, creating pressure to convert industrial parcels to other uses. At the same time, there is not enough developable industrial land to accommodate many target employers who wish to move into the county. In response, the Target Employment and Industrial Land Study was commissioned in 2008 to develop a series of strategies, including enacting land use policies that preserve property that can be used for target employment needs. Criteria and policies that restrict the conversion of such land to other uses were subsequently adopted into Section 6.5.4.4 of the Countywide Rules and Land Use Goal 9.0 of the Countywide Plan Strategies. These provisions have reinforced Pinellas County's economic and redevelopment strategy for well over a decade.

Following the 2020 legislative session, Governor DeSantis approved House Bill 1339 (Section 125.01055, Florida Statutes), a bill addressing several provisions including affordable housing. Among other provisions, the new law allows the governing body of a county or municipality to approve an affordable housing development on any parcel designated for residential, commercial, or industrial use. This preemption conflicts with Countywide Plan policies prohibiting residential uses in the Employment and Industrial categories. Furthermore, Pinellas County recently established the Penny for Pinellas Affordable Housing Program and Employment Sites Program. These two programs provide up to \$80 million in grant funding over the next decade for land acquisition or capital projects associated with the development, construction, and major

rehabilitation of local workforce housing units or assistance in the construction and redevelopment of industrial (manufacturing & flex) and office buildings to facilitate a robust local economy that provides growth opportunities for existing businesses and attracts new target industry employers to Pinellas County.

These factors have compelled Forward Pinellas to reassess the locational needs of target employment industries in Pinellas County and the existing policy framework in the Countywide Plan which preserves land for high-wage jobs.

#### PROJECT DESCRIPTION

Forward Pinellas seeks a Consultant to gather and analyze information that will assist in an assessment of strategies that are effective in retaining and attracting high-wage primary businesses. This effort will include recommendations addressing both those business assistance techniques and regulatory policies necessary to accurately reflect the changing needs of target employers and achieves the objectives of the Countywide Plan.

The project has two main objectives. The first is to identify the needs for industrially-designated land by target employers, including but not limited to those identified in the Countywide Plan. Industrially-designated land includes properties designated Employment or Industrial on the Countywide Plan Map, areas designated with the Target Employment Center overlay, and/or equivalent designations on locally adopted future land use maps. The survey will also generate information about the appropriateness of the size, location, amount, and development readiness of existing sites suitable for business/industrial uses, including an assessment of what constitutes target employment land viability, e.g., whether the land is suitable for development or is constrained by characteristics that limit its use for industrial purposes.

The second objective is composed of two parts. Part a) will identify potential actions that may be employed to support and incentivize the location and/or retention of target employers and to ensure that regulatory provisions do not hamper their locating and/or expanding in Pinellas County. Part b) will evaluate the existing Countywide Plan criteria related to the retention of industrially-designated land and its conversion to other designations.

#### **SCOPE OUTLINE**

## TASK 1 - KICK-OFF MEETING, PROJECT MANAGEMENT, AND LITERATURE REVIEW

The Consultant shall coordinate all project activities with the Forward Pinellas project manager and provide management of all project tasks. The project shall begin with a kick-off meeting followed by a literature review of the following planning and policy documents. Forward Pinellas staff will provide copies of the planning and policy documents list below.

- Target Employment and Workforce Housing Best Practices and Case Studies Research

Summary report of the literature review.

#### TASK 2 - TARGET EMPLOYERS NEEDS ASSESSMENT

The Consultant shall survey existing and desired target employers regarding their use of, and need for, industrially-designated land. Target employers include, but are not necessarily limited to, those identified in the Countywide Plan: aviation/aerospace, financial services, high tech industries, information technology, marine science, medical technology, microelectronics, modeling/simulation, optics/photonics, research/development, and wireless technology. This task shall also use relevant data sources such as the National Association for Industrial and Office Parks (NAIOP), to determine the most viable existing and potential target employment uses for Pinellas County. Staff from Pinellas County Economic Development will provide input on the target number of survey respondents, methodology used to determine the viability of specific target employment uses and the survey process, identification of target employers, etc. A parallel assessment of existing target employers using Geographic Information Systems (GIS) datasets shall also be conducted to supplement the above-referenced survey information.

The target employers survey will answer the following questions:

- 1) In what plan categories are the current target industries located?
- 2) What are their characteristics? (i.e., proximity to transportation facilities, building size, average wage, etc.)
- 3) What are the land-based needs of the target employers identified in the Countywide Plan, including needs for supportive or complementary uses such as residential and retail, and access to multimodal transportation (e.g., bus, pedestrian, bicycle)?
- 4) How much land, of what type, and in what locations, do we need over the next 20 years to accommodate our target employers?

### This task is intended to:

- Determine the common/typical characteristics of the target employers, e.g., size, location, access, relationship to like uses, plan categories, etc.
- Determine the needs and criteria for the establishment and growth of target employment clusters.

• Determine whether the current supply of target employment parcels in the county is sufficient to fulfill the needs of existing and potential target employers over the next 20 years concerning land area, location, and proximity to desired supportive uses.

#### Deliverables:

The Consultant shall prepare a report summarizing the results of the survey and GIS
analysis to include the identification of characteristics and needs of target employers and
prioritization of recommended actions required to fulfill those needs. Actions may include
measures such as land assembly, infrastructure improvements, area-wide development
plans, providing for a mix of land uses, regulatory incentives, etc.

### TASK 3 - PRESERVATION CRITERIA ASSESSMENT

The Consultant shall conduct a technical assessment of the effectiveness of the current regulatory framework that was adopted following the completion of the Target Employment and Industrial Land Study in 2008. This assessment will include, at a minimum, a comparative analysis of the land available for target employment uses (e.g., industrially-designated land as defined above), number of primary employers, square footage of new construction and expansion, average wages, etc. for each year between 2008 and 2021. The Consultant shall then use this information to identify criteria related to the preservation of industrially-designated land and its conversion to other designations.

#### This task is intended to:

- Determine how much land has been absorbed by target industries since 2008.
- Determine how much land has been converted from other categories to industriallydesignated land and vice-versa.
- Determine whether the existing policies that seek to preserve land for target employment uses have been successful in maintaining or expanding the number of target employers in Pinellas County.
- Determine criteria by which to gauge the viability of land for target employers.
- Determine which lands, if any, should be recategorized to better reflect these criteria, and to what alternative plan category.
- Determine whether new plan categories or types of uses should be created or modified to accommodate the needs of target employers.
- Determine the characteristics of "prime" industrial land which should be protected from conversion to non-industrial uses for a variety of reasons such as size, location, and infrastructure investment.
- Determine common constraints or impediments to the use of industrially-designated lands.

- Determine whether industrial designations have been appropriately applied to sites.
- Determine whether there are sites that are not currently industrially-designated that should be so designated.
- Determine whether target employers are currently located on appropriately designated sites, including those supportive of the Advantage Pinellas corridor investment strategy.
- Determine whether the industrial designations contained in the Countywide Rules are the appropriate designations for target employers.
- Determine a methodology and develop a summary that classifies or groups industriallydesignated lands into categories based on their viability for target employment.

#### Deliverables:

The Consultant shall prepare a report summarizing the results of this assessment.

#### TASK 4 – COUNTYWIDE RULES AMENDMENTS RECOMMENDATIONS

The Consultant shall identify a series of recommendations that would result in amendments to the Countywide Rules review criteria when an application for conversion of industrially-designated land is made. Recommendations should address criteria in support of conversion as well as those to be employed when a conversion of land to another category would have negative impacts on the ability of the county to provide viable properties for employment.

#### This task is intended to:

- Determine the appropriate criteria to be applied to applications for the conversion of industrially-designated land and criteria to permit target industry uses in other categories for clean industries; e.g.:
  - Criteria for evaluating whether a proposed land use qualifies as target employment.
  - Methodology for estimating the target employment capacity of an industriallydesignated parcel, based on typical land use patterns and jobs per acre for similar developments.
  - Criteria for allowing industrially-designated parcels to transition to higher-intensity mixed use developments with "no net loss" of target employment capacity.
  - Allow conversion of marginal industrial land (e.g., small sites without good access or infrastructure, sites adjacent to or near residential uses, older multi-story buildings, etc.) unless nearby viable industries would be impacted by encroachment.

- o Infrastructure desired or required by target employers (e.g., access to high-speed broadband service, etc.).
- Determine the feasibility of establishing "industrial sanctuaries" where non-industrial uses
  are restricted. Industrial sanctuaries are a management tool for protecting prime industrial
  land at the industrial district level by limiting uses to those which would not interfere with
  the development of the site for industrial uses and/or by preventing or restricting
  incompatible uses on adjacent or nearby lands.
- Determine the characteristics of other "necessary" industrial lands that should be protected from conversion to other uses such as those needed for heavy automotive repair, and like uses, which have been historically located in areas classified as industrial because of their impacts (noise, dust, light, odor, etc.). While these are not target industries, these uses, are also considered valuable and necessary to Pinellas County's economic system.
- Identify potential actions that may be employed to support the retention of other necessary industrial lands and to ensure that regulatory provisions do not hamper their location and/or expansion in Pinellas County.
- Identify potential actions to prioritize the location of target employers relative to the Advantage Pinellas corridor investment strategy.

#### Deliverables:

• The Consultant shall prepare a report summarizing whether the industrially-designated lands on the Countywide Plan Map are appropriate; and whether the Countywide Rules for industrial designations are the appropriate ones for business enterprises we seek. A comprehensive list of recommended amendments to the Countywide Rules to better preserve and enhance land for target employment should also be included in this deliverable.

#### TASK 5 – STAKEHOLDER INVOLVEMENT PLAN

The Consultant shall work with the staff of Forward Pinellas and Pinellas County Economic Development to develop a Stakeholder Involvement Plan. This plan should be developed following the kick-off meeting and include the identification of relevant stakeholders (e.g., Economic Development Council, Planners Advisory Committee, Gateway Partnership, focus group, etc.), meeting/workshop schedule at key milestones, software platform needs, etc. The objective of this plan is to ensure that the appropriate representatives from the public and private sectors are aware of this project, can easily provide input, and shape the report's recommendations.

#### TASK 6 – DOCUMENTATION AND MEETINGS

Technical findings from Tasks 1 through 5 shall be documented in a narrative report for Forward Pinellas and Pinellas County Economic Development staff review. Given the nature of this project, it is recommended that the project documentation also include a series of infographics to summarize the findings in a clear, concise, and public-friendly manner. All project files shall be provided to Forward Pinellas in an approved format.

The Consultant shall hold bi-weekly meetings with the Forward Pinellas project manager to ensure that the project schedule is maintained and concerns are addressed promptly. The Consultant shall also give a number of presentations throughout the course of the project to various stakeholder groups (e.g., Pinellas County Economic Development Council, Planners Advisory Committee, Forward Pinellas Board, Board of County Commissioners, chambers of commerce, etc.) consistent with Task 5 - Stakeholder Involvement Plan.

# 7D. Private Sector Perspectives – Transit and Jobs Access Study

#### SUMMARY

Earlier this year, the Forward Pinellas Executive Committee recommended that the board periodically hear from leaders in the private sector on issues facing Pinellas County and the Tampa Bay region. The "Private Sector Perspectives" topic will highlight key issues relating to land development, transportation and infrastructure, affordable housing, workforce development, and similar topics within the scope of Forward Pinellas. Designed to stimulate discussion and potential future activities, the October board meeting will feature the inaugural perspectives topic, with subsequent presentations occurring roughly once per quarter.

The Tampa Bay Partnership, a coalition of regional business leaders joined by a shared commitment to improving the personal and economic well-being of Tampa Bay residents, commissioned a study to understand how different transit investment scenarios improve accessibility of jobs for Tampa Bay residents. While not a specific component of federal or state grant funding, the Partnership believes that job access should be a consideration alongside ridership and cost-effectiveness as agencies contemplate the funding of transit investments. Dave Sobush, the Partnership's Director of Policy and Research, will present the study findings and conclusions.

## 7E. Alt US 19/5th Avenue North Lane Repurposing



#### **SUMMARY**

In 2019, the Florida Department of Transportation District 7 identified Alt US 19/5<sup>th</sup> Ave N as a priority corridor for speed management and completed a Speed Management Study. The study recommended exploringa lane repurposing from west of 16<sup>th</sup> St N to Dr MLK Jr St N to add a two-way separated bicycle facility. The facility would connect the existing network of separated bicycle lanes on Dr MLK Jr St N to a potential future rail-trail shared use path west of 16<sup>th</sup> St N.

The Department of Transportation is asking for a letter of support from Forward Pinellas to show local and countywide support as part of the evaluation performed by the Central Office in Tallahassee. FDOT District 7 will present the background and purpose for the project, an initial concept plan, and preliminary traffic information for the board's input and recommendation.

## 7F. Establishment of Nominating Committee



#### **SUMMARY**

The Forward Pinellas Executive Committee is comprised of board officers that include the chair, vice chair, treasurer and secretary. Each officer serves for a one-year term. As prescribed in its Operating Procedures, each year the Forward Pinellas Board must decide the manner in which it wishes to elect its officers for the following year. The board has the option of directly electing its officers from the entire board membership or convening a Nominating Committee.

If a Nominating Committee is preferred, the board shall establish the committee at a regular meeting. The Nominating Committee will then meet and recommend a slate of officers for approval by the full board. With a Nominating Committee, any board member may still express their interest in serving as an officer, or may recommend other members for an officer position before the Nominating Committee makes its official recommendations.

Due the cancellation of the December Forward Pinellas meeting, the process for the election of officers for 2022 will be handled in November.

The term of membership for members' appointments to the board are subject to local elections and/or reappointments. A list of members eligible to hold office is attached. The newly established Executive Committee members shall take office in January.

#### 8B. Forward Pinellas Legislative Committee Update



#### **SUMMARY**

The Legislative Committee resumed meeting last month to begin its work for the upcoming session. Based on the preparation for and dialogue at our Legislative Workshop on August 11<sup>th</sup>, Forward Pinellas staff have drafted the attached legislative priorities for consideration around the following major concepts:

- More flexible transportation funding programs for large urban areas
- A targeted and collaborative approach to safety
- Keeping communities strong and independent while working to solve bigger challenges, such as affordable housing, together
- Ensure Florida's resilient future

The executive director and/or the committee chair will brief the board on the committee's discussions and seek direction on any desired policy positions, as may be needed.

In addition, the executive director drafted a letter to the Legislative Delegation to safeguard local decision-making for mid-block crossings and the use of Rectangular Rapid Flashing Beacons (RRFBs). The Sun Coast Transportation Planning Alliance approved the letter for signature by Chair Kimberly Overman and distribution to the legislative members across the region and to the chairs of key committees.

#### **Draft Policy Positions – 2022**

#### FIND FLEXIBLE SOLUTIONS TO FUND TRANSPORTATION NEEDS IN OUR COMMUNITY.

- Taxes on fuel are a primary source of transportation funding for local governments. Increasing
  fuel efficiency, more electric vehicles in the fleet, and rising roadway maintenance and operating
  costs are placing pressure on local governments to search for additional funding. Forward
  Pinellas supports the creation of a statewide pilot program to tax automobiles based on
  vehicle miles traveled (VMT), ensuring sufficient roadway funding while charging users fairly.
- Local fuel taxes are not indexed to the Consumer Price Index to account for inflation, as state fuel taxes are, and therefore, revenues are declining at a faster rate. Forward Pinellas supports the Legislature permitting the indexing of local fuel taxes for inflation to better keep pace with transportation needs like it has done for state fuel tax revenues.
- The Strategic Intermodal System (SIS) receives the vast majority of state transportation funding. As our highway network continues to mature in urban areas like Pinellas County, and reaches a point where expansion is not a feasible or affordable option, Forward Pinellas supports increased flexibility for SIS funds for improvements to parallel non-SIS roadways, and allowing premium or express transit operating on the SIS roadway, but not necessarily on its own fixed guideway, to enhance mobility on the SIS. This is consistentwith the legislative position of the Florida Metropolitan Planning Organization Advisory Council.
- The Transportation Regional Incentive Program (TRIP) is a valuable transportation funding
  mechanism based on 50/50 state and local participation through regional collaboration.
   Forward Pinellas believes in fostering stronger regional transportation planning and decisionmaking and supports sustained funding of \$250 million per year for the TRIP program as a way
  to strengthen regional partnerships to improve mobility.
- Increasing flexibility of funds in urban areas enables MPOs and transit agencies to collaborate on priorities and direct resources to projects where they are most needed. In contrast, the use of legislative earmarks merely reallocates funding from existing priorities, reducing funding for needed local transit projects. Forward Pinellas supports the Tampa Bay Transportation
   Management Area position calling for increased flexibility for state transportation funding programs in urban areas while discouraging the use of earmarks.

#### ENSURE A TARGETED, FOCUSED AND COLLABORATIVE APPROACH TOWARD SAFETY.

- Distracted driving poses a threat to the safety of motorists and non-motorized users. Between 2015 and 2019, 42 fatalities and 480 incapacitating injuries happened in Pinellas County related to distracted driving crashes (Crash Data Management System). Forward Pinellas supports legislation that expands upon the adopted Texting While Driving law by prohibiting distracted driving by addressing the use of wireless communications devices with clear definitions and clarification on what it means to be stationary and operating.
- Rectangular rapid flashing beacons (RRFBs) at pedestrian crossings have proven effective at reducing injuries and fatalities for vulnerable road users. Studies by the National Academies of Science and the Federal Highway Administration show that RRFBs increase driver yielding rates between 73-96% and reduce pedestrian collisions by 47%. Forward Pinellas supports continued

#### local authority over the use of RRFBs.

• Safe Streets Pinellas is a collaborative effort to create a transportation system that is safe for everyone. On average, two people are killed or seriously injured each day in Pinellas County (Crash Data Management System). Forward Pinellas created Safe Streets Pinellas, a sustained effort of education, research and transportation facility improvements, based on the vision that not one person should be killed or seriously injured using our roadways. Forward Pinellas supports state funding to address high injury corridors, conduct demonstration projects, and educate the public to ensure that Pinellas County streets are safe.

#### KEEP OUR COMMUNITIES STRONG AND INDEPENDENT, WHILE WORKING TO SOLVE BIGGER CHALLENGES TOGETHER.

- Florida is a diverse state characterized by unique communities. Pinellas County is an example of
  that with its many downtowns, beach communities and neighborhoods. Home rule allows local
  governments to align the values of a community to its ordinances and other governing elements.
   Forward Pinellas supports home rule and opposes bills that erode the ability of local
  governments to reflect the wishes and desires of their communities.
- In 2011, the Florida Legislature passed legislation curtailing the ability of local governments to
  regulate vacation rentals, defined as residences that are rented out to visitors on a short-term
  basis. Preemption of this local authority impairs the ability of communities to determine their
  own character and protect neighboring homes from the impacts of incompatible tourist-related
  uses. Forward Pinellas supports the restoration of local authority to regulate vacation rentals.
- Building design is essential to community character. Particularly for mature communities such as
  those in Pinellas County, where neighborhoods are established and new development is
  primarily infill and redevelopment, design standards ensure that new residential structures fit in
  aesthetically and functionally, without disrupting quality of life for existing residents. Forward
  Pinellas supports local authority to regulate community character through building design.
- Trust funds such as the Sadowski Housing Trust Fund and the State Transportation Trust Fund
  are established with a clear purpose. These trust funds should be protected and not subject to
  transfers to the Budget Stabilization Fund and the General Revenue Fund. Forward Pinellas
  supports protecting funding intended for affordable housing and other specific purposes from
  being transferred to other sources.
- State-mandated changes to metropolitan planning organizations (MPOs) are a recurring concern
  to Forward Pinellas and other MPOs statewide. Forward Pinellas opposes one-size-fits all
  changes that would usurp local authority to determine the most appropriate structure of
  MPOs consistent with federal law and consultation with the Governor.

#### ENHANCE RESILIENCE TO GUARANTEE THE SAFETY AND PROSPERITY OF OUR COMMUNITIES AND MAINTAIN OUR QUALITY OF LIFE.

• The Resilient Tampa Bay Transportation Study, of which Forward Pinellas was a partner along with other MPOs and regional agencies, found that 19% of the Tampa Bay region's roadways are highly or moderately vulnerable to storms, sea level rise, and heavy precipitation. The State can take a leadership role by providing funding to harden infrastructure, conduct vulnerability assessments on transportation projects, incentivize resilient development, and support research and mitigation for sea level rise. Forward Pinellas supports state funding assistance to address the impacts of climate change and increase the resiliency of our communities.

**RE: Pedestrian Safety and Mid-Block Crossings Legislation** 

To Whom it May Concern:

During the last two sessions, the Florida Legislature has introduced and advanced bills that purport to be about pedestrian safety by restricting use of certain safe crossing devices at midblock crosswalks. These bills actually run counter to improving pedestrian safety, using a tragic fatality to keep Florida's roadways "dangerous by design" and inaccessible for everyone needing to use a public roadway. Introduced as HB 1113 and SB 1412 in the 2021 Session, they would require certain lighting and location changes to mid-block crosswalks, or state and local governments would be forced to remove the protective flashing beacon devices, thus leaving mid-block crossings unprotected and less safe for users.

Known as Rectangular Rapid Flashing Beacons (RRFBs), the yellow flashing pedestrian crossing devices increase the visibility of people crossing a roadway to make vehicle drivers aware of their legal right and presence at an approved crossing location. The RRFBs are a recommended practice in the Federal Highway Administration's (FHWA) Everyday Counts Safety Program and acknowledged as an effective safety device in the Manual on Uniform Traffic Control Devices (MUTCD). Federal approval to change the lights from yellow to red is extremely unlikely, despite formal requests for pilot treatments. They are recognized by FHWA, the Florida Department of Transportation, the state's MPOs and many local governments as a cost-effective tool in the transportation safety toolbox to help combat Florida's nationally recognized status as the least safe state for people walking or bicycling.

On behalf of our partners in state and local government across the Tampa Bay region, we urge you to consider the following points in your consideration of potential legislation concerning mid-block crossings and RRFBs:















- Since their start in 2004, RRFBs have proven to increase motorist response to people
  using crosswalks from 18% to 88%. Their success starting in Pinellas County has led to
  more than 300 devices located throughout the County on state and local roadways, 170
  in Hillsborough County, and hundreds more in counties large and small across Florida
  and the U.S.
- The unfunded mandate of removing these devices will be an enormous fiscal burden on state and local governments. The human cost will be much greater. Bicycle and pedestrian fatalities on our roadways are rising rapidly, and while no traffic control device is 100% capable of preventing serious injuries and fatalities, RRFBs have a proven safety record of <u>reducing fatalities and crashes by 47 percent</u>. They save lives every day, but that doesn't make the press.
- On Fletcher Avenue, which serves the University of South Florida area, RRFBs at midblock crossings have helped to create a dramatic transformation. Prior to installation, Fletcher Ave. was the highest fatality corridor in Hillsborough County. In 2014, RRFBs and other safety measures were installed. The post-construction study competed in 2019 demonstrated a 46% reduction in serious injuries and 60% reduction in fatalities.
- The FDOT and many local governments in Florida have adopted Vision Zero goals of no traffic deaths on our roadways. The use of RRFBs as approved is one part of the solution involving engineering, education, and enforcement to meet those goals and defined safety targets.
- Restricting these RRFBs and removing mid-block crossings is an equity concern because
  data show that underserved and minority communities bear an outsized burden of fatal
  and serious crashes involving vulnerable road users (people on foot, bicycle or
  motorcycle). In these neighborhoods, residential areas are often separated from
  commercial areas by higher speed multi-lane roads.

The prior legislation has brought greater awareness to the issue of mid-block crossings, RRFBs and pedestrian safety in general. We agree that there should be some restrictions on the location of mid-block crossings with RRFBs based on sound professional engineering. FDOT's Traffic Engineering Manual calls for RRFBs to be limited to roadways with marked, special emphasis crosswalks, four or fewer through lanes (with a refuge island required on five lane facilities with two-way left turn lanes), and a posted speed limit of 35 MPH or less. It is not a simple measure for state or local governments to change the posted speed limit on a roadway without supporting data and analysis that follows specified criteria.

But rather than legislating against a specific safety device that has been proven effective, the Legislature should turn its focus instead to other legal remedies to <u>protect vulnerable road users</u>, fund educational efforts adequately and provide more flexible transportation funding options to regions and communities. Those measures would go a much longer way toward improving safety on our roadways.

#### **CPA Actions August/September 2021:**

The Board of County Commissioners, acting according to its Countywide Planning Authority, held public hearings on August 24, 2021 to consider the following amendments to the Countywide Plan Map and Countywide Rules:






#### **July Monthly Trail Use by Counter Location**





### August 2021 Average Hourly Counter Report










As President and CEO of the St. Petersburg Area Chamber of Commerce, I write to you today to express our desire to have Forward Pinellas include a "capping" alternative at the upcoming Downtown Mobility Study Community Outreach Sessions.

The St. Pete Chamber has great interest in the outcomes from the Study and in ensuring the solutions decided are in the best interest of the community. We recognize the barrier I-175 presents in connecting South St. Pete from our Downtown just as we recognize the spur is an important connection from our waterfront to I-275.

We believe the "capping" option could give us the best of both worlds: it would allow the neighboring areas to connect to downtown, while maintaining the uninterrupted flow that is vital for our downtown hospitals, first responders, and businesses (especially in light of the massive increase in activity expected with the redevelopment of the Tropicana Field site).

With the approach of Fall and the waning days of 2021, the Tampa Hillsborough Expressway Authority (THEA) has many infrastructure projects ahead and underway that will greatly enhance mobility in our region. Please find project and THEA updates that you may wish to share with your constituents:

#### **Upcoming Projects and Public Engagement Opportunities**

THEA currently has three Project Development & Environment (PD&E) Studies underway to look at what, if any, changes should be made to improve THEA-owned transportation facilities. A PD&E study is a required process developed by the Florida Department of Transportation to determine social, economic, natural, and physical environmental impacts associated with a proposed transportation improvement project.

The PD&E process provides the community with opportunities for public input. Below you will find a brief summary of each active PD&E Study as well as the current estimated dates for public input meetings. THEA will send further updates regarding public engagement opportunities as they are confirmed. For more information about THEA's PD&E Studies please visit, www.selmonstudies.com.

- East Selmon PD&E The East Selmon PD&E is a study researching options to reduce congestion on the easternmost part of the Selmon Expressway. Specifically, the East Selmon PD&E is studying a 10-mile the stretch of road from Brorein Street in downtown Tampa to I-75 near Brandon. The first public engagement opportunity is a Virtual Alternatives Meeting slated for March of 2022.
- Whiting PD&E The Whiting PD&E is a study looking for ways to connect Whiting Street to Meridian Avenue to improve the grid network in eastern downtown Tampa, and reconstructing Exit Ramps 6-A and 6-B from the Selmon eastbound lanes to Florida Avenue and Channelside Drive respectively. As part of the Study, THEA is also exploring ways to improve operations and safety for Whiting Street between Jefferson Street and Brush Street, the Jefferson Street entrance ramp, and the downtown Tampa eastbound exit ramps. THEA held a Virtual Alternatives Meeting on May 20<sup>th</sup>, and a public hearing to review the preferred construction alternative is tentatively scheduled February of 2022.
- Nebraska Ave PD&E The primary focus of the Nebraska Ave PD&E is to identify needs, test alternatives, and develop recommendations to alleviate congestion and more efficiently distribute traffic as it enters downtown after exiting the Reversible Express

Lanes (REL). The first public engagement opportunity is a Virtual Alternatives Meeting is tentatively scheduled for March 2022.

#### **THEA Construction Projects**

- Reversible Express Lanes Additional Access and Egress Points During the research phase of the Selmon East PD&E, THEA found that two new slip ramps would be a low-cost option to improve near term service levels for drivers on the Selmon Expressway. Slips ramps are internal ramps within the Expressway, similar to the ingress/egress from the Expressway to the REL. Construction of East Selmon Slip Ramps would allow drivers to enter (ingress to) the REL westbound from the I-75 northbound ramp, which is much earlier than the current US 301 entrance ramp provides; and, then leave (egress from) the REL westbound travel direction back on to the westbound lower lanes near IKEA, vs taking the REL all the way to Twiggs Street. THEA believes the construction of these new REL Slip ramps will help reduce cut-through traffic in downtown Tampa as well as Bayshore Boulevard. *Construction on those two ramps is scheduled to begin in November 2021*.
- South Selmon Capacity Project THEA has concluded both a Virtual Alternatives Meeting and a Public Hearing on the Preferred Alternative for this effort to improve travel times, reduced congestion and improve safety for the portion of the Expressway south of downtown Tampa. An RFP for the preferred alternative design includes two additional lanes (one lane each direction) and noise walls for the full length of the project, all within existing THEA right of way. The project is scheduled to be let in mid-2022, with construction beginning in late 2023.

THEA has been on quite the streak in 2021 with the recently completed Selmon West Extension winning <u>five</u> industry achievement awards and counting! THEA is proud of its innovative Selmon West Extension – a first of its kind 1.9-mile elevated roadway over Gandy Boulevard that is reducing traffic congestion on neighborhood roads while providing quick and reliable trips for drivers on both sides of Tampa Bay.

The SCTPA understands that the Discovery Phase of the project has recently kicked off and we are excited about the opportunity to collaborate.

The launch of the MobilityHUB signals a shift in the traditional ways that transportation data have been siloed within department and agencies. By sharing data and standardizing the analytics we use to evaluate performance, FDOT will seamlessly receive locally derived datasets like pavement condition, transit asset and safety reports, multimodal levels of service, corridor counts, lane closures, and work zone information. At the same time, MPOs will receive data that previously was hosted and maintained across multiple platforms, including bridge condition, crashes, traffic incidents, speed, and several others.

Before FDOT's offer of full-cost sponsorship, our MPOs agreed to be financial partners in this project because it is fundamental to our performance monitoring. The use of performance metrics in planning is not only federally required, but also valuable in improving resource allocation and transparency. The opportunity to share the monitoring data with each other and with FDOT in real time, through this tool, will expand understanding of and collaboration on our region's most pressing challenges.















If expanded to other regions in the future, this tool also has the potential to streamline FDOT's coordination with all of Florida's MPOs on performance monitoring and target setting. Accordingly, while the MobilityHUB has the capacity to support sharing of many kinds of data, we request that the functionalities related to planning-level performance monitoring and target setting be given a top priority.

Close coordination among FDOT, MPOs, and the consultant team will be essential to this project's success. We envision regular meetings, such as on a biweekly basis, to ensure that developmental milestones are being met. We look forward to discussing the project management arrangement with you and the rest of the team.
