#### FORWARD PINELLAS PUBLIC PARTICIPATION PLAN EVALUATION REPORT

#### Summary

The Forward Pinellas Public Participation Plan (PPP) guides the agency's public involvement efforts in its role as the metropolitan planning organization (MPO) for Pinellas County. Pursuant to federal requirements governing MPOs, the plan sets forth the agency's public participation goals and objectives and identifies the tools and strategies that are utilized to engage citizens in its planning process. The goals of the PPP are listed below.

- Comply with the public participation requirements of the Fixing America's Surface Transportation Act (FAST) [23 U.S.C. 134/49 - U.S.C. 5303 (i) (5), (i) (6), and (j)(4); 23 U.S.C. 135/49 U.S.C. 5304 (f)(3) and (g)(3)]; and with Title VI of the Civil Rights Act of 1964, the Limited English Proficiency requirements of Executive Order 13166, and the Americans with Disabilities Act of 1990, as it pertains to the traditionally underserved population.
- 2) Identify public priorities and perspectives regarding transportation issues and topics addressed by Forward Pinellas in its plans, projects and policies.
- 3) Inform and educate citizens on transportation matters related to the Forward Pinellas planning program.
- 4) Maintain active partnerships with civic groups, business organizations, local governments, neighboring MPOs and other local, regional and statewide public agencies in the implementation of the Public Participation Plan.

Implementation of the PPP includes monitoring activities to gauge the effectiveness of the plan in achieving its goals and objectives. This includes the production of an evaluation report following adoption of the Long Range Transportation Plan (LRTP) every five years. The most recent evaluation report was completed in 2015 following the adoption of the 2040 LRTP in the prior year.

This PPP Evaluation Report focuses on the agency's public involvement activity from 2017 to 2019. In terms of public outreach, 2016 was a transitional year for the agency so it is not included in the time period considered in this evaluation. In that transitional year, the newly unified board of the Pinellas County MPO and Planning Council, which merged in 2015, agreed to brand the agency as "Forward Pinellas." The branding effort was followed by the launch of several public outreach initiatives associated with introducing the agency and its new role to the public. This included a new website, regular blog posts, an annual report and an expanded presence on social media.

Public participation activity carried out by Forward Pinellas from 2017 to 2019 revolved around the agency's "SPOTlight" initiative and the development of the 2045 LRTP, "Advantage Pinellas." The SPOTlight initiative focused on three major planning or "emphasis" areas. These included US 19 Visioning, the Gateway Master Plan and Beach Community Access. "Advantage Pinellas" re-envisioned the LRTP process as a tool for building on the strengths and unique advantages of Pinellas County from the standpoint of mobility, economic development, tourism, the natural environment and land use. The policy framework and transportation improvements identified in the plan reflected this approach. The Advantage Pinellas Plan was adopted in November 2019. SPOTlight activity continued into 2020.

Citizen participation was a critical element in the planning activity of the emphasis areas and the development of the Advantage Pinellas Plan during these years. To provide opportunities for local residents to learn about and shape the outcome of these planning efforts, Forward Pinellas carried out a robust citizen participation program that included conducting public workshops, staff participation at citizen and business group meetings, social media outreach, assembling and coordinating focus group meetings, and staff interaction with local residents at various public events around the county.

In contrast to the 2015 Evaluation Report, this one is utilizing a tabular format intended to more closely align the agency's public outreach activity and accomplishments with the strategies and measures identified in Appendix A of the PPP. Any changes to the Appendix require amendments to be approved by the Forward Pinellas Board. Although updates to the narrative sections of the PPP are necessary to reflect current public involvement practices of Forward Pinellas, based on the results of this evaluation, no PPP amendments are recommended.
