Thank you to the selection committee for your guidance at the April 27, 2020 meeting regarding how to proceed with presentations. As discussed at the meeting, all firms receiving 470 points or more will be invited for virtual presentations. The presenters will all be virtual. Depending on the guidance received regarding Executive Order 20-69, the selection committee members will be virtual or in person. All meeting information will be made publicly available as the selection committee is a Sunshine committee.

The format will remain as discussed previously. Firms will have 30 minutes, 15 for a presentation and 15 for questions and answers and to account for the virtual technology platform. Forward Pinellas will host the meeting and will start it five minutes before the official start time to allow for set up. Each firm should identify the most pressing need facing Forward Pinellas and Pinellas County and how the firm would craft a scope of services to address that need. The project manager is required to speak. Firms may have as many individuals participate, as observers or speakers, as they choose. No additional practice time will be allowed with Forward Pinellas staff.

Forward Pinellas will reach out to the below firms to schedule presentations. Presentations will be held on May 26, May 27, May 28, June 3, June 4, June 9 and June 10. Forward Pinellas will email the project manager and ask them to call and schedule a presentation time slot. The project manager must also identify who will be acting as the primary contact for the virtual platform, as the firm may take over the screen sharing from Forward Pinellas during the presentation.
